

GENERAL INSTRUCTIONS

1. Kindly fill out all the sections of the Registration Form for participation in the 4th GNLU Moot on Securities and Investment Law, 2018. All fields are mandatory.
2. Teams that choose to pay the Registration Fee by way of online transfer in accordance with Rule 5.2 of the Rules of the Competition, are instructed to mention the full name of their University/College/Institution in the column provided for Remarks while making the payment. Teams are required to download the receipt of the payment, which alongwith the Registration Form and bonafide letter should be e-mailed to the Organizing Committee no later than 16 July 2018. Registration Forms received after this deadline will not be considered for participation in the Competition.

The Registration Form and the proof of payment must be e-mailed to gnlumsil@gnlu.ac.in with the subject “Registration on behalf of [Name of the University/College/Institution].”

3. Teams that choose to pay the Registration Fee by way of a Demand Draft in accordance with Rule 5.2 of the Rules of the Competition, will be required to post their duly filled and signed Registration Form along with the Demand Draft and bonafide letter. Further, Teams will also be required to e-mail a scanned copy of the Demand Draft and the filled Registration Form to the Organizing Committee. The Demand Draft and the Registration Form should reach the Organizing Committee via post and e-mail no later than 16 July 2018.
