Expression of Interest (EOI) Notice No: PC-27/2017

1. EOI Notification:

Gujarat National Law University (GNLU), Gandhinagar, invites sealed expression of Interest from eligible, reputed online education branding service providers as specified in of Requirement of this document.

Any subsequent amendments in the EOI will be available on the above mentioned website.

SECTION-II

ELIGIBILITY CRITERIA FOR THE BIDDER

QUALIFICATION CRITERIA (Stage I)

- 1) The bidder should have been in the coaching of civil services exam for at least 3 years as of 1st May, 2017.
- 2) The bidder/Company should have submitted Bid Processing fees of ` 2,500 (Rupees Two Thousand Five Hundred only) Earnest Money Deposit (E.M.D.) of ` 7,500/- (Rupees Seven Thousand Five Hundred only) in the form of Demand draft in favour of “Gujarat National Law University” payable at Ahmedabad.
- 3) The bidder should have a turnover of at least INR 15 Lacs in the last financial year, as revealed in Annual Financial Statement reported in India in the financial year (2016-17)
- 4) The bidder should have experience of handling at least two projects under the Govt. Dept. /Semi-Govt. Dept./Educational Institute/University or any other reputed private organization. Certification of successful accomplishment will be considered while allotting the project.
- 5) The bidder should be registered for Sales Tax/VAT/Service Tax/Excise as applicable. The copies of documentary evidence in support of this must invariably be enclosed with the offer.
- 6) The bidder should submit all supporting documents for above criteria with sign and stamp.
- 7) The bidder should have a track record of earning profits for last two consecutive years.
- 8) The bidder/Company should not have been debarred/blacklisted by any Govt. Dept. /Semi-Govt. Dept./Educational Institute/University or any other organization. Undertaking in this regard is to be submitted by Bidder.

The Evaluation Committee will assess competency of the coaching institution on below mentioned parameters:

- Number of years of existence
- Number of clients handled in government and private organisations (institution is expected to have balance of successful dealing with the government as well as private compatibility)
- The bidder shall have experience of providing coaching in English medium and satisfactory faculty team shall be there along with books, material and test series in the same language.
- Appreciation received in written form from the government agency/ any other reputed organization for the work performed.
- Track-record

PRESENTATION TO THE EVALUATION COMMITTEE (Stage-II)

Coaching Institution shortlisted in Stage I (pre-qualification) will be invited for making presentation in presence of Evaluation Committee at GNLU. Each of the shortlisted coaching institution will be given a slot of fixed time period. The Evaluation Committee will see the presentation of coaching facilities proposed by the bidder and assess competency of the coaching institution, their capacity of understanding the needs, and sensitivity to provide services to GNLU on below mentioned parameters:

- Presentation of proposed competitive exam coaching facility for University and its features
- Number of years of existence of Company
- Number of Key resource persons, faculty members and their post qualification experience
- Number of clients and details of Completed Projects any positive remarks or certificates received from the government for the same.
- Recognition/Accolades won during last 3 years
- Ability to serve GNLU
- Track-record

The Evaluation Committee will shortlist the coaching institution on basis of above evaluation for further process.

SECTION-III
GENERAL TERMS AND CONDITIONS

1. Essential technical requirement:

The agency must have all statutory registrations like PAN, Service Tax Number, Professional Tax Number and establishment registration, as applicable, with respect to this tender.

2. EOI fee & EMD:

EOI Fee & EMD: The Bidder has to submit Non-refundable Tender Fees of Rs. 2500/- & Earnest Money Deposit (E.M.D.) of Rs. 7,500/- in the form of Demand Draft in the name of “Gujarat National Law University” payable at Ahmedabad from any of the Nationalized Bank including the Public Sector Bank or Private Sector Banks authorized by RBI (operating in India having branch at Ahmedabad/ Gandhinagar). in the separate sealed cover should be remitted along with the bid. Bid without Tender fees & E.M.D. will not be termed valid. In case of non-receipt of Bid processing fees & EMD as mentioned above your bid will be rejected by GNLU as non-responsive.

3. Duration of the Project

The expected duration of assignment is **one year**. Contract may be renewed based upon the performance and feedback from the participants.

4. Assignment & Sub-Contract:

The Agency shall not assign, sub-contract or sub-let the whole or any part of the service in any manner without express approval of the University.

5. Prices, Taxes and Duties:

The Bidder should quote firm prices/ rates taking into account of all the Taxes, Duties, Levies, Personal Tax, Corporate Tax and all other expenditure required to be incurred by him/her for providing required services etc. during the contract period as indicated above and afterwards no variation on any account unless otherwise specifically mentioned will be allowed. The quoted prices for all the items shall be inclusive of all applicable taxes.

6. Taxes, labour laws and other regulations:

The selected agency shall accept and bear full and exclusive liability for the payment of any and all existing and future taxes of the Central or State Government or of any other authority with respect to the contract or any course pursuant thereto or anything done or service rendered pursuant thereto.

Confidentiality and Disclaimer

All information supplied by the GNLU in connection with this EOI must be treated as confidential and, for the avoidance of doubt, all parts of the EOI are to be treated confidentially by the Bidders.

7. Bid validity

Bid submitted by the bidder shall remain valid for a period of 6 (Six) months from the date of submission of offer. The Bidder shall not be entitled during this period to revoke or vary the content of Bid or any term thereof. In such case of making any variation subsequent to submission of bid at their own, the offer shall be treated as "REJECTED".

8. Submission of Bid:

The bid shall be submitted in sealed envelopes quoting reference number at the top of the envelope. The fee shall be enclosed with the Bid documents, in separate sealed envelopes, stapled with the packet containing Bid documents.

9. Bid Evaluation:

The Bidder will be evaluated based on the evaluation criteria.

Conditional EOI:

Conditional bids or Bids based on the process/ basic schemes other than mentioned and/ or not conforming to the requirements of the Bidding documents shall not be considered.

10. Contract Agreement:

The successful Bidder shall be required to execute a Contract Agreement with GNLU on the non-judicial stamp paper of Rs. 100/- (Rupees One Hundred Only). The cost of stamp paper shall be borne by successful Bidder. GNLU reserves the right to amend the terms & conditions of contract after mutual discussions and shall only be in writing.

11. Liquidated Damages:

In the event of failure to provide service beyond the specified date, liquidated damages @ 1% per month or part thereof in respect of the total loss value of the contract will be deducted, subject to a maximum of 10%; alternately the order will be cancelled and the remaining service will be given to any other suitable agency at the risk and expense of the qualified agency.

12. Force majeure:

If the whole or any part of the performance by the Parties of any part of their respective obligations hereunder is prevented or delayed by causes, circumstances or events beyond the control of the Parties including delays due to floods, fires, accidents, earthquakes, riots, explosions, wars, hostilities, acts of government, custom barriers, or other causes of like character beyond the control of the Parties, then to

the extent the Parties shall be prevented or delayed from performing all or any part of its obligations hereunder by reason thereof despite due diligence and reasonable efforts to do so notwithstanding such causes, circumstances or events, the Parties shall be excused from performance hereunder for so long as such causes, circumstances or events shall continue to prevent or delay such performance.

13. Interpretation:

In the event of any difference in the interpretation of any of the clauses of the service contract and / or the documents, the clarification given by the Registrar of Gujarat National Law University, Gandhinagar shall be final and binding on the Parties.

14. Exit Clause:

GNLU can terminate the contract at any time i.e. during the contract period without giving any notice or citing any reasons.

15. Settlement of Disputes:

Any dispute or difference whatsoever arising between the parties out of or relating to the construction, interpretation, application, meaning, scope of operation or effect of the service contract or the validity or the breach thereof, shall be referred for settlement to The Director, Gujarat National Law University, Gandhinagar and the award made in pursuance thereof shall be binding on the parties concerning to the arbitration.

16. Any dispute whatsoever shall be subject to the jurisdiction of Gandhinagar Courts only.

17. IMPORTANT:

- a) University may accept or reject any or all the bids in part or in full without assigning any reason and is not bound to accept the lowest bid. The University at its discretion may change the upgrade or drop the criteria or part thereof at any time before awarding the contract.
- b) A bid submitted with false information will not only be rejected but the agency will also be debarred from participation in future processes.
- c) The Agency need to submit a certificate during the opening of Technical Bids that they are not currently debarred or blacklisted in any state /national level organization or educational Institute/University.
- d) The University reserves the right to select the candidates for the course. The University may or may not allow outside candidates for the course.
- e) GNLU shall reserve the right to modify the rent.
- f) In case of any dispute, the decision of the Director of this University shall be final and binding on the Bidders.

SECTION-IV

TECHNICAL

SCOPE OF WORK:

GNLU intends to setup a centre for providing coaching of competitive exams like UPSC, GPSC among others. For that purpose the bidder is supposed to understand the requirement of the GNLU and provide the course with the following salient features:

- Awareness seminars on various competitive exams.
- 198-200 lectures (considering each lecture of two hours) of Intensive coaching.
- 1 year duration
- Medium of instruction shall be in English.
- Teaching by expert faculties which can satisfy the candidates.
- Completely upgraded books, material shall be included in the course.
- Regular test series (module wise test followed by full length tests) to assess the performance of the candidates.
- Doubt difficulty solving, guidance for form filling among others.
- Special focus on Gujarati language skills upgradation for preparing State PSC and Judiciary exam.
- If requirement arises, the bidder shall also be ready to provide coaching for Judicial Services. Course structure and prices shall be determined in consultation with the University at the time of requirement.

Implementation:

Implementation of the coaching programme will take place at GNLU premise. The bidder shall be able to provide all above mentioned services at the venue given by the GNLU. The university will provide necessary infrastructure including AC classroom with benches, LCD projector, Whiteboard etc. GNLU will provide adequate infrastructure facility in its campus with rent of ₹ 1,80,000/- (Rupee One Lakh Eighty Thousand Rupee Only) per annum. The University shall reserve the right to modify the rent.
