





# REPORT: 1<sup>ST</sup> EDITION OF GCCIL-IBBI NATIONAL MOCK-CIRP COMPETITION, 2024

Day-01: 04th April 2024 - INAUGURATION OF THE EVENT

#### **Introduction:**

The GNLU Centre for Corporate and Insolvency Law (GCCIL) successfully organised the **1st Edition of the GCCIL-IBBI National Mock CIRP** (**Corporate Insolvency Resolution Process**) **Competition** in collaboration with the Insolvency and Bankruptcy Board of India (IBBI). The event took place at Gujarat National Law University (GNLU) from 4th to 6th April 2024. Judges gathered at the designated venue, where they were welcomed and briefed by Prof. (Dr.) Mamata Biswal, Head of the Centre, providing them with essential information and guidelines for the upcoming rounds.

#### **Format of Preliminary Rounds:**

During the preliminary rounds, each team was tasked with presenting their resolution plan before an artificial Committee of Creditors (CoC). The CoC designed specifically for this event, comprised a diverse panel, including academicians, insolvency professionals, associates, and lawyers. This diverse composition comprehensively evaluated the teams' proposals from various perspectives, mirroring real-world scenarios in corporate insolvency resolution processes.

## **Objective:**

The primary objective of the preliminary rounds was to assess the teams' understanding of corporate insolvency laws, their analytical skills in formulating viable resolution plans, and their ability to present and defend their strategies effectively.

#### **Judging Process:**

The judging process was rigorous, with the CoC members carefully evaluating each team's presentation based on predetermined criteria such as feasibility, legal compliance, financial viability, and innovation in approach. Feedback provided by the judges aimed to offer constructive insights and learning opportunities to the participating teams, enhancing their overall experience and skill development.











# Date-03: 06th April 2024 - SEMI-FINALS, FINALS AND VALEDICTORY CEREMONY

The final day featured the semi-finals, finals, and the highly anticipated valedictory ceremony. **Semi-finals:** 

The top four teams, based on their scores from the preliminary rounds, advanced to the semi-finals. In this stage, teams were tasked with presenting their resolution plans before an artificial two-judge bench of the National Company Law Tribunal (NCLT), adding a layer of practicality to the competition.



#### **Finals:**

From the intense competition in the semi-finals, the top two teams emerged as finalists. The finalist teams comprised a team from **Government Law College, Mumbai** and a cross-institutional team from **Gujarat National Law University, Northcap University, and Maharaja Agrasen Institute of Legal Studies.** These finalists faced presented their comprehensive resolution plans before a special four-member bench of the NCLT, which included distinguished members such as Mr. Sumant Batra, founder of Insolvency Law Academy, Mr. Souvik Ganguly, Managing Partner at Acuity Law, serving as the technical members; and Hon'ble Mrs. Ina Malhotra, former Judicial Member, NCLT, Delhi and Hon'ble Mrs. Manorama Kumari, former Judicial Member, NCLT, Delhi acting as a judicial members.
