RULES OF THE COMPETITION

GENERAL INFORMATION

- 1. These are the rules for the 8th GNLU Moot on Securities and Investment Law, 2024. These rules supersede any rules previously released.
- 2. The 8th GNLU Moot on Securities and Investment Law, 2024 ("**Competition**") shall be held from 3rd to 6th October, 2024 in an offline mode, at Gujarat National Law University, Gandhinagar, Gujarat.
- 3. The Organizing Committee ("OC") shall function as the point of contact, and any changes in the Rules of the Competition shall be notified by email to all participating teams.
- 4. The Competition shall be conducted in accordance with the rules mentioned hereunder. Participants are required to comply with the rules and procedures prescribed herein.
- 5. The official email for all correspondence with respect to the Competition is gnlumsil@gnlu.ac.in.

1. DEFINITIONS

- 1.1. "Applicant(s)/Appellant(s)/Petitioner(s)" means that side of the Team which argues on behalf of the Applicant(s)/Appellant(s)/Petitioner(s) at any given point in the Competition.
- 1.2. "Bench" means the judges of an Oral Pleading Session collectively.
- 1.3. "Bluebook" means the Bluebook Method of Citation (21st edition).
- 1.4. "Clarifications" means the clarifications and corrections to the Moot Problem issued pursuant to Rule 5 of the Rules of the Competition. They shall be deemed to form part of the Moot Problem.
- 1.5. "Compendium" means a compilation or collection of legal or other authorities that a Team seeks to rely on during the Oral Pleading Session.
- 1.6. "Competition" means the 8th GNLU Moot on Securities and Investment Law, 2024.
- 1.7. "Identity" means any fact pertaining to the identity of the Team, or the Institution/College/University represented by the Team and the state or region where such Institution/College/University is located, and includes any identification

- marks/seal of the Team or the Institution/College/University represented including library marks or indications to the university.
- 1.8. "IST" means Indian Standard Time.
- 1.9. "Official Website" means the website of the Competition, i.e. <u>Home | GNLUMSIL</u>.
- 1.10. "Oral Pleading Session" means the oral pleadings before a Bench as explained in Rule 8 of the Rules of the Competition.
- 1.11. **"Oral Score"** means the score given by a judge in accordance with Rule 9 of the Rules of the Competition.
- 1.12. "Orator" means one of the two designated speakers in a Team.
- 1.13. "Organizing Committee" or "OC" means the committee, including any other persons specifically authorized in this respect, appointed for the administration and conduct of the Competition and all events leading to the Competition.
- 1.14. "Rebuttals" means the set of arguments/challenges that the Applicant(s)/Appellant(s)/Petitioner(s) shall raise at the end of the main pleadings of all the Orators.
- 1.15. "Reply to Rebuttals" means the defense presented by the Respondent(s) in response to the Rebuttals.
- 1.16. "Researcher" means that member of the Team who is not an Orator.
- 1.17. "Researchers' Test" means a written test conducted during the Competition in accordance with Rule 7.9 of the Rules of the Competition.
- 1.18. "Respondent(s)" means that side of the Team which argues on behalf of the Respondent(s) at any given point in the Competition.
- 1.19. **"Scouting"** means any person observing the Oral Pleading Session of a Team other than that of the Team such person is associated with.
- 1.20. "**Team**" means the registered representatives of any Institution/College/University participating in the Competition and shall include only those members as specified in Rule 2.3 of the Rules of the Competition.
- 1.21. "Team Code" means the code assigned to a Team through a draw of lots.
- 1.22. "Waiting Area" means the area designated by the OC where participants shall report prior to the commencement of each Oral Pleading Session.
- 1.23. **"Written Submissions"** means the memorandum of written submissions submitted by any Team as per Rule 6 of the Rules of the Competition.
- 1.24. "Written Submission Score" means the score determined in accordance with Rule9 of the Rules of the Competition.

2. ELIGIBILITY AND TEAM COMPOSITION

- 2.1. The Competition is open to all students, enrolled bonafide at the time of the competition on a regular basis in an undergraduate LL.B. degree programme or its equivalent conducted by any recognized Institution/College/University in India. Students enrolled in postgraduate or diploma programmes are not eligible to participate.
- 2.2. A recognized Institution/College/University shall be entitled to send only one Team for the Competition.
- 2.3. Each Team shall comprise a minimum of 2 (two) and maximum 3 (three) members. In case of a three-member team, two members of the Team shall be designated as Orators and the third member shall be designated as the Researcher. In case of a two-member team, both members shall be designated as Orators.
- 2.4. Any additional member or Team Coach accompanying a Team shall not be recognized and will not be entitled to a certificate for the Competition.

3. REGISTRATION

3.1. General Rules

- 3.1.1. In this edition of the Competition, all the Teams desirous of participating in the Competition should provisionally register themselves by sending an email to gnlumsil@gnlu.ac.in through the Moot Court Committee of their Institution/College/University or the Faculty Coordinator of the Moot Court Committee. Final registration formalities shall be completed by the Team only after receiving an affirmative reply from the OC to the provisional registration email.
- 3.1.2. The Teams from Institutions/Colleges/Universities who have already provisionally registered for the Competition before the release of these Rules will be given a preference for final registration over the Institutions/Colleges/Universities who will be provisionally registering themselves after the release of these Rules.

- 3.1.3. Each provisionally registered Team, who has received an affirmative reply from the OC to the provisional registration email, must register by filling up the Google Form <u>GNLUMSIL 2024 | Registration</u> and by paying the registration fee as provided in Rule 3.2 of the Rules of the Competition.
- 3.1.4. Each Team shall complete such provisional registration on or before 10th August, 2024 (11:59 PM IST) and complete final registration on or before 5th September, 2024.

Each Team shall upload an authorization-cum-bonafide letter issued by the appropriate authority of their Institution/College/University. In case, the letter cannot be obtained by the Team, Authorization email from the Head of the Institution, with the subject line: 'Authorization Email | GNLUMSIL 2024 | Name of the University', shall be sent to gnlumsil@gnlu.ac.in and the copy of that email shall be uploaded through the Google Form. The letter/email shall contain the details of the teammates (Name, Batch, and Year of Study). It shall contain an affirmation that the teammates are bonafide students of the Institution/College/University and are the only students authorized to participate in the Competition.

3.1.5. In the event that the Team is unable to fill the Google Form provided above, they shall notify the details required for the same, by email.

3.2. Registration Fee

- 3.2.1. The registration fee is INR 5,000 per Team.
- 3.2.2. The payment link for the Competition is https://gnlu.servergi.com:8071/SIMWEBGNLU/Utilities/opendataform.
- 3.3. Teams which have registered for the Competition in accordance with Rule 3.1 of the Rules of the Competition may withdraw from the Competition after informing the OC of such withdrawal on or before 8th September 2024. If a Team intimates a notice of withdrawal on or before 8th September 2024, then the registration fee paid, if any, will be refunded to the Team, after deducting transaction costs. In case a Team fails to intimate a notice of withdrawal within the stipulated time, such Team shall not be entitled to any refund.
- 3.4. Once a Team registers by completing the formalities provided in Rules 3.1 and 3.2 of the Rules of the Competition, a Team Code shall be assigned to each team by 10th September 2024.





- 3.5. A Team which has registered pursuant to Rules 3.1 and 3.2 of the Rules of the Competition may change its composition only after informing the OC of such change by way of filling the Google Form GNLUMSIL 2024 | Change in Team Composition. The Google Form shall be filled by the member of the team who continues a part of the team even after the change in the Team composition. After filling the Google Form, an e-mail shall be sent to gnlumsil@gnlu.ac.in informing the OC about the change in the Team composition. The change in the Team composition will be approved by the OC and a reply will be sent to the remaining and/or new members of the Team. Changes to the team composition shall not be made later than 8th September 2024.
- 3.6. Any changes in the contact details of Team members must be notified to the OC immediately, unless such a Team withdraws or is disqualified from the Competition.

4. Anonymity of Teams

- 4.1. Teams shall not reveal their Identity in any form, except by means of the Team Code assigned to them in accordance with Rule 3.4 of the Rules of the Competition.
- 4.2. Teams shall not, in any way, reveal their Identity in the Written Submissions or in the course of the Oral Pleading Session. The Written Submissions shall not bear the logo, name, etc. of the Team, its members, or the Institution/College/University represented by the Team.
- 4.3. Any material, including the Compendium, books, bare acts, or any other reference material, carried during the Oral Pleading Session, whether presented to the Bench or not subject to Rule 8.8, shall not reveal the Team's Identity and shall be devoid of any identification marks/ seal of the Team or the Institution/College/University represented. If anything on the material carried during the Oral Pleading Session reveals the Team's Identity, the Team shall render the same unrecognizable to the satisfaction of the OC prior to joining the Oral Pleading Session.
- 4.4. Any violation of Rules 4.2 or 4.3 of the Rules of the Competition may attract disqualification of the Team from the Competition or any other penalty as determined by the OC. The decision of the OC in this regard shall be final and binding.

5. CLARIFICATIONS TO THE MOOT PROBLEM

- 5.1. Teams may seek Clarifications via e-mail to gnlumsil@gnlu.ac.in, latest by 24th August 2024 (11:59 P.M. IST).
- 5.2. All Clarifications, if any, shall be posted on the Official Website by 4th September 2024. This date may be subject to change.

6. WRITTEN SUBMISSIONS

- 6.1. Each Team is required to prepare Written Submissions for both sides, i.e., the Applicant(s)/Appellant(s)/Petitioner(s) and the Respondent(s) of the case.
- 6.2. A Written Submission shall be identified solely by the Team Code assigned to the Team pursuant to Rule 3.4 of the Rules of the Competition. The Written Submissions shall not, in any way, disclose any fact pertaining to the Identity of the Team, its members (not limited to the name of the participants), or the Institution/College/University represented by the Team.
- 6.3. A Written Submission shall consist of the following mandatory heads:
 - a. Cover Page
 - b. Table of Contents
 - c. List of Abbreviations
 - d. Index of Authorities
 - e. Statement of Facts (not exceeding 2 pages)
 - f. Statement of Jurisdiction
 - g. Issues Raised
 - h. Summary of Arguments (not exceeding 2 pages)
 - i. Arguments Advanced (not exceeding 20 pages)
 - j. Prayer (not exceeding 1 page)
- 6.4. The Cover Page of a Written Submission must contain the following information:
 - a. The Team Code in the upper right-hand corner in accordance with Rule 6.11.3 of the Rules of the Competition.
 - b. The name and year of the Competition.
 - c. The name of the case.
 - d. The side for which the Written Submission has been prepared.
 - e. Name of the forum resolving the dispute.

6.5. List of Abbreviations and Index of Authorities



- 6.5.1. The List of Abbreviations shall include all abbreviations and acronyms (such as "SEBI", "SC", etc.) used in the Written Submission. If any abbreviation does not appear in the List of Abbreviations or vice versa, every instance wherein it is used in the Written Submission shall constitute a violation of this rule.
- 6.5.2. All authorities cited in the Written Submission must be included in the Index of Authorities and vice versa. If any authority cited in the Written Submission is not included in the Index of Authorities or vice versa, every instance wherein it is used in the Written Submission or the Index of Authorities, as the case may be, shall constitute a violation of this rule.
- 6.5.3. The List of Abbreviations shall be in alphabetical order.
- 6.5.4. Index of Authorities shall be in alphabetical order. Each head under Index of Authorities, such as Articles, Case Laws, Online sources etc., must be in alphabetical order.

6.6. Footnotes and Citations

- 6.6.1. Teams shall cite all authorities in the Written Submission using footnotes as per Bluebook (21st edition). A few sample citations have been provided in **Annexure** I for reference.
- 6.6.2. While citing the legal resources mentioned in this rule, the citation format (including punctuations, capitalizations, etc.) recommended in **Annexure II** shall to be followed in place of Bluebook.
- 6.6.3. While citing any legal resource, which is neither specified in Rule 6.6.2 of the Rules of the Competition nor specifically provided for in Bluebook (21st edition), but found online, the legal resource should be cited as an internet resource as per Bluebook (21st edition).
- 6.6.4. Footnotes shall be limited only to citations and in no case, footnotes shall contain additional information or arguments.

Example:

Acceptable footnote: A v. B, AIR 2015 SC 50, 12-23 [hereinafter A].

Unacceptable footnote: A v. B, AIR 2015 SC 50, 12-23 [hereinafter A] (holding that the basic structure of the Constitution cannot be amended).





6.7. Graphs, Tables, Diagrams and Annexures

- 6.7.1. The 'Arguments Advanced' shall not contain any graphs, tables, diagrams, photographs, or any other representation of like nature.
- 6.7.2. Graphs shall only be included wherever necessary, and shall be presented separately at the end of the Written Submission as Annexure, subject to a maximum page limit of 2 pages.
- 6.8. The Written Submission (including the preliminary pages and excluding the cover page) shall adhere to the following mandatory specifications:
 - a. Paper size: A4
 - b. Font type: Times New Roman
 - c. Font size: 12
 - d. Line spacing: 1.5
 - e. Body of text: Justified
 - f. Margin: 1 inch on all sides
 - g. No borders

For footnotes, the formatting specifications are:

- a. Font type: Times New Roman
- b. Font size: 10
- c. Line spacing: 1
- d. Paragraph spacing: 0
- e. No additional space between 2 footnotes
- f. Body of text: Justified

6.9. Presentation of the Written Submission

- 6.9.1. The Written Submission must be submitted in **Spiral Bound** only.
- 6.9.2. The hard copy of Written Submission shall be printed on both sides.
- 6.9.3. The cover page of the soft copies of the Written Submissions shall comply with the following color scheme:

Applicant(s)/Appellant(s)/Petitioner(s) – Blue (in any shade)





Respondent(s) -Red (in any shade)

- 6.10. Each Team shall send a soft copy of the Written Submissions, via email, on or before 20th September 2024 (11:59 PM. IST) to gnlumsil@gnlu.ac.in, and shall comply with Rule 6.11 of the Rules of the Competition.
 - 6.10.1. Any soft copy submission made after 20th September 2024 (11:59 PM IST) shall be considered as a late submission and shall attract a penalty with 1 mark for each day of delay till 25th September 2024 (11:59 PM IST).
 - 6.10.2. Any soft copy submission after 25th September 2024 (after 11:59 PM IST) shall be accepted only at the discretion of the OC.
 - 6.10.3. Where a Team sends multiple soft copies as their submissions, the submission last in time shall be considered for the purpose of Rules 6.10.1 and 6.10.2 of the Rules of the Competition.
- 6.11. It shall be the responsibility of each Team to ensure that the soft copies of the Written Submissions:
 - 6.11.1. can be opened and read with Adobe Acrobat Reader and Microsoft Word Document (through use of compatibility mode);
 - 6.11.2. are submitted as four (4) separate file attachments: two (2) as Written Submission for the Applicant(s)/Appellant(s)/Petitioner(s) (one each in PDF and Microsoft Word (.docx/.doc) format) and two (2) as Written Submission for the Respondent(s) (one each in PDF and Microsoft Word (.docx/.doc) format); and
 - 6.11.3. are named according to the Team Code and the side for which the Written Submission is prepared. (For instance, Team 01 will name its Written Submission for the Applicant(s)/Appellant(s)/Petitioner(s) as 01A and Written Submission for the Respondent(s) as 01R.) Use of any other format (for example "Team 01A" or "Team 01R") will be penalized.
- 6.12. All Teams are required to bring Five (05) hard copies of the Written Submissions for each side (05 for the Complainant and 05 for the Respondent) to the competition.
 - 6.12.1. The teams are required to submit a cover letter along with the hard copy of the Written Submissions. The cover letter should specify the Team Code assigned to such Team, details of the Team members and the College/Institution/University represented.
 - 6.12.2. Teams are required to send the soft copies of the Written Submissions well in time, taking all contingencies into account. Equipment failure, computer disk





failure, internet connectivity issues, etc. shall not be considered as grounds for condoning late submission of Written Submissions in determining any penalty imposed.

- 6.13. The hard copies of the Written Submissions must be exactly the same as the soft copies of the Written Submissions sent by the Team. Any violation of this rule shall attract penalty as determined by the OC. The decision of the OC in this regard shall be final and not subject to challenge.
- 6.14. Teams may carry hard copies of their Written Submissions for their personal use. No hard copies of Written Submissions submitted by a Team to the OC in accordance with Rule 6.12 of the Rules of the Competition shall be provided to such Team for their personal use.
- 6.15. Any Written Submission violating any of the specifications enumerated in Rule 6.2 to Rule 6.9 and in Rule 6.11 of the Rules of the Competition shall attract a penalty according to the scheme provided below:

6.16. Any Written Submission violating the specifications enumerated under Rule 6.10 of the Rules of the Competition shall attract a penalty according to the scheme provided below:

- 6.17. Deductions made under Rule 6.13 of the Rules of the Competition shall be over and above the maximum deduction of 10 marks prescribed under Rule 6.12 of the Rules of the Competition.
- 6.18. Any decision of the OC regarding the deductions shall be final and binding.

7. STRUCTURE OF THE COMPETITION

7.1. The Competition shall be conducted over a period of four days from 3rd October, 2024 and 6th October, 2024.

- 7.2. The Researchers' Test shall be conducted in accordance with Rule 7.9 of the Rules of the Competition.
- 7.3. The Inaugural Function and Orientation of Participants will be held on 3rd October, 2024. Preliminary Rounds will be conducted on 4th October, 2024 and 5th October, 2024, and Quarter Final Rounds, Semi Final Rounds and the Final Round on 6th October, 2024.
- 7.4. The Competition shall consist of the following Oral Pleading Sessions:
 - a. The Preliminary Rounds;
 - b. The Quarter Final Rounds;
 - c. The Semi-Final Rounds; and
 - d. The Final Round.
- 7.5. The Teams participating in a Round will be provided with a hard copy of the opposite Team's Written Submission prior to the Oral Pleading Session.

7.6. Preliminary Rounds

- 7.6.1. The Preliminary Rounds will be held on 4th October, 2024 and 5th October, 2024. There will be two Preliminary Rounds and each Team shall argue once as the Applicant(s)/Appellant(s)/Petitioner(s) and once as the Respondent(s).
- 7.6.2. The pairing of Teams for the Preliminary Rounds shall be done by a draw of lots by the OC. No two Teams shall argue against each other more than once in the Preliminary Rounds.
- 7.6.3. Each Team will be provided with a hard copy of the opposite Team's Written Submission prior to the Oral Pleading Session.
- 7.6.4. Each round shall be decided through the allocation of a total of 9 round points, with 6 points being awarded on the basis of the Oral scores of the Teams and 3 points being awarded on the basis of the Written Submission scores of the Teams.
- 7.6.5. If the difference between the Written Submission scores of the two Teams (determined in accordance with Rule 9.1 of the Rules of the Competition) is more than 7% of the higher score, then the team with the higher Written Submission scores will be awarded 3 points. If the difference is less than 7% of such higher score, then 2 points will be awarded to the Team with the higher score and 1 point will be awarded to the other Team. In case of a tie, the Teams will be awarded 1.5 points each.





7.6.6. A Bench of 2 judges will judge each round in the Preliminary Rounds. For each judge, if the cumulative Oral score (determined in accordance with Rule 9.2 of the Rules of the Competition) of one Team exceeds the cumulative Oral score of the other Team by 7% of the higher cumulative Oral score, then the Team with the higher cumulative Oral score will be awarded 3 points. If such difference is less than 7%, then the Team with the higher score will be awarded 2 points and the other Team will be awarded 1 point. In case of a tie, the Teams will be awarded 1.5 points each for that judge. Hence, a total of 3 points per judge will be allocated for the Oral Pleading Sessions.

Example:

In a round between Team A and Team B, Judge 1 gives a cumulative Oral score of 170 marks to Team A and 165 marks to Team B. The difference is 5 marks. Since this difference is less than 7% of 170 (which is 11.9) for Judge 1, Team A will be awarded 2 points and Team B will be awarded 1 point. In the same round, Judge 2 gives a cumulative Oral Score of 160 marks to Team A and 175 marks to Team B. Here, the difference of 15 marks is more than 7% of 175 (which is 12.25) and hence, Team A will be awarded 0 point and Team B will be awarded 3 points. If the Written Submission Score of Team A is 75 and the Written Submission Score of Team B is 75, there exists a tie and hence, the 3 points will be split equally, Team B will be awarded 1.5 points and Team A will be awarded 1.5 points. The total round points for that round are therefore:

Team A: 2 (Judge 1) + 0 (Judge 2) + 1.5 (Written Submission) = 3.5 points

Team B: 1 (Judge 1) + 3 (Judge 2) + 1.5 (Written Submission) = 5.5 points

- 7.6.7. The Team with the higher cumulative round points determined in accordance with Rules 7.6.4 and 7.6.5 of the Rules of the Competition will be adjudged as the winner of that particular round. Hence, in the example above, Team B will be adjudged the winner.
- 7.6.8. The top 8 Teams will qualify to the Quarter Finals. The Teams will be ranked as per the following scheme:





- a. Firstly, on the basis of the total round points earned after the two Preliminary Rounds.
- b. If there is a tie in the total round points, the rank will be determined on the basis of the number of wins in the Preliminary Rounds.
- c. If a tie persists, the rank will be determined on the basis of the total round points earned in the Oral Pleading Sessions in the Preliminary Rounds.
- d. If a tie persists after the above, it will be resolved on the basis of the Written Submission scores of the Teams.

7.7. Quarter Finals/ Semi- Finals

- 7.7.1. The Quarter Final Rounds will be held on 6th October, 2024 and are knockout rounds. Amongst the top 8 qualifying teams determined as per rule 7.6.8, the pairing of Teams for the Quarter Finals shall be decided by a draw of lots.
- 7.7.2. A Team will be credited with a win if the cumulative Oral score of the Team in that match, calculated in accordance with Rule 9.2 of the Rules of the Competition, is higher than the cumulative Oral score of the opposite Team in the Quarter Final round.
- 7.7.3. A tie will be resolved on the basis of the Written Submission scores of the Teams. In case the tie persists, it will be resolved by the toss of a coin.
- 7.7.4. The Semi-Final Rounds will be conducted on 6th October, 2024 and are knockout rounds. Amongst the teams that qualify the Quarter Final rounds, the pairing of Teams for the Semi-Finals shall be decided by a draw of lots.
- 7.7.5. Rules 7.6.4 and 7.6.5 of the Rules of the Competition will apply mutatis mutandis to determine the winner of the Semi-Final Rounds.
- 7.7.6. The Teams in Quarter Final Rounds and Semi-Final Rounds will be provided with a hard copy of the opposite Team's Written Submission prior to the Oral Pleading Session.

7.8. Final Round

7.8.1. The Final Round of the Competition will be held on 6th October, 2024. The Final Round will be conducted between the Teams that win the Semi-Final 1 and Semi-Final 2. The sides for which the Teams will argue will be determined through a draw of lots.

- 7.8.2. For each judge on the Bench, 1 point will be awarded to the Team which is given the higher cumulative Oral score by that particular judge. On this basis, the total points awarded to each Team by the Bench shall be calculated.
- 7.8.3. The winner of the Competition shall be determined on the basis of the highest total points determined in accordance with the Rule 7.8.2 of the Rules of the Competition.
- 7.8.4. A tie will be resolved by considering the cumulative Oral Score awarded by the Bench to each Team in accordance with the Rule 9.2 of the Rules of the Competition. A tie will be resolved by considering the Written Submission scores of the Teams.
- 7.8.5. The Teams will be provided with a hard copy of the opposite Team's Written Submission prior to the Oral Pleading Session.

7.9. Researchers' Test

- 7.9.1. The Researchers' Test shall be conducted on 3rd October, 2024.
- 7.9.2. In case of Teams with three members, only the Researcher, as designated under Rule 2.3 of the Rules of the Competition, shall appear for the Researchers' test.
- 7.9.3. In case of Teams with two members, either of the members may appear for the test. However, in such a situation the name of the member appear for the test must be notified to the OC at the time of registration.
- 7.9.4. The duration of the Researchers' Test shall be 1 hour and it shall be in the Multiple-Choice Question Format.
- 7.9.5. No notes, legal texts, books or any other reference material or electronic aid shall be permitted during the Researchers' Test.
- 7.9.6. The Researchers' Test shall test the knowledge of the laws involved as well as the factual details of the Moot Problem and the application of the relevant laws to the circumstances in the Moot Problem.

8. ORAL PLEADING SESSIONS

8.1. The order in which Teams shall submit their oral pleadings throughout the Competition shall be:

Orator 1 for Applicant(s)/Appellant(s)/Petitioner(s)

Orator 2 for Applicant(s)/Appellant(s)/Petitioner(s)





Orator 1 for Respondent(s)
Orator 2 for Respondent(s)

- 8.2. No Researcher of any Team will be allowed to address the Bench during the Oral Pleading Session.
- 8.3. All Oral Pleading Session for the Competition will be conducted in an offline set-up at the Gujarat National Law University.
- 8.4. The Rebuttals or Reply to Rebuttals, as the case may be, shall be presented by only one Orator of the Team. The Rebuttals of the Applicant(s)/Appellant(s)/Petitioner(s) shall be limited to responding to the oral pleadings of the Respondent(s). The Reply to Rebuttals of the Respondent(s) shall be limited to responding to the Rebuttals of the Applicant(s)/Appellant(s)/Petitioner(s). There will be no sur-rebuttals allowed.
- 8.5. Before the commencement of the Oral Pleading Session of a Team, the Orators of the Team shall be asked to inform an OC member about:
 - 8.5.1. Order of speaking of the Orators.
 - 8.5.2. The Orator delivering the Rebuttals or Reply to Rebuttals, as the case may be.
 - 8.5.3. Time reserved by each speaker for Oral Pleadings, as well as for Rebuttals or Reply to Rebuttals, as the case may be, in accordance with the Rule 8.13 and 8.14.

Once the Team has communicated these details to the OC, these details cannot be changed for the Session in question. Extensions of time may be granted only in extraordinary circumstances at the discretion of the Bench.

- 8.6. Teams shall not reveal their Identity throughout the Oral Pleading Session.
- 8.7. The dress code for the Competition shall be as per the applicable Bar Council of India Rules for advocates. However, robes and collars shall not be worn.
- 8.8. Teams shall be allowed to submit Compendiums during the Oral Pleading Session to the Judges. The Compendiums, if any, shall be subject to the scrutiny by the members of the Organizing Committee.
- 8.9. Any Team which violates any of the Rules with respect to the Oral Pleading Sessions may attract penalty. The decision of the Bench shall be final and binding.
- 8.10. Teams shall not be permitted to use any electronic devices, like laptops, projectors, video cameras, mobile phones, etc. during the Oral Pleading Session.
- 8.11. An additional member or Team Coach accompanying a Team shall be permitted to observe the rounds for that Team such person is associated with. Such additional member or Team Coach shall not be permitted to use any electronic devices, like





- laptops, projectors, video cameras, mobile phones, etc. during the Oral Pleading Sessions.
- 8.12. Any form of Scouting during the Competition is strictly prohibited and shall entail disqualification of the Team. The decision of the OC in this regard shall be final and binding.
- 8.13. Teams shall reserve at least 1 minute for Rebuttals or Reply to Rebuttals, as the case may be, for all Oral Pleading Sessions throughout the Competition. No Team shall, however, reserve more than 5 minutes for the rebuttals.
- 8.14. The allocation of time between the Orators of a Team, as well as time reserved for Rebuttals or Reply to Rebuttals, as the case may be, shall be in whole minutes only.

8.15. Preliminary Rounds

- 8.15.1. Each Oral Pleading Session will be for a period of 60 minutes wherein each Team will be allotted 30 minutes (*including Rebuttals or Reply to Rebuttals, as the case may be*). Any extension of time beyond this specified period is subject to the discretion of the Bench.
- 8.15.2. No Orator of a Team shall speak for more than 15 minutes, excluding the time reserved for Rebuttals or Reply to Rebuttals, as the case may be.

8.16. Quarter Finals/ Semi Finals

- 8.16.1. Each Oral Pleading Session will be for a period of 60 minutes wherein each Team will be allotted 30 minutes (*including Rebuttals or Reply to Rebuttals, as the case may be*). Any extension of time beyond this specified period is subject to the discretion of the Bench.
- 8.16.2. No Orator of a Team shall speak for more than 15 minutes, excluding the time reserved for Rebuttals or Reply to Rebuttals, as the case may be.

8.17. Final Round

8.17.1. Each Oral Pleading Session will be for a period of 80 minutes wherein each Team will be allotted 40 minutes (*including Rebuttals or Reply to Rebuttals, as the case may be*). Any extension of time beyond this specified period is subject to the discretion of the Bench.
