**Step 6:** Enter your CLAT Credential/Score details.

**Step 7:** Upload the necessary documents.

**Step 8:** Accept T&C.

**Step 9:** Click on save button.

**Step 10:** Click on payment link to pay the online payment of the application fees.

## 5. Selection Process:

The selection of candidates shall be purely based on CLAT All India Rank (AIR) merit, out of the application(s) received by the GNLU under this category. The application received after the due date will not be considered.

## 6. General Instructions:

- The candidates appearing in the qualifying examination shall be required to produce evidence of their passing the qualifying examination at the time of finalization of admission.
- The students who have passed their qualifying examination from schools located outside India (affiliation boards other than CBSE, ISCE, IB and Cambridge) are required to produce the equivalency certificate from the Association of Indian University. The same certificate is required to produce at the time of admission.
