2. Eligibility:

- For admission to UG (LL.B.) Programme:
 - Passed 10+2 or equivalent examination with a minimum of 45% marks.
 - Candidates who are appearing in the qualifying examination (10+2) in 2026 are also eligible to apply.
 - A person having citizenship of a foreign country (citizens other than India) and not having the status of "NRI".
- For admission to LL.M. Programme:
 - LL.B. or equivalent degree in law examination with a minimum of 50% marks.
 - Candidates who are appearing in the qualifying examination (LL.B) in 2026 are also eligible to apply.
 - A person having citizenship of a foreign country (citizens other than India) and not having the status of "NRI".

3. Application Form and Fees:

The candidates who are interested in seeking admission under the Foreign National (FN) category for UG/PG Programme(s), subject to satisfying eligibility conditions can apply directly by filling the below link along with all the relevant certificates which needs to be uploaded latest by **31 May**

Step 7: Upload the necessary documents.

Step 8: Accept T&C.

Step 9: Click on save button.

Step 10: Click on payment link to pay the online payment of the application fees.

Step 11: On successful payment, a confirmation e-mail will be delivered to the given e-mail id.

Note: Please upload the documents/photo within 150 KB size in JPG/JPEG format only.

***If the candidate is selecting wrong admission category, then the candidate himself/herself will be fully responsible for the result and the University will not accept or edit the admission category once the application is submitted.**

The Candidates may upload the documents or can edit the application form till 31 May 2026 by 05:00 P.M. The candidates are advised to fill the form in full. Incomplete application form (including non-submission of documents/fees) shall be rejected.

5. Selection Process:

The selection of candidates shall be purely based on merit, prepared in accordance with marks secured in 10+2 or equivalent examination, out of the application(s) received by the GNLU under this category. The application received after the due date will not be considered.

6. General Instructions:

- i. The candidates appearing in the qualifying examination shall be required to produce evidence of their passing the qualifying examination at the time of admission. The students who have passed their qualifying examination from schools outside India (affiliation boards other than CBSE, ISCE, IB and Cambridge) must produce the equivalency certificate from the Association of Indian University.
