About GNLU, Gandhinagar

Gujarat National Law University (GNLU), Gandhinagar - established under the Gujarat National Law University Act, 2003 - is a research-based teaching university recognized by the Bar Council of India (BCI) and the University Grants Commission (UGC). The University offers a diverse and unique range of teaching, research, training, and extension programmes, aimed at fostering academic excellence and professional competence in the field of law and allied disciplines.



GNLU enjoys membership in several prestigious national and international networks of universities, including the Association of Indian Universities (AIU), United Nations Academic Impact (UNAI), International Association of Law Schools (IALS), Asian Law Institute (ASLI), and the Shastri Indo-Canadian Institute (SICI).

In the National Institutional Ranking Framework (NIRF) 2025, released by the Ministry of Human Resource Development, Government of India, Gujarat National Law University (GNLU) was ranked as the 5th best law school in the country. The Gujarat State Institutional Rating Framework (GSIRF) has conferred upon GNLU the status of a 'Five Star' University in the category of Law, with the highest CGPA. Further, GNLU was ranked 4th among the top law institutes in the Outlook Ranking 2024. The Week–Hansa Research Survey 2025, in its Best Law College category, placed GNLU in the 3rd position, while the India Today Ranking 2025 also ranked GNLU as the 3rd Best Law College in the Country.



About GNLU-Silvassa Campus

The Gujarat National Law University (GNLU), which has its main campus in Gandhinagar, expanded by establishing an additional campus at Silvassa in the Union Territory of Dadra and Nagar Haveli and Daman and Diu (DNH & DD).





The DNH & DD is the fastest growing Union Territory in India and are acquiring importance both at the national and international level with the commencement of so many international projects across the UT. With the initiative of the Hon'ble President of India, Hon'ble Prime Minister of India and the Hon'ble Administrator, this UT is turning into an education hub, where many reputed institutes have opened their Campuses or also planning to start many more campuses in the near future.



Apart from education, there has been multi-fold development in this Union Territory in various sectors like entertainment, tourism, and trade etc. Therefore, the need was felt that imparting legal education is one of the most crucial requirements for the holistic growth of the region since the law graduates are going to play a vital role in the development of the Union Territory of Dadra and Nagar Haveli and Daman and Diu. With the support of the Administration of UT of DNH & DD, the Government of Gujarat and overall guidance of the members of the Statutory Council of the University, GNLU has established an additional Campus at Silvassa from the Academic Year, 2023-24.

Horizontal Reservation:

In addition to the above-mentioned vertical reservation, horizontal reservation of 30% shall be made in favour of female candidates, 5% of seats for Specially Abled Persons/Persons with Disability (*Divyang*) Category and 25% of seats shall be made in favour of candidates of Gujarat Domicile, cutting across all the above categories (Non-compartmentalized), except for EWS category.

(D) Admission of Supernumerary (NRI/NRI Sponsored, Foreign National, J & K Residents and North East Indian, SAARC for PG Programme) Seats by GNLU:

Apart from the admission & allocation of seats by CLAT Office, the admission under supernumerary seats shall be filled by the GNLU separately. Interested candidates are required to fill-up separate expression of interest form published by GNLU on its Website under the Admission webpage. The direct admission will be undertaken on the basis of applications received by the University and for merit purposes, the CLAT All India Ranking (AIR) only will be considered. For a detailed selection process, candidates are required to refer the notification. NRI category seats are available to NRI candidates or Indian nationals sponsored by NRI as per the conditions mentioned under Notification.

Foreign National (FN) category seats are available to Foreign Nationals only i.e., candidates with

foreign citizenship. Candidates seeking admission under the Foreign National category are not required to appear in the CLAT and shall apply directly to the University against the notification to be uploaded on the GNLU website under the Admission webpage. Interested candidates are required to refer to the GNLU website for further more details. Unfilled Foreign National category (FN) seats shall be offered to the candidates from NRI/NRI Sponsored Category as per the provisions of the University conversion policy approved by the competent authority. The Details regarding the eligibility criteria for admission under J & K (Jammu & Kashmir) Residents and NEI (North East India) shall be mentioned in the notification published by the University on its website.

- The Candidates getting admission under NRI/NRI Sponsored/Foreign Nationals
 Category shall have to make the payment of academic fees from the foreign account of
 the Sponsor only. In no circumstances, fee will be accepted from Indian Bank
 Account for the USD Component of Applicable Fees.
- Once the candidate is provisionally admitted against NRI/NRI Sponsored/Foreign Nationals category, he/she has to pay the fees in USD only through his/her or Sponsors NRI/NRO account only. In case of exceptional cases, only the sponsor change may be accepted with the approval of the competent authority.

The notification shall be announced on the GNLU website and the candidates are required to refer the notification for detailed selection process. The details of the number of seats available under the supernumerary seats are as follows: -

After the closure of the CLAT Office, in case of vacant seats, a merit list will be prepared by the University based on the All India Rank from the applications received against the particular vacancy notification.
- Out of the total allocation of seats by CLAT Office, further allocation of stream will be based on merit-cum-preference, subject to fulfilling the eligibility criteria after completing the admission process.
