  - iii. A person having citizenship of a foreign country (citizens other than India) and not having the status of "NRI".
- b) For admission to LL.M. Programme:
  - i. LL.B. or equivalent degree in law examination with a minimum of 50% marks.
  - ii. Candidates who are appearing in the qualifying examination (LL.B) in 2025 are also eligible to apply.
  - iii. A person having citizenship of a foreign country (citizens other than India) and not having the status of "NRI".
