- 3 The candidates shall have to make the payment of the Application fee of **INR 4, 000/- (non-refundable) through the above link only**.

- 7 The candidates who are making applications against this vacant seat notification shall be considered for that particular category for all upcoming vacancies, and are not required to re-apply against future vacancies, subject to eligibility criteria as applicable.
- 8 The provisionally selected candidates claiming the reservation are required to submit a valid category certificate issued by the competent authority before making the payment of academic fees.
