Inviting Expression of Interest for Seeking Admission under the Sports Quota Category for UG (LL.B.) Programme for the Academic Year 2025-26.

Date: 30 May 2025

Gujarat National Law University invites application for admission under Sports Quota Category from the outstanding players who have represented at International/National/State level in the registered tournaments organized by the Central or State Government or by any authority recognized by Central or State Government. The admission is available only for UG Programme offered by the University. The candidates who appeared in the Common Law Admission Test (CLAT-2025), and are interested in seeking admission under the Sports Quota Category for UG Programme (LL.B.), subject to satisfying eligibility criteria and fulfilling all of the below mentioned conditions, may apply directly to the University.

1. Number of Seats:

UG Programme (LL.B.) – 04 (Girls: 02/Boys: 02)

2. Eligibility Conditions:

- (a) A candidate seeking admission under sports category shall have appeared in the Common Law Admission Test (CLAT-2025) and secure minimum 40% of the highest score of the CLAT-2025.

For example, if the CLAT-2025 highest score is 150, then the candidates who have secured minimum of 60 marks or above are eligible to apply under this category.

- (b) The applicant as per their age must be eligible to participate in Inter-University Competitions for the next three years.

3. Application and Fee:

The candidates, who are interested in seeking admission under the Sports Quota for UG Programme, subject to satisfying eligibility conditions, may apply directly by filling the 'Admission (**Expression of Interest**) Form for Sports Quota as mentioned below. The candidates have to apply online as well as after successful submission of online application, must share screenshot of the payment application fee, all the sports related certificates, other relevant certificate such as CLAT Admit Card, CLAT Score Card, SSC/ HSC Marksheet etc., The candidate has to mail all these documents/certificates including sports certificates (Self Attested copy) to sportsadmission@gnlu.ac.in, shall reach the University latest

by 25 June 2025 by 1700 Hrs. After the due date/time, any submitted application will not be considered.

The candidates may please follow step by step instructions/flowchart given below for making an application:-

Step 1: Click on URL: <https://gnlu.servergi.com:8071/OLAGNLUUGPG/Student/welcome>

Step 2: Click UG for Under Graduate Programme.

Step 3: Enter the Personal Information.

Step 4: Choose Sports Quota under “Category” head, in case of Horizontal category please mention NA.

Step 5: Enter Address.

Step 6: Accept T&C.

Step 7: Click on Save button.

Step 8: Click on Submit button to pay the online payment of application fees.

Step 9: On successful payment, a confirmation e-mail will be delivered to the given e-mail id.

Step 10: Take print out of the application form and send it to GNLU alongwith fees payment receipt and all the relevant certificates. It is **mandatory** to mail the payment receipt and all other relevant documents (as mentioned above) at sportsadmission@gnlu.ac.in

Note: Please upload the documents/photo within 150 KB size in JPG/JPEG format only.

5. Selection Process:

The admission under this category shall be on the basis of weightage of the CLAT score, sports certificates and performance in the trials.

- (a) **CLAT Score** - 40% weightage shall be given to the marks secured in the CLAT examination.
- (b) **SPORTS Certificates** - 30% weightage shall be given to the past three years performance i.e. 2022-23, 2023-24, 2024-25 (April to March) in the sports activities (assessment shall be done on the basis of certificates produced); and weightage shall be given as per Point No. 8 and 9 of this notification.
- (c) **TRIAL Performance** - 30% weightage shall be given on the basis of performance in the trials conducted by the University.

6. Verification of Certificates & Trials: The assessment/verification of certificates/medals shall be done by the University. The University shall form a panel of experts to judge the potential of the candidates and trials shall be conducted by them. The constitution and composition of members of the panel shall be the sole discretion of the University. The University in consultation with the panel, shall decide upon the format of the trial and has a right to modify/amend the format whenever it deems appropriate/fit. The decision of the panel shall be final for selection of the candidates.

7. List of Sports:

The admission for the Academic Year 2025-26 under sports category is limited to the following games. The trials shall be conducted for all the following games or some of the games, depending upon the receipt of the applications (Expression of the Interest Form) by the University.

9. For a particular year, only the highest certificate shall be considered for scoring.

E.g.: If a candidate has played international, national and state level games in a particular year, his/her International certificate will only be considered for that year.

Also, if a candidate has participated in an individual or a team event, or different types of event, only one certificate will be considered. E.g.: Table tennis – team events and individual events, the candidate is supposed to submit the highest of them.

10. Important Note:

1. Sports Certificate of Invitational/Memorial/Open/Prize Money League/Ranking competitions shall not be considered.
2. Any injury/ casualty caused to the applicant during Sports Trials shall be the sole responsibility of the Applicant.
3. It is mandatory to submit an Undertaking on Non-Judicial Stamp Paper by the applicant at the time of admission stating that he/she will play for the Gujarat National Law University during their Under-Graduate Programme of study.

11. Tie Breaker policy:

In a scenario wherein two or more candidates secured the same marks in the same Game or Sports and are eligible to secure admission then tie-break policy will be applied by the Admission Committee as per the below mentioned criteria:-

- (a) The candidates securing higher marks in CLAT examination will be given higher preference.
- (b) If the Tie still persists, then applicant securing higher marks in Sports trials will be given preference.
- (c) If the Tie still persists for Chess and Tennis, the following criteria shall be applicable:-
- (d) Chess: The candidates having the FIDE rating 1700.

- (e) Tennis: The candidates having the AITA ranking up to 300 for under 18 years boys/girls or ranking up to 500 for open (Men/Women) category.

The rating/ranking for Chess & Tennis on the day/week of publication of advertisement for admission under sports quota shall be considered.

The shortlisted candidates who are eligible for appearing in the trials shall be intimated in due course of time. The candidates shall be required to produce original certificates at the time of Trial/Admission.
