## 2. Eligibility:

- a) For admission to LL.B. Programme:
  - i. Passed 10+2 or equivalent examination with the minimum of 45% marks.
  - ii. Candidates who are appearing in the qualifying examination in April/May 2020 are also eligible to apply.
- b) For admission to LL.M. Programme:
  - i. LL.B. or equivalent degree in law examination with a minimum of 50% marks.
  - ii. Candidates who are appearing in the qualifying examination in April/May 2020 are also eligible to apply.

## 3. Application and Fees:

The candidates, who are interested in seeking admission under the FN Category for UG (LL.B.) & PG (LL.M) Programmes, subject to satisfying eligibility conditions, can apply directly by sending expression of interest by filling the 'Admission (Expression of Interest) Form' on or before 01<sup>st</sup> July, 2020. The hard copy of the filled-in admission (Expression of Interest) form along with all the relevant certificates shall reach the University through post latest by 15<sup>th</sup> July, 2020.
