# Notification: Inviting Expression of Interest for Seeking Admission under the Sports Category for UG (LL.B.) Programme for the Academic Year 2021-22.

Gujarat National Law University invites application for admission under sports category from the outstanding players who have represented at International/National level in the registered tournaments organized by the Central or State Government or by any authority recognized by Central or State Government. The admission is available for UG programme offered by the University. The candidates appearing in the Common Law Admission Test (CLAT) – 2021 and who are interested in seeking admission under the Sports Quota Category for LL.B. Programme, subject to satisfying eligibility criteria and fulfilling all of the below mentioned conditions can apply directly to the University.

#### 1. Number of Seats:

UG Programme (LL.B.) – 4 (Girls:2/Boys:2)

#### 2. Eligibility Conditions:

- a) A candidate seeking admission under sports category shall have appeared in the Common Law Admission Test (CLAT) and secure minimum 40% of the highest score of the CLAT–2021. For example, if the CLAT–2021 highest score is 150, then the candidates who have secured minimum of 60 marks or above are eligible for admission under this category.
- b) A candidate shall have represented at International/National level in the registered tournaments organized by Central or State Government or by any authority recognized by Central or State Government in the above-mentioned games. The Certificate issued/approved by School Games Federation of India (SGFI)/Association of Indian Universities (AIU) in the relevant game shall only be considered.
- c) The applicant as per their age must be eligible to participate in Inter-University Competitions for the next three years.

#### 3. Application and Fees:

The candidates, who are interested in seeking admission under the Sports Quota for UG Programmes, subject to satisfying eligibility conditions, can apply directly by filling the 'Admission (Expression of Interest) Form for Sports Quota available on GNLU website. The hard copy of the filled-in admission (Expression of Interest) form along with all the relevant certificates shall reach the University through post latest by 31 August, 2021.

The Application fee INR 4,000/- (non-refundable) shall be made through the following link:-

#### 4. Selection Process:

- a) **Weightage:** The admission under this category shall be on the basis of weightage of the CLAT score, Sports certificates and performance in the trials. 40% weightage shall be given to the marks secured in the CLAT examination. 30% weightage shall be given to the performance in the sports activities (assessment shall be done on the basis of certificates produced) and 30% weightage shall be given on the basis of performance in the trials conducted by the University.
- b) Verification of Certificates & Trials: The assessment/verification of certificates/medals shall be done by the University. The University shall form a panel of experts to judge the potential of the candidates and trials shall be conducted by them. The constitution and composition of members of the panel shall be the sole discretionary of the University. The University in consultation with the panel, shall decide upon the format of the trial and has a right to modify/amend the format whenever it deems appropriate/fit. The decision of the panel shall be final for selection of the candidates.

#### 5. List of Sports:

The admission for the Academic Year 2021-22 under sports category is limited to the following games. The trials shall be conducted for all the following games or some of the games, depending upon the receipt of the applications (Expression of the Interest Form) by the University.

#### 6. Weightage of Marks for the Certificates/Medals:

<sup>\*</sup>Please note that the University reserves the right to revise the above mentioned point system as and when it deems fit. Only highest score of the particular certificate weightage shall be considered for marking. The highest score shall be scale down to 30% for the purpose of calculation irrespective the number of certificates.

#### Important Note:

- 1. Sports Certificate of Invitational/Memorial/Open/Prize Money League/Ranking competitions shall not be considered.
- 2. Any injury/ casualty caused to the applicant during Sports Trials shall be the sole responsibility of the Applicant.
- 3. It is mandatory to submit an Undertaking on Non-Judicial Stamp Paper by the applicant at the time of admission stating that he/she will play for the Gujarat National Law University during their Under-Graduate programme of study.

#### 7. Tie Breaker policy:

In a scenario wherein two or more candidates secured the same marks in the same Game or Sports and are eligible to secure admission then tie-break policy will be applied by the Admission Committee as per the below mentioned criteria:-

- a) The candidates securing higher marks in CLAT examination will be given higher preference.
- b) If the Tie still persists, then applicant securing higher marks in Sports trials will be given preference.
- c) If the Tie still persists for Chess and Tennis, the following criteria shall be applicable:-
- d) Chess: The candidates having the FIDE rating 1700
- e) Tennis: The candidates having the AITA ranking up to 300 for under 18 years boys/girls or ranking up to 500 for open (Men/Women) category.
  - The rating/ranking for Chess & Tennis on the day/week of publication of advertisement for admission under sports quota shall be considered.
- 8. The shortlisted candidates who are eligible for appearing in the trials shall be intimated in due course of time. The candidates shall be required to produce original certificates at the time of Personal Interview/Admission. The hard copy of the application along with payment receipt and photo copy of the relevant documents shall be sent to the below mentioned address:-
