Gujarat National Law University invites applications for admission under Foreign National (FN) category for UG (LL.B.)/PG (LL.M.) Programme(s) for the academic year 2023-24. The seats under the FN Category shall be filled by the University directly and the candidates seeking admission under this category is exempted from the Common Law Admission Test (CLAT) and can apply directly to the University.

1. Number of Seats:

UG Programme (LL.B.) - **05**

PG Programme (LL.M.) - **02**

2. Eligibility:

a) For admission to UG (LL.B.) Programme:

- i. Passed 10+2 or equivalent examination with a minimum of 45% marks.
- ii. Candidates who are appearing in the qualifying examination in 2023 are also eligible to apply.

b) For admission to LL.M. Programme:

- i. LL.B. or equivalent degree in law examination with a minimum of 50% marks.
- ii. Candidates who are appearing in the qualifying examination in 2023 are also eligible to apply.

3. Application Form and Fees:

The candidates who are interested in seeking admission under the Foreign National (FN) category for UG/PG Programme(s), subject to satisfying eligibility conditions can apply directly by filling the below link along with all the relevant certificates which needs to be uploaded latest by **30 April 2023 (11:59 P.M.)**. The Application fees of **INR 10,000/- (non-refundable)** shall be made through the following link:

Step 7: Upload the necessary documents
Step 8: Accept T&C
Step 9: Click on save button
Step 10: Click on payment link to pay the online payment of the application fees.
Step 11: On successful payment, a confirmation e-mail will be delivered to the given e-mail id.

The Candidates may upload the documents or can edit the application form till 30 April 2023 by 11:59 P.M. The candidates are advised to fill the form in full. Incomplete application form (including non-submission of documents) shall be rejected.

5. Selection Process:

The selection of candidates shall be purely based on merit, out of the application(s) received by the GNLU under this category. The application received after the due date will not be considered.

6. General Instructions:

- i. The candidates appearing in the qualifying examination shall be required to produce evidence of their passing the qualifying examination at the time of admission. The students who have passed their qualifying examination from schools outside India (affiliation boards other than CBSE, ISCE, IB and Cambridge) must produce the equivalency certificate from the Association of Indian University.  - ii. The candidate(s) applying under PG Programme are required to submit their final year mark sheet of LL. B. Programme at the time of admission.
