CLAT FIRST ALLOTMENT LIST STEP-BY-STEP INSTRUCTION

Step: 1 Upload all the relevant documents on CLAT Portal.

- a) Marks Statement for Tenth standard or equivalent Marks Statement - Mandatory
- b) Marks Statement for XII Standard or equivalent Marks Statement*
- c) Admit Card of CLAT 2022
- d) Character Certificate
- e) Transfer or Migration Certificate
- f) Caste Certificate (SC / ST / OBC) if applied and allotted under reserved category- Mandatory
- g) Domicile / Residence Certificate if applied and allotted under domicile/resident category seats- Mandatory
- h) PwD Certificate if applied and allotted under PwD Category mandatory from a Government hospital or Government approved hospital indicating 40% or more quotient of disability.
- i) Any other supporting document to claim your seat for the category you've applied (Eg: Dependents of Freedom Fighters

* Candidates for whom the results of XII standard are yet to be announced shall have to submit an undertaking stating they will submit marks statement for XII standard or any equivalent Marks statement within 7 days of the announcement of results. In case, the candidate does not meet the minimum eligibility criteria i.e., securing a minimum of 45 % or 40 % (in case of SC / ST) when the results are announced, the University reserves the right to cancel the seat allotted to the candidate.

** Candidates for whom the final year results of LL.B./B.L are yet to be announced shall have to submit an Undertaking stating they will submit Marks Statement for LL.B./B.L or any equivalent Marks Statement at the earliest upon announcement of results. In case, the candidate does not meet the minimum eligibility criteria i.e., securing a minimum of 50 % or 45 % (in case of SC / ST) when the results are announced, the University reserves the right to cancel the seat allotted to the candidate.
