Role and Responsibilities: Under the guidance of Head, Research and Development Cell, Head, Academic Affairs and overall supervision of the Director and the Registrar, the incumbent shall perform the following roles and responsibilities:-

- (i) Conduct interdisciplinary research in areas of law and Legal studies in collaboration with teaching and research staff.
- (ii) Provide research assistance to teaching and research staff as and when required;
- (iii) Develop, plan, execute, monitor and report interdisciplinary research in collaboration with external Universities, Institutions, Government Departments, Industrial and Economic agencies, Judiciary within India and abroad;
- (iv) Provide input to general teaching faculty on latest research developments and emerging research trends in respective fields;
- (v) Participate in overall planning and development of academic, research, training and extension programs and activities of the University;
- (vi) Conduct research based training and extension activities in the area of law;
- (vii) Perform any other duties including administrative, coordination, etc. as required to achieve the aims and objectives of the University, as assigned from time to time.

Essential Criteria:

- (i) Master's Degree in Law/Interdisciplinary area related to Law and Legal studies with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) from a recognized Indian University, or an equivalent degree from an accredited Foreign University.
- (ii) For Teaching and Research Associate (TRA) Candidates must have either cleared the National Eligibility Test (NET) conducted by the UGC/CSIR or an equivalent test accredited by the UGC such as SLET/SET in the relevant subject, or have been awarded a Ph.D. Degree in accordance with UGC regulations, along with a minimum of Two years of relevant research experience working in National Law Universities and/or in reputed NIRF ranked HEIs.
- (iii) For Senior Research Associate (SRA) Experienced applicants who have LLM and engaged in research or having experience in research activities etc., and if do not possess NET/SLET/SET/Ph.D., must demonstrate at least Five years (05 Years) of relevant research experience working in National Law Universities and/or in reputed NIRF ranked HEIs.

Applicants must have publications published in reputed national and international journals. Candidates with SCOPUS and Web of Science indexed publications will be given preference.

Highly desirable:

- (i) Experience in Teaching/ Research in premier law Universities/ Colleges;
- (ii) Excellent inter-personal and teambuilding skills;
- (iii) Ability to innovate and to improve academic programmes or services and to pursue interesting new ideas and new methods.

Important Notes:

- This appointment TRA/SRA is initially for a period of 364 days and subsequent extension on an annual basis depending upon the performance and progress to be assessed by a duly constituted committee and approval of Competent Authority, but in any case, not exceeding in total 3 years period.
- The appointment is purely on a contractual basis and can be terminated at any time through 01-month notice either side.
- The University retains the discretion not to make any appointment to this position, to make an appointment at a revised remuneration, or to make an appointment with a modified job description and to fix revised qualification and requirements.
- The Candidate selected against the advertisement shall be required to work at GNLU, Gandhinagar.
