## **Essential Criteria:**

- (i) Master's Degree in Law with atleast 55% marks (or an equivalent grade in a point scale wherever grading system is followed) from a recognised Indian University, or an equivalent degree from an accredited Foreign University;
- (ii) Good knowledge of latest National and International research trends and developments in Law;
- (iii) Ability to conceptualise and organise International Training Workshops and brainstorming online/ onsite discussions apart from Teaching/ Research;
- (iv) Fluency in English language.

## Highly Desirable:

- (i) Experience in Teaching/ Research in premier law Universities/ Colleges;
- (ii) National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/ SET or who are awarded Ph..D Degree in accordance with the University Grants Commission;
- (iii) Excellent inter-personal and team- building skills;
- (iv) Ability to improve academic programmes or services and to pursue innovative ideas and new methods.

Roles and Responsibilities: Under the guidance of Head, Research and Development Cell, Head, Academic Affairs and overall supervision of the Director and the Registrar, the incumbent shall perform the following roles and responsibilities:-

- (i) To conduct interdisciplinary research in areas of law in collaboration with teaching and research staff including honorary staff members and students;
- (ii) To provide research assistance to teaching and research staff as and when required;
- (iii) To develop, plan, execute, monitor and report interdisciplinary research in collaboration with external Universities, Institutions, Government Departments, Industrial and Economic agencies, Judiciary within India and abroad;
- (iv) To provide input to teaching faculty on latest research developments and emerging research trends in respective fields;
- (v) To participate in overall planning and development of academic, research, training and extension programs and activities of the University;
- (vi) To conduct research based training and extension activities in the area of law;
- (vii) To perform any other duties including administrative, coordination, etc. as required to achieve the aims and objectives of the University.
