**Minimum Eligibility Criteria for Sr. No. 1**

**Essential Criteria:**

The candidate(s) should have minimum ten (10) years of experience of working in University.

**Minimum Eligibility Criteria for Sr. No. 2**

**Essential Criteria:**

The candidate(s) should have minimum three (03) years of experience of working in University.

### **Minimum Eligibility Criteria for Sr. No. 3 & 4**

#### **Essential Criteria:**

The candidate(s) should have minimum two (02) years of experience of working in University.

### **Minimum Eligibility Criteria for the Position Sr. No. 5, 6 & 7**

#### **Essential Criteria:**

- (i) The candidate(s) should be SSC/ 10<sup>th</sup> Standard pass from any recognized Board.
- (ii) The candidate(s) should have valid Government Certificate/ License (as applicable) for the specific post.
- (iii) The candidate (s) applying for the post of “Driver” should be SSC/ 10<sup>th</sup> Standard pass and have valid Driving License for both Heavy Vehicle and Light Motor Vehicle.
- (iv) The candidate(s) should have minimum two (02) years of experience of working in University for all the positions.

### **Minimum Eligibility Criteria for the Position Sr. No. 8**
