NOTIFICATION

PROMOTION OF TEACHERS UNDER CAREER ADVANCEMENT SCHEME

The University is hereby inviting applications from eligible faculty members for the promotions under Career Advancement Scheme (CAS) from Assistant Professor (Level 10) to Assistant Professor (Level 11&12), Assistant Professor (Level 12) to Associate Professor (Level 13A) and Associate Professor (Level 13A) to Professor (Level 14) as per the University Grants Commission (Minimum Qualification for Appointment of Teachers and other Academic Staff in Colleges and other Measures for the Maintenance of Teachers Standard in Higher Education) Regulations, 2018 (No.F.1-2/2017/(EC/PS) dated 18th July 2018) as amended from time to time.

In view of the Gazette of India Notification dated 6th June 2024 on the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) (4th Amendment) Regulations, 2024 and in compliance with UGC letter No. No.F.9- I /201 0(PS/MISC.) Pt. Vol-ll dated 20th June 2024, the University is hereby issuing this notification with the following conditions: -

- 1. Faculty members who have already qualified or are likely to qualify under CAS till 31st December 2024 as per the UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic staff in universities Colleges und other Measures for the Maintenance of Standards in Higher Education, 2010, a choice is given to them either for being considered for promotions under the 2010 or 2018 Regulations.
- 2. The faculty members who have already applied under Notification No. GNLU/Reg./UGSCAS/02/jc/1223 dated 28th December 2023 may reapply under 2010 Regulations for being considered for promotions under the said Regulations.
- 3. The teachers shall offer themselves for assessment for promotion under CAS by submitting an application, subject to fulfilling the conditions as laid down under the UGC Regulations.
- 4. The teacher shall be on the role and in active service of the University on the date of consideration by Screening-Cum-Evaluation Committee for Promotion under the CAS.
- 5. The teachers are informed to ensure that all the prescribed conditions are fulfilled before the submission of the application. The application form duly filled-in must by supported by self-attested copies of all educational qualifications and relevant documents.

The teachers fulfilling the eligibility criteria as per the Regulations are required to submit the application to the Section Officer, HR Section along with relevant documents in two sets on or before 13th September, 2024
