### NOTIFICATION

In pursuance to, "Powers and Function of Executive Council", vide Section 20, and further in exercise of the powers conferred by section 46 of Gujarat National Law University Act, 2023 (Gujarat Act No. 9 of 2003), for regulations to be made by the Executive Council for the Administration and Management of the University.

And as section-III of Gujarat National Law University Administrative and Staff Regulations, The Regulation-29, "OTHER ALLOWANCES" with existing provisions, and as recommended in the 37<sup>th</sup> Finance Committee meeting held on 26<sup>th</sup> March, 2025, the recommendations of Finance Committee in the matter was placed before the 61<sup>st</sup> Executive Council, vide Additional Agenda No 61.06, regarding the payment of allowances to non-teaching employees also as similarly being paid to Teachers as per central Government rules and other details, as recommended by Finance Committee in Executive Council meeting held on 28<sup>th</sup> March 2025. The Executive Council in its 61<sup>st</sup> meeting so held, approved and accepted recommendations with other details as Resolution for Item AEC:61.06. Further this resolution of Executive Council as resolved was further placed before the General Council, in its 26th Meeting held on 26th April, 2025.

The General Council in its 26<sup>th</sup> Meeting approved and accepted the recommendation and resolutions in the stated matter as above and as made by Finance Committee and Executive Council in the 37<sup>th</sup> Finance Committee meeting and 61<sup>st</sup> Executive Council meeting respectively, and accordingly as approved by General Council in its 26<sup>th</sup> Meeting, the Regulation 29, "OTHER ALLOWANCES', is amended as below:

#### **Existing Regulations**

Unless otherwise specified in these regulations, the terms and conditions of any other allowances such as house rent allowance, dearness allowance, transport allowance, education grant for children and academic and research promotion allowance, for the academic and non-academic staff shall be governed by the UGC and Government of Gujarat regulations respectively.

#### Amended Regulations

Unless otherwise specified in these regulations, the terms and conditions of any other allowances such as house rent allowance, dearness allowance, transport allowance, education grant for children and academic and research promotion allowance, for the academic and non-academic staff shall be governed by the UGC and Government of Gujarat regulations respectively.

However, The General Council in its meeting held on 26th April 2025 approved the payment of HRA, Transport Allowance and Children Education Allowance to all regular Administrative Staff at the same rate and entitlement that is paid to the Academic Staff of the University with effect from 1st of June 2025.
