1) Student Research Development Council {SRDC}: The University, to cultivate and promote a culture of research amongst the students, has created the Student Research Development Council (SRDC). The SRDC is formed to imbibe in students a culture of interdisciplinary research on relevant contemporary issues. It brings a fresh, proactive and creative perspective while finding solutions to existing challenges. The University has created this platform for research, by the students, of the students and for the students with attractive recognition and credits towards developing the research culture amongst the students.) Role of Moot Court Committee: Gujarat National Law University strives to integrate the theoretical and practical aspects of law by conducting various moot court and client counselling activities on a semester basis. The Moot Court Committee is entrusted with the responsibility of facilitating and administering such exercises through its rigorous qualifying mechanism involving two rounds of mooting. The University has a well-rooted Mooting Culture, which is appropriately spread by the students amongst the students. The Teachers act as a guiding torch for all academics and presentation related matters, however, the activities under the moot are planned and executed by the students, which helps to create a participate approach towards the successful organization of moot events In-house (Intra Rounds) National and International. GNLU organises the GNLU International Moot Court Competition (GIMC) annually. Intra Rounds The first round usually witnesses the participation of over a 100 students in teams of two to tackle a moot problem ordinarily involving domestic Indian laws and Indian courts as their main forum of adjudication. At the end of this round, a Rank List entailing the Oralists as well as the Researchers ranks will be produced. On the availability of moots, a cut-off limit is determined and a selected number of successful participants (usually the top 80-90) then move to individually compete in the 2nd level where the moot problem will be structured around public international law or international arbitration. Various international and national moot court competitions are then allotted on the basis of the ranks obtained in the 2nd round. The oral rounds will be judged on the ability of the participants to identify legal issues, research exhaustively

in the prescribed areas of law and endurance before a grueling bench.

Curriculum Development

Curriculum development is attached the highest degree of importance at GNLU. The University follows a healthy and systematic process for the designing and development of curriculum. Faculty-members are allocated subjects (core, optional and

seminar) based on the preference/s indicated and the expertise shown through applications (that come, along with the notice of intimation of the same, at the end of the semester to decide curriculum plan for the next semester). The ACC prepares a draftlist of allocation of subjects among the faculty-members. Upon the acceptance and approval (of the draft) by the Director and the Dean (AA), the ACC releases the final list of allotment. GNLU designs its curricula in accordance with the UGC and the BCI mandates, and does take into account the syllabi of other prominent National Law Universities in India and major foreign universities for further upgradation of its own curricula. At GNLU, the curriculum is reviewed and upgraded every year. So, meaningful restructuring, keeping account of latest developments and anticipated developments is done every year. Each faculty member is required to anticipate research developments and also broadly outline Vision 2025 in his/her particular subject. The University follows a systematic process for the designing, development, updating and revision of the curriculum. Curriculum is developed through a Ten-Point RbTU (Research based Teaching University) document, an initiative of the University to amalgamate teaching and research. The following are the parameters of the RbTU model, as developed by the University: (1) Preparation of courseoutline in consultation with minimum two experts from India and/or abroad. The University at regular intervals has taken important measures to enhance the quality of examination and evaluation. The University with an object to keep the students updated and equipped on their subject knowledge, conducts continuous evaluation (Test, Projects, and Group Discussion etc.) Apart from continuous evaluation the University conducts the Mid-Term Test as well as End Term Examination. Students are allowed to access their scripts of mid-term tests as well as end term examinations to resolve their doubts and improve their performance at the next examination. Students can also apply for re-evaluation of their End-Semester answer scripts. To maintain the sanctity of the examination process, students with inadequate attendance are not permitted to appear for the said examination. To avoid any kind of malpractices or unfair practices, invigilation duty and flying squad are performed by the faculty

Library, ICT and Physical Infrastructure / Instrumentation

GNLU has been able to build up a good library in a short span of time. GNLU Library invested meaningfully in purchasing and licensing digital collections. To fulfill the requirements of the patrons, UN ILibrary and World Bank e-library have been added to it existing database collection and it reached to 19 electronic databases. Total 139

members.

Journals were subscribed. 61 E-books from Cambridge University Press and Edward Elgar Publishing have been purchased. A total of 1591 books was purchased and the collection reached to 17630.  - A) First Best Practice 1) Title of the Practice: GNLU Litigation Assistance Support Scheme (GLASS): 2) Objectives of the Practice: To incentivize and support brilliant students who opt to join the Bar despite other lucrative career opportunities. GNLU strives to provide a head-start to such aspirants along with contributing quality advocates to the Bar and to the Society. 3) Context: It was found to encourage the students for litigation, in order to incentivise a greater number of students with exemplary academic and extracurricular records and a demonstrable interest in litigation, GNLU will provide assistance to graduating students who demonstrate potential to be an asset to the bar and society. 4) The Practice: GNLU Litigation Assistance

Support Scheme was initiated in the year 2015. Five meritorious students were selected after rigorous procedure and the financial assistance of INR 7500/was paid to them for a period of one year. It was hugely appreciated by practitioners as well as parents. With class 2016, GLASS offered INR 15,000/per month to selected 10 students and with class 2017, GLASS financial assistance of INR15,000/- per month offered to 15 selected students. 5) Evidence of Success: The GLASS is the most applauded litigation assistant programme for the young and budding lawyers. So far more than 45 students benefited through the process. The Scheme, enterprising as it was, quickly garnered support in the student and legal community, and GNLU was able to enhance the scholarship from Rs. 7500/- to Rs. 15,000/- per student. From the academic year 2016-17 onwards, GLASS witnessed a positive trend in terms of meritorious recipients increasing from five to ten students. Thus, GNLU was successful in not only enhancing the number of recipients but also the monthly financial assistance. The GLASS recipients also get access to the GNLU library infrastructure including digital and physical databases, along with guidance from faculty members as and when required. The administration is also mindful to introduce new policies each year to reflect changes observed over previous academic years. Most recently, the policy was revised to make special provisions for students hailing from economically backward backgrounds. Hence now under this scheme, the said ten slots are divided in two parts (a) five litigation scholarship shall be granted to students having exemplary academic and extracurricular records, demonstrating a keen interest for litigation and (b) five litigation scholarships shall be for students belonging to economically weaker section of the society and exhibiting merit and demonstrable interest in litigation. GLASS recipients are selected through a rigorous selection process that tests students on multiple fronts such as their academic performance, personal interview, and participation in moots, cocurricular and extra-curricular activities, alongside a demonstrable interest in the arena of litigation. 6) Problems encountered: In certain cases, the financial assistance of one year is not sufficient. B) Second Best Practice 1) Title of the Practice: Food and Water Testing on a regular basis 2) Objectives of the Practice: Keeping in view the general health of the students and staff using water from the water resources present within the university campus regular testing is performed in the science laboratory of campus. 3) Context: The testing plays a crucial role in suggesting the full scope of water consumption. Biological and Chemical analysis is performed which indicates the drinking standards of water. Food Testing is carried for chemical, microbial, physical, and adulteration. The testing is done randomly for a variety of raw and cooked food. This is why food handlers have a legal responsibility to ensure that the food they prepare is free from these contaminants and safe for consumption. The analysis is carried with the help of nearby institution i.e. Gujarat Forensic Sciences University and nearby laboratory Gujarat Laboratory. 4) The Practice: The said practice was started in 21-07-2013. 5) Evidence of Success: Environmental Impact assessment and cleanliness 6) Problems encountered: N/A
