### General FAQs

- 1. What are the registration fees for the competition?
  - Indian Nationals: The total registration fee is 25,000 INR, split into two parts:
  - 30% (9,000 INR) due at pre-registration for memorial rounds.
  - 70% (16,000 INR) due upon selection for the oral rounds.
  - Foreign Nationals: The total fee is 300 USD, divided as:
  - 30% (100 USD) due at pre-registration for memorial rounds.
  - 70% (200 USD) due upon selection for the oral rounds.
- 2. How can I pay the registration fee?
- Payment can be made online via Razorpay or through a wire transfer to HDFC Bank. Details for both payment methods are provided in the registration instructions.
- 3. When is the final deadline for registration?
  - Last date for registration is 15th January,2026
