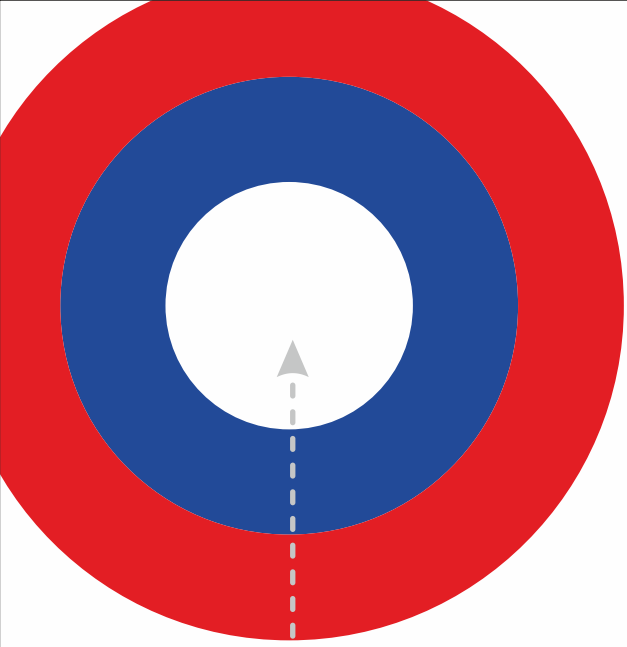

These laws ensure that patients receive appropriate medical care, have access to necessary information, give informed consent, and are protected from harm or exploitation. It set forth the ethical responsibilities and professional standards for healthcare practitioners.



The medical laws and guidelines also help ensure that healthcare professionals uphold high ethical standards, maintain patient confidentiality, provide competent care, and avoid conflicts of interest. Further it emphasizes the importance of informed consent, which means that patients have the right to be fully informed about their medical condition, treatment options, potential risks and benefits, and alternative therapies. Duration, Classes and Subjects

Duration

The duration of the course is 1 year. The course is offered from January to December every year.

Regular classes will be conducted on weekends in Blended Mode i.e. in both online and offline mode.

** Offline classes will be scheduled every last Saturday-Sunday of the month at GNLU, Gandhinagar. On other Saturdays and Sundays, online classes will be conducted.

Attendance

As per the University policy, it is mandatory to maintain a minimum attendance of 70% in all subjects. Furthermore, it is also mandatory to attend 6 days of offline sessions (i.e. 3 weekends) in the span of two semesters (January to December).

Examination & Evaluation

The students are expected to appear for Internal Continuous Evaluation as well as the End-Semester examination.

To be eligible for the End Semester Examination, students must fulfill the minimum attendance criteria and obtain passing marks in the ICE (50 marks).

As per the university's policy, the passing mark for each subject is 50.

For candidates who could not appear for the examination, the university shall conduct a special examination in the month of February/March the following year.

The subject faculties will design the Internal Continuous Evaluation (ICE) and provide details through the course outline at the beginning of every semester. The ICE carries a maximum score of 50 marks per subject.

The university conducts the End-Semester examination every semester on the designated date at the University Campus (offline mode). The maximum score for the End-term examination is 50 marks per subject.

Candidates who could not clear the examination shall be given an opportunity to reappear for the examination in the following year by submitting the prescribed fee (Course Extension Fee)
