As a part of such initiatives, GNLU facilitated the establishment of **Free Legal Aid Clinic at Koba village in Gandhinagar.** The clinic was inaugurated by Shri Ashish Dave, Chairman of the Gandhinagar Urban Development Authority on 18<sup>th</sup> January 2016. Shri Shambuji Thakor, Member of Legislative Assembly from South Gandhinagar, Shri Yogesh Nayi, Sarpanch, Koba Village and Mr. Saurabh Anand, Faculty Convener of GNLU Centre for Law and Society and Legal Services Committee were also present on this occasion. Gujarat National Law University has initiated *pro-bono* activities as a part of their course curriculum. The students involve in these activities to provide free legal assistance and legal knowledge to the villagers of Koba. The villagers are provided assistance through a variety of methods including traditional casework, summary advice, community legal education, awareness programmes and community development.

Shri Ashish Dave, Shri Shambhuji Thajor, MLA, Dr. Thomas Mathew, Registrar, GNLU and Shri Yogesh Nayi distributed dustbins as a part of *Swachh Bharat* and *Nirmal Gujarat* programmes started by the Central and State Governments respectively which is being supported by GNLU and Koba Panchayat. It is worth mentioning that Koba village has been adopted by the Gujarat National Law University under the Swachh Bharat initiative. Dr. Thomas Mathew, the Registrar of the university also shared the commitments for the people of Koba as a part of their responsibility towards society.
