## Recruitment Statistic Day Zero : Graduating batch of 2016

Gujarat National Law University, Gandhinagar (GNLU) commenced the recruitment process for the batch graduating in 2016 (2011-2016 Batch) in January, 2015. It is a matter of great pride that 9 students from the 2011-2016 batch have received Pre-Placement Offers (PPOs) from India's leading law firms and this is the highest number of PPOs being offered to any batch in GNLU till date prior to Day Zero. GNLU organised the 'Day Zero' for the 2011-2016 Batch on April 8, 2015.

'Day Zero' at GNLU witnessed presence of tier-I firms Amarchand & Mangaldas & Suresh A Shroff & Co, Delhi Offices; Amarchand & Mangaldas & Suresh A Shroff & Co, Mumbai Offices; Luthra & Luthra Law Offices, J. Sagar Associates (JSA), Khaitan & Co. L.L.P. and Trilegal.

The total batch strength is of 155 students of which 115 opted for being part of the recruitment process and 80 students applied to the firms participating for Day Zero. A total of 26 offers were made by the esteemed firms. The remuneration packages being offered to the students were in the range of Rs. 18 lacs to Rs. 11 lacs (CTC) and the average package came up to Rs. 14.2 lacs (CTC).
