### Forum on 'GoG funded GNLU Projects: Research Outputs 2018' graced by Hon'ble Minister Bhupendrasinh Chudasama

Gandhinagar, May 10, 2018: GNLU Research & Publication Division organised a Forum on "GoG funded GNLU Projects: Research Outputs 2018" on 9 May 2018 to showcase and deliberate on the outputs and outcomes of the current Government of Gujarat funded Research Projects undertaken by Gujarat National Law University. The forum explored the opportunities to promote the dissemination and utilization of the interdisciplinary research findings, supported by primary data and tested through statistical methods, in presence of Shri Bhupendrasinh Chudasama, Minister of Education (Primary, Secondary and Adult), Higher and Technical Education, Law and Justice, Government of Gujarat. Hon'ble Minister asked the researchers to share their final report with respective departments of Government of Gujarat to strengthen the knowledge base that the government and its departments use in decision making, knowledge-based policy and overall strategic insight.

In an introductory session, Prof. (Dr.) Bimal N. Patel, Director, GNLU apprised the Forum on the subject matter of 15 GoG funded research projects which touches range of diverse and contemporary areas like Start-Ups, Digital Financial Literacy, Police Accountability, Sports Governance, IP Awareness, Social Entrepreneurship, NRIs etc. Professor Patel highlighted that GNLU is creating a strong and holistic research culture to impact socio-economic development, through empirically grounded policy interventions that are relevant to the needs of the society.

The following session included the presentations by Researchers wherein they summarized their findings with overall economic and societal impact of the research work supported by the GoG grant before the three external membered Panel [Research Assessment and Review Committee (RARC)] comprising of Prof. N. K. Pathak, Member Former Director, School of Law, Gujarat University; Prof. Rasananda Panda, Professor & Area Leader - Business Management, Mudra Institute of Communications; and Prof. Somdeb Lahiri, Professor, School of Petroleum Management, PDPU. The Panel assessed and evaluated the submissions, including the quality of research and further guided researchers on potential reach and significance of research impacts.

Interesting insights were shared by invited and nominated participants from various Government of Gujarat departments advising researchers in developing a strategy to put knowledge into practice.
