Ambedkar on **Monday, 21st December 2015 at 10:30 am at GNLU** for the tribal students of Secondary and Higher Secondary Level of the State of Gujarat. Total 206 students along with their teachers from Ambaji, Bardoli(Surat), Dahod ,Shamlaji etc.participated in the programme.

The Patron in-chief for the event was Mr. Sanjay Nandan, Commissioner for Persons with Disabilities, Gandhinagar. The resource persons for the program were Prof. Dr. Jayprakash M.
