## Rajiv Gandhi School of Intellectual Property Law (IIT Kharagpur) wins the GNLU Moot on Securities and Investment Law

**Gandhinagar, Sep 15, 2019:** Rajiv Gandhi School of Intellectual Property Law (IIT Kharagpur) emerged victorious at the fifth edition of the GNLU Moot on Securities and Investment Law, today. School of Excellence in Law, Tamil Nadu Dr Ambedkar Law University bagged the trophy for the runners-up.

The panel of judges for the finals comprised of Justice Tarun Agarwala (Presiding Officer, Securities Appellate Tribunal), Mr Sandeep Parekh (Founder and Managing Partner, Finsec Law Advisors), Mr. Somasekhar Sundaresan (Advocate, High Court of Bombay), Mr Sanjay Asher (Senior Partner, Crawford Bayley & Co.) and Mr Murali Neelakantan (Principal, Amicus).

Justice Tarun Agarwala presided over the valedictory function. In his valedictory address, Justice Agarwala stressed on the importance of mooting and said, "moot court competitions are very useful in preparing law students for a career in litigation. They give them an experience similar to the actual courtroom much before they enter a courtroom as an advocate." He recalled his first day in the court. "I was nervous as I rose to address the court. My mind went blank and I was speechless for a while. This would not have happened if we had moot court competitions in my student days," said Justice Agarwala.

The winning team was awarded a cash prize of Rs. 50,000, a trophy, merit certificates, books sponsored by Corporate Law Adviser and a subscription to Manupatra for six months in addition to an internship opportunity with the leading law firm of Shardul Amarchand Mangaldas & Co.
