Prof. (Dr.) Mamata Biswal, Professor of Law and Dean – Academic Affairs at GNLU, has been awarded the Senior Fellowship in Law by the Indian Council for Social Science Research (ICSSR) for the year 2016-17. Her research will be fully funded by the ICSSR. Her topic of research is "Legal Challenges before India to ratify the United Nations Convention on Contracts for the International Sale of Goods (CISG) – A Critical Analysis". Dr. Biswal is among the 33 candidates who have been awarded the Senior Fellowship Grant by the ICSSR.

Further, GNLU is also glad to share that Prof. (Dr.) Ranita Nagar, Professor of Economics and Dean – Research has been nominated to participate in the 2017 Asia-Pacific Law Deans' Forum to be held on 9th & 10th March 2017 in Yogyakarta, Indonesia, organized by the International Association of Law Schools (IALS) in collaboration with Universitas Gadjah Mada, Faculty of Law. The Asia-Pacific Law Deans' Forum is open to Deans and Associate Deans from law schools and law departments in the Asia-Pacific region. It provides an opportunity to engage with law school leaders to develop a critical set of issues and proposals in developing a global approach to the challenges facing legal education today.

In addition to the above achievements, GNLU is also pleased to share that Dr. Vikas Gandhi, Associate Professor of Law and Dean – Extension, has been selected to serve as a Judge at the upcoming 22nd Annual Inter-American Human Rights Moot Court Competition organized by American University Washington College of Law. The Competition will take place from 21st – 26th May, 2017 in Washington, D.C. The Competition is a trilingual moot court (English, Spanish and Portuguese), based on the Inter-American system for the promotion and protection of human rights.

Furthermore, it is a matter of pride for GNLU to share that Dr. Joshua N. Aston, Assistant Professor of Law and Dean – Students' Welfare at GNLU has been selected for the prestigious DAAD (German Academic Exchange) Research Grant. This grant is facilitated by the partner University of GNLU in Germany – the University of Cologne for two months. Dr. Aston will be visiting Germany from March – May 2017 and will be conducting a research on Human Rights Law focusing on the Human Trafficking taking place in the European countries, with a special focus on Germany and a critical analysis of the CoE Convention (Council of Europe Convention on Actions against Trafficking in Human Beings) and its effectiveness in combating human trafficking.

It is certainly a matter of pride for GNLU to have its representative at such an important event at the international stage.
