GNLU Organises the 9th GNLU International Moot Court Competition

GNLU recently organized the 9th edition of its flagship moot, the GNLU International Moot Court Competition, 2017 from the 1st to the 5th of February, 2017. GIMC, which has been an annual event since 2009 is conducted keeping in line with GNLU's effort to serve as a world class institution that places equal reliance on both academic endeavors and practical applications of law. Since its conception, it has grown exponentially, and has garnered due recognition from prestigious organizations like the American Society of International Law (ASIL), the International Law Students Association (ILSA) and the Asian Society of International Law (ASIAN SIL).

This edition of GIMC saw participation from around 50 teams, including teams from Nepal, Bangladesh, Sri Lanka, Mauritius and the United States of America. Further, the judges invited to adjudicate this edition were experts in the field, ranging from academicians to practitioners of international trade law. The moot problem for this edition was based on anti-dumping laws in the trade of Aluminum, based on a current dispute before the WTO involving India.
