# FROM THE DESK OF THE REGISTRAR

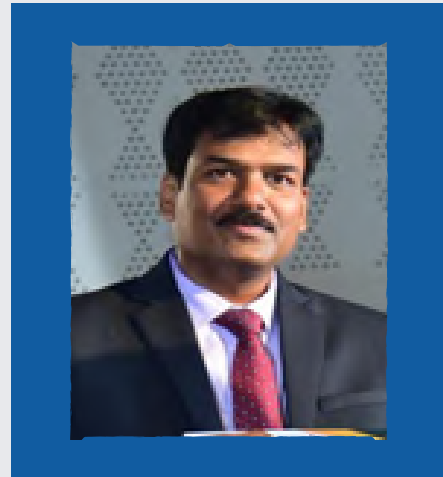
Respected Recruiters,

Greetings from Gujarat National Law University!

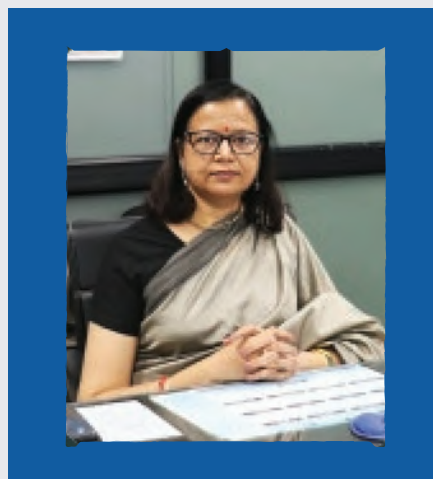

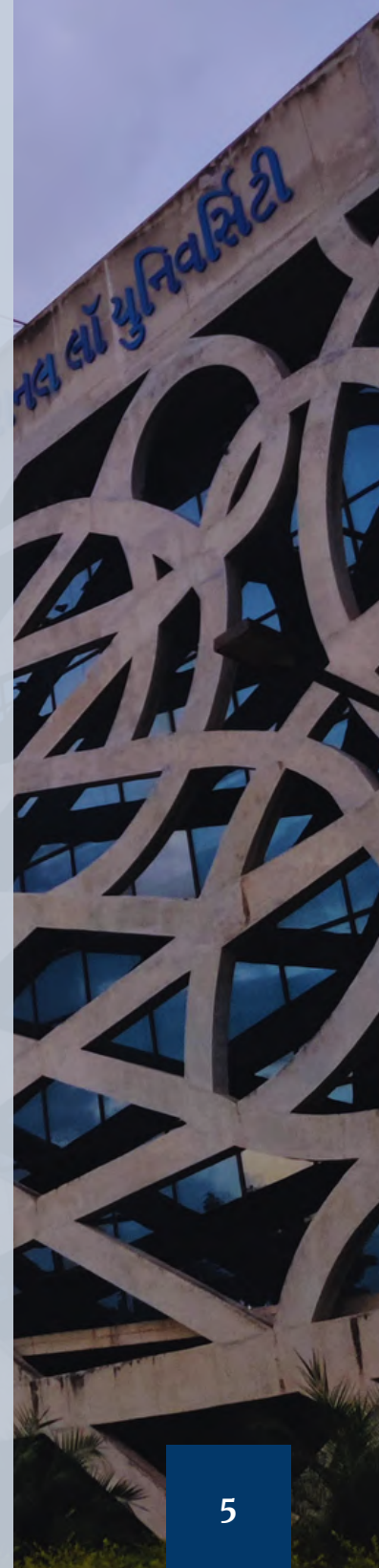
# ABOUT GUJARAT NATIONAL LAW UNIVERSITY

Gujarat National Law University (GNLU) is a statutory university established by the Government of Gujarat under the Gujarat National Law University Act, 2003 and functions as the nodal agency to uplift legal education in the State. The University is recognized by the Bar Council of India (BCI) and the University Grants Commission (UGC). The University is also a member of the Association of Indian Universities (AIU) and is accredited with an 'A' Grade by NAAC.

The GNLU Act, 2003 proclaims the objectives of the University “shall be to advance and disseminate learning and knowledge of the law and legal processes and their role in national development; to develop in the students and the research scholars a sense of responsibility to serve society in the field of law by developing skills in regard to advocacy, legal services, legislation, parliamentary practice, law reforms and such other matters; to make law and legal processes efficient instruments of social development; and to promote the interdisciplinary study of law in relation to management, technology, international cooperation and development.”

The University is instrumental in providing a multi-disciplinary, LLM Programme and five-year integrated course - humanities, commerce, management, science, and social work. It is a legal institution with global outreach, which undertakes a continuous, dynamic process of creating legal minds who are par excellence professionals with an innate sense of social responsibility. With state-of-the-art research facilities and readily accessible campus infrastructure, the students, faculty, and research fellows are well-equipped to pursue their research interests. The University's library boasts books on myriad areas of law and provides access to online research databases and journals.
