## ABOUT GUJARAT NATIONAL LAW UNIVERSITY

Gujarat National Law University (GNLU) is a statutory university established by the Government of Gujarat under the Gujarat National Law University Act, 2003. The University is recognized by the Bar Council of India (BCI) and the University Grants Commission (UGC). The University is also a member of the Association of Indian Universities (AIU) and is presently accredited with an 'A' Grade by NAAC and functions as the nodal agency to uplift the legal education in the State of Gujarat.

The GNLU Act, 2003 proclaims the objects of the University “shall be to advance and disseminate learning and knowledge of law and legal processes and their role in national development; to develop in the students and the research scholars a sense of responsibility to serve society in the field of law by developing skills in regard to advocacy, legal services, legislation, parliamentary practice, law reforms and such other matters; to make law and legal processes efficient instruments of social development; and to promote inter-disciplinary study of law in relation to management, technology, international cooperation and development.”

The University is instrumental in providing a multi-disciplinary five-year integrated course - humanities, commerce, management, science, and social work. It is a legal institution with global outreach, which undertakes a continuous, dynamic process of creating legal minds who are par excellence professionals with an innate sense of responsibility to the society.

With state-of-the-art research facilities and campus infrastructure readily accessible, the students, faculty, and research fellows find themselves well equipped to pursue their individual research interests. ## UNIVERSITY INITIATIVES

### LEGAL SERVICES COMMITTEE

The GNLU Legal Services Committee has been set up in the year 2007 by way of Section 4(k) of the Legal Service Authorities Act, 1987 which reads as "Develop, in consultation with the Bar Council of India, programs for clinical legal education and promote guidance and supervise the establishment and working of legal services clinics in universities, law colleges and other institutions". The Legal Aid committee provides assistance through a variety of methods, including traditional casework, summary advice, self-help, community legal education, community development and policy reform initiatives.

The GNLU Annual Legal Services Forum is an annual event organized by the Legal Services Committee. It aims to bring together legal services committees and legal aid clinics to a common platform to deliberate upon ideas to collaborate and contribute to the objective of providing free and competent legal service to the underprivileged. The core aim is to pool resources and share best practices, while appreciating the difficulties faced, in order to enhance the functioning of legal services committees and create a reverberating impact on legal services and information dissemination in the country.

### PRO BONO

Keeping in mind the social goals of law, Gujarat National Law University became the first National Law University to introduce a 100 hours pro bono programme spread across the 5-year course. A dedicated pro-bono committee has been set up under the aegis of the Centre for Law and Society to facilitate the students to fulfil the pro bono requirement. The major objective of introducing 'pro bono service' is to encourage and motivate the students of the University to work for the community, offer their services under the legal provisions, which will help them bring closer to the society, besides helping them in their future career. This is done through activities such as providing free and competent legal services to eligible persons and institutions, organizing Lok Adalats for amicable settlement of disputes, legal awareness camps and services in rural areas, among others. To recognize the students' sincere efforts to impact the society through their work, the University has also instituted the Annual Pro-Bono Legal Aid Award which is given to one person from each batch who has done the most exceptional and extensive work in providing legal aid to the marginalized and the underprivileged.

### GNLU STUDENT MENTORSHIP PROGRAMME

The GSMP was established in 2016 under the aegis of the Student Welfare and Grievance Redressal Committee. Mentoring is a particular form of relationship designed to provide personal and professional support to an individual. The mentor is generally more experienced than the mentee and makes use of that experience in a facilitative way to support the development of the mentee. The mentoring relationship provides a developmental opportunity for both the mentor and the mentee. Mentors and mentees are matched on the basis of common interests, hobbies etc. Mentors are students from the 4th and 5th Year while the 1st, 2nd and 3rd year students are mentees.

### CENTRES OF EXCELLENCE

The University has adopted a research-based teaching model with the aim of promoting a temper for in-depth research while forwarding critical and analytical thinking. In furtherance of this, the institute has established several centres of law to help realize its research objectives. The Centres of excellence have been set up in various genres of legal research viz. food security, constitutional & administrative law, foreign policy, environmental law to name a few. Further new areas of law like Centre for Sports and Entertainment Law and Centre for Law and Society have also been established to promote diverse interests of students.
