FROM THE DESK OF THE DIRECTOR



I have pleasure in presenting the Annual Report of the Gujarat National Law Universities on its programs and activities concerning academics, research, extension, training and administration in 2018. At the outset, I thank my colleagues in academics and research for giving their valuable input for the report, making the report comprehensive and enabling the readers to learn about University's growth and achievement. While the report will speak for itself, I would like to highlight few remarkable achievements in the year.

The Academic Curriculum Committee conducted a complete review of the curriculum offered in the Under-Graduate Program. The exercise involved consultations with key stakeholders, academicians, members of judiciary and statutory bodies, law firms, alumni, among others. The main outcome of the exercise is introduction of Honors with Specialisation from academic year 2018-19. Recognising the importance of specialisation, the University also plans to introduce more specialisations in LLM program from 2018-19 academic year. Students welcomed the academic initiative.

GNLU completed 16 small-research projects, having strong policy-input and impact assessment orientation, funded by the Government of Gujarat. The inter-disciplinary projects further strengthened capacity and capability of the University to present research based recommendations to the policy-makers and impact-evaluators. Besides these small research projects, the University faculty and students, individually and collectively, pursued several research projects funded by the University, state and central government as well as endowment agencies. Several faculty members of the University are becoming part of Cambridge University Press Cambridge History of International Law - India part. GNLU introduced dedicated research cadre faculty to pursue focussed research agenda, first of its kind among NLUs.

GNLU Legal Incubation Center and GNLU Litigation Assistance Scholarship Scheme, encouraging students to pursue legal entrepreneurship and litigation in courts of law and arbitration tribunals in different parts of India, remained highly successful innovation and appreciated by students, members of bar and bench alike.

2018 was one of the busiest and most productive years for GNLU extension and training divisions. Besides, annual flag-ship programs - GNLU International Moot Court Competition, International Maritime Academy, Air and Space Law Academy, Law and Economics, the University hosted and organised training programs for members of judiciary, bar, executive, civil society, and student community at large. The whole-some approach to education - teaching, research, extension and training, in sum, is strongly embedded and institutionalized at the University.

GNLU students continued to exceed expectations in various curricular and co-curricular activities, notably among others national and international moot court competitions, bringing the University at top position in several of these competitions. Along with the highest ever zero-day recruitment, followed by most successful rounds of recruitment of students by senior advocates, judiciary, top law firms, industrial houses, public sector undertakings, and NGOs, the University students excelled in achieving coveted scholarships to pursue higher studies in different universities of the world. The Sports Authority of Gujarat sanctioned grant of 10 Crore Rs to create state-of-art multi-sports indoor facility at the University.

The process of recruitment of qualified candidates for various teaching and non-teaching posts on permanent appointment continued. Similarly, the guidelines on Post-Doctoral research, Honorary Doctorate Degree, Research and Consultancy by faculty members were adopted during the year, further consolidating academic and research vision of the University. The support and encouragement of members of statutory bodies of the University further propelled the overall growth and achievements of the University. The University conducted a systematic review exercise to assess the implementation of the recommendations made by Dr. Bakul Dholakia Review Commission in 2013.

In sum, 2018 consolidated the University impact and contribution to nation's development agenda and provided new insights and ideas to march ahead in 2019.

ABOUT THE UNIVERSITY

Gujarat National Law University (GNLU) is a statutory University established by the Government of Gujarat through Gujarat National Law University Act, 2003. GNLU is recognised by the Bar Council of India (BCI) and the University Grants Commission (UGC) [(2 (f) & 12 (b)] as under. GNLU is a member of the Association of Indian Universities (AIU); the United Nations Academic Impact (UNAI); and International Association of Law Schools (IALS).For its exemplary efforts in the promotion of legal education, UGC has recognized GNLU as a model legal university in terms of access, equity, relevance, and high standards in 2011. The National Assessment and Accreditation Council (NAAC) has accredited the University with 'A' Grade in 2016. GNLU has also been ranked as the 3rd and 4th Best Law University in the country by Outlook-Drshti Professional College Survey 2016 and India Today-Nielsen Survey 2016, respectively.

Post Graduate Programme - MBA in Financial Management& Business Laws Eligibility for Admission for MBA Programme

- The programme will be open to the graduates from any recognized university or institute with minimum qualification in/with commerce, management, law, arts, science and engineering except fine arts.
- Only Candidates who have appeared at Common Admission Test (CAT) 2016 conducted by IIMs are eligible to apply.
- The candidate must hold a Bachelor's Degree, with at least 50% marks or equivalent CGPA (45% in case of the candidates belonging to Scheduled Caste (SC), Scheduled Tribe (ST) category) awarded by any of the Universities incorporated by an act of the central or state legislature in India or other Educational institutions established by an act of Parliament or declared to be deemed as a University under Section 3 of the UGC Act, 1956, or possess an equivalent qualification recognized by the Ministry of HRD, Government of India.
- The percentage of marks obtained by the candidate in the bachelor's degree would be calculated based on the practice followed by the university/institution from where the candidate has obtained the degree. In case the candidates are awarded grades/CGPA instead of marks, the conversion of grades/CGPA to percentage of marks would be based on the procedure certified by the university/ institution from where they have obtained the bachelor's degree. - Candidates appearing for the final year of bachelor's degree/equivalent qualification examination and those who have completed degree requirements and are awaiting results can also apply. If selected, such candidates will be allowed to join the programme provisionally, only if she/he submits a certificate latest by October 01, 2018 from the Principal/Registrar of her/his College/Institute (issued on or before June 30, 2018) stating that the candidate has completed all the requirements for obtaining the bachelor's degree/ equivalent qualification on the date of the issue of the certificate.

ACADEMIC DIVISION

Academic Curriculum Committee (ACC)

The main object of the GNLU Academic Curriculum Committee ('ACC') is to provide guidance, approval and supervision to the faculty members on curricular innovation and instructional quality by ensuring that the curriculum of the University is academically sound, comprehensive and responsive to the evolving needs of the society; thus, serving the University's mission, and also the educational and vocational needs of the students. This Committee comprises mostly the senior faculty members of the University.

Roles and responsibility: ACC is entrusted with developing the standard curriculum and addressing the broader concerns that would be reflected in the curriculum framework. The following are the broad roles of the ACC:-

- Defining the goals and objectives of the curriculum;
- Designing and management of the curriculum;
- Scheduling of courses;
- Recommendations on new courses and new instructional programmes;
- Recommendations on deletion of courses and instructional programmes;
- Vetting of proposed courses;
- Allocation of subjects;
- Offering academic inputs to initiatives and proposals for different types of extra-UG courses;
- Review, evaluation, revision and implementation of policies/guidelines for course-outline/reference materials, etc. to ensure that the curriculum is coherent, coordinated, fully integrated, current and effective.

Curriculum Development in the year 2018:

The Academic Curriculum Committee has approved introduction of new courses and updated or modified existing courses according to the requirements of time. Three seminar paper subjects 'Health Law", 'Animal Protection Law', and 'Socio Economic Offenses (White Collar Crimes)' has been shifted from Semester X to Semester IX effective from July 2018. Also, seminar paper subject 'Medical Law and Ethics' was removed from Semester IX effective from July 2018.Besides, the Committee has approved the academic content of 15 training programmes/certificate courses imparted at GNLU.

About the Division:



Further, the Research Assessment and Review Committee (RARC) was constituted to examine the updates of the allotted projects. three external membered Panel namely Prof. N. K. Pathak, Former Director, School of Law, Gujarat University; Prof. Rasananda Panda, Professor & Area Leader - Business Management, Mudra Institute of Communications; and Prof. Somdeb Lahiri, Professor, School of Petroleum Management, Pandit Deen Dayal Petroleum University. The Principal Investigators and Co-Investigators presented the progress of their Research Projects before the Hon'ble Committee and on the basis of presentation and submitted progress report, the committee assessed and evaluated the submissions, including the quality of research and further guided researchers on potential reach, significance of research impacts and several other criteria. This rigorous process was continued till the completion of project.

Once the research projects work concluded, GNLU Research & Publication Division organized a Forum on "GoG funded GNLU Projects: Research Outputs 2018" on 9th May 2018 to showcase and deliberate on the outputs and outcomes of the current Government of Gujarat funded Research Projects undertaken by Gujarat National Law University. The forum explored the opportunities to promote the dissemination and utilization of the interdisciplinary research findings, supported by primary data and tested through statistical methods, in presence of Shri. Bhupendrasinh Chudasama, Hon'ble Minister of Education (Primary, Secondary and Adult), Higher and Technical Education, Law and Justice, Government of Gujarat, Research Assessment and Review Committee (RARC) members and other dignitaries invited from several departments of Government of Gujarat. Hon'ble Minister instructed the researchers to share their final report with respective departments of Government of Gujarat to strengthen the knowledge base that the government and its departments use in decision making, knowledge-based policy and overall strategic insights. Interesting insights were shared by invited and nominated participants from various Government of Gujarat departments advising researchers in developing a strategy to put knowledge into practice.

Gujarat National Law University expressed its sincere gratitude to the Government of Gujarat and its various departments for their encouragement and support to this collaboration between government and academia. The research projects will definitely explore the avenues through policy interventions on the contemporary issues. The complete research project report will be shortly submitted to the concerned departments of Government of Gujarat.



About the Centre:

The Centre wishes to reinforce its belief that an independent academic Centre, committed to excellence can play an important role in bringing industry, civil society, governments and other stakeholders together to design and implement strategies to achieve success in development of financial literacy & development of modern legal education and making it sustainable. And the Centre has also been working keenly in this area in collaboration with the BSE-IPF (Bombay Stock Exchange Investor Protection Fund) and Gujarat International Finance Tec-City (GIFT) — International Financial Services Centre (IFSC).

- Distinguished Ambassador Lecture Series On "Current and Future Trends in International Relations" on 5th January, 2018: The address was delivered by Ambassador (Retd.) HE Mr. Eric Gonsalves, Former Ambassador of India to European Union and Japan and former Secretary, Ministry of External Affairs, Government of India, on the topic, "Current and Future Trends in International Relations".
- Winter Law School on National Security and Defense Law and Regulations, A Comparative Approach (Indian, Germany and France): GNLU Centre for Public International Law and Centre for Foreign Policy and Security Studies and University Paris Nanterre, Paris and University of Potsdam, Germany, jointly organized the Trilateral Winter Law School on National Security and Defense Laws and Practices. The Winter Law School, a trilateral academic-scholarly academy, addressed the legal and regulatory challenges of national security and defense, which are often tackled through political and geopolitical lenses. It provided an ideal platform to inquire into these regulatory challenges, between academicians and professionals, both young as well as established, from the three nations.
- Distinguished Ambassador Lecture Series on 'Indo-Japanese Bilateral Relations for a Peaceful and Prosperous World and Asian Order': The address by H.E Ambassador Mr. Sujan Chinoy, Ambassador of India to Japan held on 26 June, 2018 was very well received. Mr. Chinoy focused on key trends in India Japan relations, while also tracing the relations to ancient time.
- Distinguished Ambassador Lecture Series on 'Understanding National Power': The Address by H.E Ambassador Mr. B S Prakash, Ambassador of India to Brazil on 03 August, 2018 firstly provided a simple but effective definition of power. He further explained about the changing dimension of power and its various aspects. He also described the influence of military power and influence of the power of peace then he compared both power.

GNLU Centre for Intellectual Property Rights

About the Centre:

GNLU has established a Centre for Intellectual Property Rights, in the year 2016, with an aim and vision to incentivize innovative and cutting-edge academic research in the field of IP Laws, and conducting various training and extension activities for creating more awareness in the field of IP laws. Over a short period of time, the Centre has emerged with various programs focused on strengthening the level of awareness on IP laws amongst stakeholders; capsule courses, special lecture series and panel discussions form part of the programs.

Activities Undertaken:

Special Lecture on 'Who Owns IP- Intellectual Property Rights in a Technology Driven World?': Ms. Lisa Macklem examined existing similarities between the Indian and Canadian jurisprudence with reference to copyright, and emphasized the need to study foreign jurisprudence in order to bridge the knowledge gap in a globalized industry. She questioned the concept of copyright and what a copyright should promote and protect with the growing pace of technology. Further, Ms. Macklem looked into the judicial developments in the Copyright sector, highlighting key trends and concepts like technological neutrality and net neutrality.



- Empirical Research Work Entitled "Adding Life to Centuries' Dying Art- A Comparative Market Analysis between Tangaliya Shawls and Kutch work Shawls" –A project by Dr. Nidhi Buch, Ms. Vaishali Singh and Ms. Hetvi Trivedi, from November 2017 to August 2018. The project was divided into two stages through an investigative empirical study, aims to find root causes of the gradual extinction of two handicrafts Tangaliya Shawl and Kutchhi Shawl in State of Gujarat.
- Working Paper Presentation at "IP Scholars Asia" 2018 -The Centre's empirical research project was selected for presentation as a working paper at the IPScholars Asia Conference, held in Singapore. For the purpose of presentation the first and pilot phase empirical survey was conducted by the team among weavers of Tangaliya and Kutch handicrafts. Basing on the survey, the preliminary set of results and data analysis were presented.



GNLU Centre for Law and Economics (CLE)

About the Center:

GNLU Centre for Law and Economics (CLE) has been established in the year 2013. The objective of the CLE is to create awareness about the nascent interdisciplinary field of Law and Economics, which can play a crucial role in making the Indian Legal System more efficient. Apart from offering the subject as part of its regular curriculum the Centre organizes Research activities, Conferences, Workshops, Competitions, Seminars and Capacity Building Sessions to provide a forum for discussion and debate in the field of Law & Economics to students and academicians.

Activities Undertaken:

Special Lecture Series on Traditional and Contemporary Issues in Law and Economics: The Center organized the Special Lecture series from January – April 2018. The lectures were engaged by Mr. Ajit Sahijwani, Advocate Gujarat High Court, Mr. Avinash Ganu, Founder, Avinash Ganu and Associates Law Firm and Professor Thomas Ulen, American law and economics professor. The objective of the programme was to engage lectures of the eminent persons in the field of Law and Economics. There were a total of 35 participants.





- Training Programme on Applied Statistics using IBM SPSS Statistics for Legal Studies: The Centre organized the training Programme on Applied Statistics using IBM SPSS Statistics for legal studies" on 03-04 February, 2018 and basically focused upon different Data Types, Measures of Location, Variability, Shape and Association between variables, Descriptive Statistics, Multiple Response Analysis, Correlation Analysis and Regression Analysis. Dr. Gaurang Rami, Professor of Economics, Veer Narmad South Gujarat University was the resource person for the programme.
- Certificate Course on Economics of Regulation and Globalization: The Centre organized a 15 hours 'Certificate Course on Economics of Regulation and Globalization' from 12-16 February 2018. The Guest Faculty for the Course was Prof. Dr. Regis Lanneau, French academician and Director of undergraduate program in Law and Economics as well as Co-Director of the Masters Program in Economic Regulation at University Paris West Nanterre la Defense. The Certificate Course addressed questions ranging from accountability standards to environmental and human rights treaties, to WTO regulation and arbitration.



- Certificate Course on Economics of Constitutional Law: The Centre has conducted a 15 hours Certificate Course on Economics of Constitutional Law from 27-31 August, 2018. The resource person for the Course was Prof. Dr. Regis Lanneau, French academician and Director of undergraduate program in Law and Economics as well as co-director of the Master's Program in Economic Regulation at University Paris West Nanterre la Defense. His sessions covered various topics like representation and democratic election, understanding the legislative process, rent seeking and constitutions matters for economic development. Apart from it, Dr. Hitesh Kumar Thakkar, Assistant Professor of Economics at GNLU also contributed himself as a resource person with his session on "Behavioral Economics and Constitutional Law".
- Training Programme on "Advanced Applied Statistics using IBM SPSS Statistics for Legal Studies" from 13 16 September 2018: The key resource person for the Course was Dr. Guarag Rami, Professor, Department of Economics, Veer Narmad South Gujarat University, Surat. The motto of the training programme was to encourage the participants towards more on empirical research by use of IBM SPSS Statistic.
- **3rd Annual Quiz on Law & Economics:** The Centre has organized "3rd Annual Quiz on Law & Economics" on 12th October 2018 as the part of its capacity building programme. This year, the quiz saw a large number of participants with 28 teams.
- Additional achievements: The Centre has published Online GNLU Journal on Law and Economics in month of August 2018.

GNLU Centre for Law and Society (GCLS)

The GNLU Centre for Law and Society carries its tasks through two wings i.e., the Law & Society Wing and the Legal Services Committee. The Law and Society wing is a reconstitution of the erstwhile GNLU Centre for Law and Society. It functions as a focal point for socio-legal research, facilitating interdisciplinary and multi-disciplinary research and study on law and society, and law and legal institutions. The mission of the wing is to promote an understanding of the role of law in society. The wing encourages multidisciplinary perspectives to inform analysis and debate on socio-legal issues, thereby providing the most comprehensive approach to research and policy-making. It seeks to examine and inquire into law-related issues from the perspectives of a broad range of disciplines, such as anthropology, communication, critical gender studies, economics, environmental studies, ethnic studies, history, linguistics, philosophy, political science,

psychology, sociology, and urban studies and planning. Findings originating at the Wing are disseminated through conferences and symposia, journals, in-house student vignettes, and policy white papers. The objective is to make the findings easily accessible to professionals in government, business, or the law, and in so doing, to bridge the gap between academia and policymaking.

Activities Undertaken:

- Research Project on Exercise of Free Speech by Government Employees: The J&K Government recently passed an order curbing the use of social media by its employees. This order was accompanied with an elaborate "Social Media Policy" which the employees are required to abide while posting anything on social media. The Centre has carried out the research project by referring to varioous authorities including foreign Courts decisions, more particularly from USA, EU and South Africa.
- Research Project on 'Enforcing Fundamental Rights Against Citizens: The Need for a Civil Rights Act': The Indian Constitution ensures an effective remedy against the State in case of arbitrary exercises of power, but the same does not adequately address the needs of today. There have been instances where individuals and big corporate houses have infringed the rights of citizens enshrined under Part III of the Constitution. But the aggrieved party was unable to bring an action against them for the simple reason that the Article 12 restricts the applicability of fundamental rights to the government and its instrumentalities and not against private individuals. In this background, the Center has undertaken the research acitivity by referring to various authorities.
- Comments on the Anti-Discrimination and Equality Bill, 2016: Ever since independence, India made piecemeal attempts for ensuring a discrimination free environment with separate legislations for SC/ST, persons with disabilities, women and other groups. The Centre has undertaken the project to comment the bill in the light of the Rohit Vermula suicide, Section 377 etc, anti discriminations prevailing in USA, Canada, South Africa. The Centre aims to submit the same to the Government of India.
- **Open House with Mr. ShyamDiwan on 29 September 2018:** The Centre organized an Open House Session with Mr. Shyam Divan, Senior Advocate at the Supreme Court of India, who was the leading petitioner in the Aadhaar case. The session discussed the concepts of "Liberty, Privacy in relation with Aadhaar:



- **DM Hardoi Project on Juvenile Justice:** The team of students engaged with the DM Hardoi Project on Juvenile Justice facilitated a one-of-a-kind project in India on securing justice for juveniles through tracking rights received by them during their stay in rehabilitation homes as well as through tracking their record post release. The students focussed on the reformative aspect of law with an endeavour for the portal to reflect tenets of the best interests of the child and the reposed faith in reform. The team consisted engineers and policy scientists alongside the students.
- Sarjan Foundation Policy Drafting: A team of six students of the Centre assisted the Sarjan Foundation, Ahmedabad in developing model policies. The students prepared a comprehensive outline

of policies spanning the model code of conduct for the employees, prevention of sexual harassment at the workplace, anti-bribery policy, procurement policy, whistleblowing policy and conflict of interest policy. The team also assisted the foundation in drafting a contract of employment for Teachers for their informal non-residential centre named Badri.

- 3rd GNLU Essay Competition on Law & Society: The 3rd GNLU Essay Competition on Law & Society, 2018 was conducted under the able guidance of Prof.UpendraBaxi on the theme of 'The Careful Questioning of Socio-Legal Premises'.
- Panel Discussion on Opportunities and Challenges for Women Entrepreneurs in India: GCLS along with GNLU Legal Incubation Council organised the panel discussion as a part of the University's celebrations of the women entrepreneurship week. The panel includes Dr.Bimal N Patel, Director, GNLU, Ms. Pritibala N Patel, Founder, Usha International Electric Co., Baroda, Ms. Arpita Vyas, Founder, 'Wings to Fly- a Rehabilitation project for bootlegger women' and Ms. Phani Trivedi, Founder, 'Waste Engage', a social enterprise concerned with waste management. The discussion was on the importance of entrepreneurship, need to encourage women into entrepreneurship and problems faced by women entrepreneurs.

GNLU Centre for Private International Law (GCPRIL)

About the Centre:

GNLU Centre for Private International Law (GCPrIL) aims to foster the development of Private International Law in India with an objective to spread awareness about Private International Law among people engaged in administration of Justice i.e. Judges, Lawyers, Arbitrators etc., and other stakeholders. The Centre endeavors to develop expertise in this branch of law by encouraging research and publications. GCPrIL aspires to enroot this discipline by engaging prospective researchers and students in various programmes of study to develop Private International Law as specific field of study and area of professional practice.



Activities Undertaken:

• Symposium on Convergence of Private International Law in IPR and Cyber Law on 01 April, 2018: The Centre in collaboration with GNLU-Microsoft India Chair on Intellectual Property Rights and Policy Research and GNLU-GUJCOST, Research Centre of Excellence on IPR Laws, Policies and Practices, organized a 'Symposium on Convergence of Private International Law in IPR and Cyber Law', on 1st April, 2018. The objective of this symposium is to focus on Indian laws with appraisal of legal

developments in corresponding jurisdictions for Private International Law in Cyberspace and Private International Law in IP Regime.

• **Research Project:** The Centre for Private International Law in collaboration with Government of Gujarat under the Principal Investigator Ms. Harsha Rajwanshi and Co-Investigator Mr. Soaham Bajpai carried out the research project entitled "Primary care takers and Interparental Cross-border Child Custody Disputes- Should India sign Convention on Civil Aspects of International Child Abduction 1980?" The said GOG project covered different aspects of Hague Child Abduction Convention, Review of Cross Border Child Custody Disputes. In India, Analysis of Supreme Court reasoning with Hague Convention and gaps unaddressed by Justice Rajesh Bindal Committee Report.

GNLU Centre for Sports and Entertainment Law (GCSEL)

About the Centre:

The Gujarat National Law University Centre for Sports and Entertainment Law (GCSEL) is one of the first Centre in India that working in the area of Research and Development of Sports and Entertainment Law. The Centre has been expanding and developing ever since its inception in the year 2010 by working and getting associated with renowned and well known personalities of the field and has been working with dedication towards development and generating awareness of these niche fields of law in India. The Centre is presently working under 2 separate wings, one dealing with the Sports law, while the other with the Entertainment laws.

Activities Undertaken:

- Completed research project in collaboration with Government of Gujarat entitled "A Study on Sports Governance and Policy in India: Current Issues and Challenges": The Centre has undertaken the research project with an objective of helping the Government and Nation at large to identify issues and challenges related to the sports governance and probable and workable solutions.
- Sports and Legislature, Vol. II: In pursuance of the Centre's commitment to promote legal research and development, the Centre is committed to the promotion of avenues and forums which foster

advancement of legal thoughts. This publication is an attempt to examine and analyze the ways in which sports and law interact. The emphasis of Sports and Legislature is on providing an overview of some of the unique legal issues which arise in modern elite and professional sports at a National and International level.

• Sports Law Academy on Corruption in International Sports, 09-13 July 2018: The Centre has organized India's first Sports Law Academy on Corruption in International Sports from 9-13 July, 2018. The resource persons for the academic includes Mr. Hayden Opie, Senior Fellow, Melbourne Law School and Member, Court of Arbitration for Sports and Dr. Laurent Vidal, Professor, University Paris 1 Panthéon-Sorbonne. The esteemed resource persons discussed about corruption issues in sports in relation to match-fixing/spot fixing, doping, event hosting rights, sponsorships, advertising, etc.



• Certificate Course on Law and Business of Entertainment, 20-22 September 2018: The Centre in collaboration with BananaIP (BIP) Counsels conducted a three day Certificate Course on Law and Business of Entertainment from 20-22 September, 2018. The certificate course gave a bird's eye view of the basics of the law and business entertainment. It included specific sessions on entertainment contracts, negotiation skills, entertainment disputes and resolution. Mr. Sanjeeth Hegde, Senior Partner, Banana IP and Ms. Anchita Sharma, IP Attorney, BananaIP were the resource persons for the certificate course.

EXTENSION DIVISION

About the Division:

With a view to provide an access to the best quality learning resources across the country and overseas, GNLU-Extension Division has initiated practical oriented Online Diploma and Certificate Courses in different subjects of Law and Social sciences that bridge the gap between academia and profession. The Extension Division provides an integrated platform and portal for online courses, using information and communication technology (ICT) and covering six online programs to ensure that every student registered with benefits from quality learning material through ICT. Since last five years the University has offered courses in the areas like 1) Intellectual Property: Law and Management; 2) Internet Law and Policy; 3) Advanced Entrepreneurship Management and Corporate Laws. GNLU is the first national law university to offer such unique programs for the student and professional community in India. Recently it has launched online programmes on Legislative Drafting, Sports Law, Maritime Law and Contract Drafting that has



About Committee:


About the Cell:





About the Section:









Stream wise strength of final year (UG)




Grade wise result of final year (UG)




Specialization wise Strength of LL.M. batch

GENDER SENSATIZATION COMMITTEE

About the Committee: The philosophy of Gender Sensitization at GNLU involves creation of value and virtue based system for gender equality. It involves creation of gender sensitive social and cultural environment which discourages gender biased behaviors and practices. The aim of GNLU Gender Sensitization Commitee is to organise workshops and awareness programmes at regular intervals for sensitizing the employees and University's stakeholder with the provisions of the 'The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013'. Additionally, to promote gender equality, the Commitee also creates awareness on gender issues and work towards creating and enabling environment where men and women can study and work together with security and dignity.

Achievements & Initiatives: Team of Gender Champions have been appointed. The team of young girls and boys as Gender Champions advocate for gender equality and monitor progress towards gender justice. The team of students working as Gender Champions regularly organizes focused group discussions and debates and make recommendations to the committee members in addressing the gaps for gender equality. Committee organized a workshop on "Gender Awareness and Gender Sensitization" for the service providers, security guards and canteen staff on 10th August 2018.



INTERNAL COMPLAINTS COMMITTEE

The University aims to provide safe working and learning campus life for staff and students, free from gender discrimination and sexual harassment. As per the guidelines given by the UGC's Saksham Report with respect to the constitution of Complaints Committee on "Sexual Harassment of Women at Workplace", GNLU has constituted the Internal Complaint Committee (ICC) at the University. The Internal Complaint Committee (ICC) formed by GNLU shall be responsible for the formal Redressal of complaints of gender discrimination and sexual harassment. It shall receive complaints, conduct inquiries and recommend disciplinary action, if any, in accordance with the provisions of the "Regulations". GNLU is committed to having a work environment that is creative, productive and fulfilling. This includes ensuring that each student, teacher and non-teaching staff works together, in an environment of mutual trust, freedom of expression and dignity, free from all forms of violence, harassment, exploitation, discrimination and intimidation. Accordingly, ICC has framed the rules and regulations named 'Sexual Harassment of Women at the GNLU, Redressal of Complaints Regulations 2014', after due deliberations, which have been notified by the University. These regulations prescribe the institutional process to handle complaints of reported Sexual Harassment issues. Gender Sensitisation Committee is also responsible to create awareness on gender related issues and promote gender sensitisation.

DIGITAL MEDIA (GDM)

GNLU Digital Media (GDM) is a separately incorporated affiliate of the University. It is the only platform covering all the activities of the University. Although it is a brand new committee, its importance and scope is absolute and far reaching. The affiliation with the University gives GDM the insider's point of view; yet its editorial independence means that it covers the University and its entities with objectivity and integrity.

The purpose of having a GNLU Digital Media Team is to cover all the activities of the University merging with other Committees and put forward, on a common and wider platform, the activities undertaken at the University. The GNLU Digital Media Committee provides a common platform for all events whether Cultural, Academic, Sports or Entertainment. For the purpose of swift and efficient management, the GDM Committee is composed into three sub committees, namely the Operations Wing, Research and Content Creation Wing and the Multimedia Wing. We strive towards exploring and portraying opinions, views and coverage of social and legal issues, Alumni Interactions and Faculty Interviews. Unlike outsider publications, the Team has an inside track; provides substantive content, thoughtful commentary, and informed discussion, with an occasional bit of wit and irreverence.



GNLU LEGAL INCUBATION CENTRE

About the Council: The main objective of establishment of GNLU Legal Incubation Council is to encourage and support startups in the field of law with allied interdisciplinary areas. The Council aims to act as the institutional mechanism to provide guidance and function as the ecosystem on all aspect of enterprise building to nascent entrepreneurs in the domain of law.

The competition aimed to promote startup ventures in law and other domains. In the competition, many teams from across the nation participated and presented their business plans.
- Organized Workshop on Social Entrepreneurship: GNLU Legal Incubation Council organized 'the Workshop on Social Entrepreneurship' during August 3-4, 2018. The workshop was organized to identify, nurture and support budding social entrepreneurs across the country and help realize their dreams. The workshop imparts essential knowledge of how to start one's own social venture and the various facets that influence successful set up and operations.
- **Participation in Biothon organized by Government of Gujarat 2018:** Government of Gujarat came up with Biothon-Scheme on Hackathon of biotech solutions and GLIC has participated through their incubatees. Many GNLU students have participated in the same to provide solutions to various themes such as Swacch Bharat, Swastha Bharat, Preserving natural resources, Make in India and Digital India etc.

INITIATIVES TOWARDS CLEAN AND GREEN ENVIRONMENT (SWACCH BHARAT ABHIYAN)

About the Drive: GNLU, true to the ethos of giving back to the society and to contribute to Clean India Mission, organized regular cleanliess campaign at Koba Village and Adalaj step-well. Two dedicated house-keeping staff are kept on GNLU Housekeeping contract to provide daily cleaning services at Koba Village. The University observed 8 hours of mandatory cleaning in these places for all staff members.

LEGAL HISTORY MUSEUM

About the Museum: Legal History Museum of GNLU is a visual journey into the India's past where Indian laws were enacted and practiced in time and space. The museum is one of the most important landmarks in the journey of GNLU and is not merely a piece of infrastructure but a living epitome of the history. The museum comprises of evolution of Legal History of India, development of law and Judicial Institutions prevailing in ancient, medieval and modern times. With an aim to preserve and disseminate education on legal heritage to the civil society at large, GNLU has established this museum. It is one of its kind and is the first Legal History Museum in Asia. The open sculpture gallery became fully functional and the footfall in the museum was increased to an average 6000 visitors compare to 4000 visitors of previous years.

Activities Undertaken:

- Inauguration of International and Comparative Law Section 28 April 2018: This Section is exclusively designed to display evolution of law and judicial activities in various countries across the globe. This section depicts contribution of Indian judges at International level, East Asia Tribunal Tokyo Trial, International Administrative Building, such as United Nations, International Monetary Fund, The North Atlantic Treaty Organization, United Nations Educational, Scientific and Cultural Organization. The World Bank, and Supreme Courts of counties such as India, Pakistan, Sri Lanka, Bangladesh, France, Spain, USA, Canada, South Korea, Japan, South Africa, Vietnam. It also showcases the Ancient Wisdom on International Law.
- **Museum Heritage Festival 2018:** The Legal History Museum of Gujarat National Law University had celebrated the Museum Heritage Festival from October 1st to 10th 2018. The Master students of Museology of the Faculty of Fine Arts from the Maharaja Sayajirao University of Baroda were part of this festival as interns. During this Festival, the museum had also invited experts in museum and heritage fields to give lectures to the students on how law can be connected to the society by means of museum.



INFORMATION AND COMMUNICATION TECHONOLOGY

About ICT: The University has a state-of-the-art ICT infrastructure on the campus. Computer Systems of all offices and workplace of the University are connected through LAN with high-end Servers. The Computer Networks of various buildings are interconnected through fibre optic cables. The University has 1 Gbps Internet bandwidth connectivity under NMEICT project. The WiFi Network connectivity is available at the Hostels, Admin/Library block, Mess, Faculty cabins, Guest house and some outdoor locations of the campus. More than 230 computer systems with latest configuration and updated genuine software are installed at various sections and divisions of the University.

The ICT Section manages Campus Local Area Network of GNLU and provides technical support for Computer Hardware, Software and Network Infrastructure to the users. The Section is responsible for the availability of intra-campus connectivity of all the departments, hostels, staff quarters, guesthouse and the internet server connectivity of GNLU to the outside world.

LANGUAGE LABORATORY

About the Laboratory: Language learning is given the utmost importance at GNLU. The University offers seven foreign languages to the students. These are French, Spanish, Japanese, Chinese, Arabic, Swahili and German. Students choose to learn any one of the seven languages offered. GNLU conducts foreign language classes every semester. These classes run parallel to the regular semester. Each language is taught for a minimum of 120 hours, stretching across three semesters. This gives them basic proficiency in reading, listening, speaking and writing in the language of their choice. A final test is conducted in each foreign language a week before the regular end term examination. Students are then provided with certificates on the basis of their grades in the language of their choice. For students of the first semester learning a foreign language is compulsory.

State-of-the-Art Language Laboratory: GNLU is proud to have established a state-of-the-art language laboratory. It is used optimally by foreign language faculty for speaking and listening modules. The University also plans to use the language laboratory as a repository of Ancient Indian Languages. In the years to come, the University hopes to offer the study of ancient Indian languages such as Pali, Ardhmagadhi, Sanskrit, etc.

LEGAL SERVICES COMMITTEE

About the Committee: The GNLU Legal Services Committee has been set up in the year 2007 as per the mandate of Section 4(k) of the Legal Service Authorities Act, 1987 which reads as "Develop, in consultation with the Bar Council of India, programs for clinical legal education and promote guidance and supervise the establishment and working of legal services clinics in universities, law colleges and other institutions". The Legal Services Committee, established under statutory law provides assistance through a variety of methods, including traditional casework, summary advice, self-help, community legal education, community development and policy reform initiatives.

Activities undertaken:

- Legal Aid Clinic: Legal Services Committee has been running two legal aid clinics one in the campus which is open on all working days from 3:00 PM to 5:30 PM. The second legal aid clinic is run in Koba, which is open every Thursday and Friday from 3:00 PM to 5:00 PM.
- Saral Kanoon and PIL under Advocate Aditya Bhatt: GCLS executed a collaboration over a period of four months with Advocate Aaditya Bhatt, under the aegis of his initiative called Saral Kanoon. The Centre worked to prepare simplified versions of laws relating to women, as well as helped in designing graphics for the purpose of awareness generation. The team involved worked on topics such as Stalking, Sexual Harassment at the Workplace, Female Infanticide and so on. The Centre also assisted in background research for a PIL for Plastic Waste Management in Ahmadabad and the execution of the Plastic Waste Management Rules. The team also drafted various parts of the PIL, and identified specific failures on part of the responsible stakeholders to adequately address the problem of plastic waste management.

- Know Your Rights: 'Know Your Rights' initiative is a legal awareness program for students. In the odd semester of 2018, the Legal Services Committee carried out 12 such sessions in various schools, an NGO and an Industrial Training Institute.
- Plea bargaining with DLSA: A team of students assisted DLSA, Gandhinagar in their plea bargaining project. It is an ongoing initiative by Gandhinagar DLSA to promote and encourage under trials residing in Sabarmati central jail, Ahmedabad to participate in the plea bargaining process. The students were first given an orientation on the plea bargaining process, they then went to Sabarmati Central jail to talk to undertrial prisoners and talked to them about the plea bargaining process, benefits of plea bargaining and collected data of undertrials who were interested in plea bargaining.
- Assisting DLSA in LokAdalat: A team of six students of the Committee assisted DLSA, Gandhinagar in organising Lok Adalat. This LokAdalat was conducted on 9th September 2018 with the objective of settling loan default cases.
- Swachh Bharat Initiative: Importance of cleanliness was highlighted in the Swacchh Bharat sessions conducted in Koba and Valad. The sessions include both cleanliness drive and awareness programmes.
- Kalam Library: The Legal Services Committee has been running Kalam Library in Koba since past few academic years. This semester around 20 students were involved in running Kalam library. To garner more interest in reading, the volunteers indulged in role plays and storytelling.
- **Tree Plantation Drive:** The Committee volunteers carried out sapling plantation drive. Over 500 saplings were planted in the college, its vicinity and Valad village. The Committee collaborated with Van Chetna Kendra, Gandhinagar, for this initiative.
- Focus Group Discussion (FGD): Volunteers of the Committee interacted with few women of Koba village. The Committee has identified few of their problems which will be conveyed to the appropriate authority by the committee.
- Blood Donation and Health Check-Up Camp: A Blood Donation and Free Health Check-up Camp was conducted on 5 September, 2018, in the University campus, in collaboration with the Ahmedabad Civil Hospital Ahmedabad. The free Health-checkup was conducted by a group of doctors including two ENT specialists, two Ophthalmologists, two orthopedics, two general physicians, two pediatricians, two dermatologists, a dentist and a Diabetes Specialist; and nearly 27 technicians to ensure the smooth functioning of the event. Dr. Mehta, the University's general physician, was also present to assist the doctors. The Blood Donation camp was conducted by two doctors and 14 technicians. The Camp saw a footfall of 120 people who availed the Health Check-up services and around 180 people who donated blood.
- **Robin Hood Army:** The Robin Hood Army is a volunteer based organization that works to get surplus food from restaurants, weddings, temples, canteens and distributes it to the lesser fortunate sections of society in 80 cities across the world. Volunteers from the Committee have proudly contributed over 50 hours working 4 days a week in collaboration with the organization and providing leftover food from the college mess to village settlements in Koba and Raysan.



- Mental Health Awareness Camp: The Mental Health Awareness Camp was organised by the Legal Services Committee under the aegis of Centre of Law and Society of Gujarat National Law University, in collaboration with MINDS Foundation, Gujarat. The programme was conducted on 11th September 2018. The programme sensitized students regarding mental health, the ways of coping with the illness and the measures one can take to help friends and family suffering from the same.
- Centre Member Training on Financial Literacy: A training session was conducted by Learning Links and Vodafone India Foundation on financial literacy under their Jaddu Ginni Ka initiative. The objective of this training session was to equip Centre members with knowledge so that they can conduct financial literacy programmes at different places. These Centre members along with other volunteers will be conducting these financial literacy programmes in the upcoming semester.


LIBRARY AND LEARNING RESOURCES

The Library: Library is the central points of all academic, research and extension activities of the university. Information resources acquisitions, dissemination and preservation these are the main functions of GNLU library. Library is the learning place, it offers comfortable, inviting environment for reading, reference, and interaction. Library provide huge space to accommodate more than 300 users at a time, with common, group and silent reading space facilities. The library occupies 2760 square meter is the largest air-conditioned wing in the administrative building to stack and preserve print and digital resources. Library has a vast collection of more than 38000 print resources, books, e-books, law reports, journals, e-journals, online databases and reference collections.

Library Acquisitions: Library acquired more than 2200 Books, which includes books on international law, Financial and investment laws, Intellectual Property Rights, Management, special collections on startup, Literature, Political science, History, Management, and Commerce. The best collections in the areas of law and non-law subjects are the top priority of library collections development.

Special Collections: GNLU Library has received another special big donation collection from the Peace Palace Library, the Netherlands. This collection includes reference books, reports and collections of various research work. Peace Palace Library Director, Prof. Jeroen Vervliet had collected the donation and shipped to GNLU library in the month of December 2018. This is really very rich collections for research and teaching purpose. Library subscribes globally identified 19 best online databases like Manupatra, SCC Online, LexisNexis, Hein online, JSTOR, World Bank eLibrary, Nature, CMIE, Corporate Law Advisor, Kluwar arbitration, Taxation online, Cambridge, Oxford, Taylor and Francis online, Edward Elgar, GAR, Investment Arbitration Reporter (AREPORTER) and IndiaStat online databases.

Library Usages: Library offers its digital resources access by 24X7 and 9 to 12 for print resources. More than 35107 thousands books circulations, thousands of reference queries handled/answered by reference section and similar huge access for digital resources, reading purpose, this shows the extensive usages of GNLU library. The library is a growing organism, to keep it updated to make a big repository of legal knowledge is the aims of GNLU library.



MODEL UNITED NATIONS (MUN)

About the MUN Society:

The GNLU Model United Nations Society was founded in March 2015, with an aim to promote and foster an MUN culture amongst students within the University and outside. It aims to provide a platform where learning is facilitated by allowing students to confront a range of issues that the world is facing today. The objective is to enable students to broaden their worldview, develop an appreciation of differing views, face the challenges of negotiations, see the benefits and rewards of cooperation and discover the human side of international relations and diplomacy. At GNLU, the society too aims to prepare students not only for their future careers but for global citizenship as well. The MUN Society does this through conducting intrarounds every semester, as well as organising a national-level inter-college MUN conference. Though in a small way, we aim to fulfil the goals set out by the founders of the United Nations in the Preamble of the Charter: "to practice tolerance and live together in peace with one another as good neighbours," and to further this aim, the Society hosted its first national-level MUN, GNLUMUN'16, The first year of the Society was witness to the following achievements

The Discussion witnessed a Panel of renowned experts, namely, Ms. Veena Bandyopadhyay, (Planning, Monitoring & Evaluation Specialist, UNICEF, India), Mr. Sudarshan Rama badran (Deputy Director, India Foundation), Ms. Niha Masih (Independent Journalist) and Mr. Raghav Awasthi (Practicing Lawyer, Supreme Court of India) deliberating upon the policy fallacies and mechanisms of constructive change through the impetus provided by Ms. Aarti Tikoo Singh (Editor, Times of India) who moderated the discussion. • **GNLU Model United Nations, 2018:** The Third edition of the GNLUMUN took place from the 06 - 08 April 2018. This edition simulated the United Nations Security Council, the Human Rights Council, the Special Economic & Political Council, the G20 and the International Press. The event saw over 103 Participants from various Universities across India.



MOOT COURT COMMITTEE (MCC)

About the Committee: The Moot Court Committee ("MCC") is constituted by student members from all batches of the University, who are selected through an interview process. Dr. Girish R. heads the Committee as its Faculty Convener, with help from Ms. Garima Goswami, Faculty Co-Convenor and Ms. Palak Jagtiani, Member. For the academic year 2017-18, 60 members were selected alongwith Student Convener, Mr. Yuvraj Rathore, and Student Co-Convener Ms. Gayathree Devi. All decisions are taken by the Committee after elaborate consultations among all members.

Activities Undertaken:

- Intra Rounds: The MCC adopts a twin intra rounds system, which serves as a fair procedure to decide which students can represent the university in national and international moots. In order to encourage students to take up the Researcher's spot in a moot team, a separate Researcher's Round (which requires only memorial submission) is also conducted every year. In the year 2018, the MCC conducted 6 intra rounds and 2 challenger rounds to select students who shall be representing the University at moot court competitions.
- 1st Intra Round, January 2018: This round was conducted to screen students from the 1-5 year and select top performers for the second intra round. The top 91 oralists and 51 researchers qualified to the next round. The problem was drafted by Ms. Padmaja Menon, who is an alumnus of NLU-Jodhpur. The judges were Ms. Vacha Desai, Mr. Munjaal Bhatt, Mr. Dwijen Joshi, Mr. Randall Williams, Mr. Ishan Joshi, Mr. Nisarg Desai, Mr. Rishiraj Baruah, Mr. Harshvardhan Abburi, Ms. Neelam Pathak and Mr. Kunal Sharma.
- 2nd Intra Round, February 2018: After the first round, the selected students took part in the Second Intra Moot Court Competition which involved issues revolving the issues of Public International Law.

The problem was drafted by Mr. Rohan Tigadi who is an alumnus of NLU-Jodhpur. The judges were Mr. Rohan Tigadi, Ms. Ishita Kumar, Mr. Vikrant Pachnanda and Mr. Shubang Setlur.

- 1st Intra Round, August 2018: This round is conducted as a screening round for students from 2nd -5th year. The top 90 oralists and 50 researchers moved to the next intra round. The problem was drafted by Ms. Yashna Mehta, an alumnus of National Law School of India University. The judges were Ms. Shriya Maini, Mr. Ishan Joshi, Ms. Aanchal Kapoor, Mr. Randall Williams, Mr. Dwijen Joshi, Ms. Anu Shrivastava, Ms. Kriti Jha, Mr Harsh Parekh, Ms. Priyal Parikh, Mr. Tirth Bhatt and Mr. Apoorv Jani.
- 1st Intra Round for 1st Years, August 2018: The MCC recognizes the difficulty faced by first year students in competing with their seniors at the very first go. Therefore as every year, the MCC conducted special classes, with the help of students from the fourth year, to help the first years understand the rules of mooting. The MCC also allows first year students to watch the seniors' intra rounds. Secondly, a separate intra round moot based on municipal law, usually tort law, is organized for first year students exclusively. The top 40 students were allowed to participate in the second intra round and compete with their seniors. In order to ensure that the students take the activity seriously, the memorial marks and oral marks are added as a part of their continuous evaluation for the subject of Legal Methods. For this academic year, the problem was drafted by Mr. Dhruv Malhotra and Mr. Shivansh Jolly who are the alumni of GNLU. The judges were Mr. Dhruv Malhotra, Mr. Shivansh Jolly, Mr. Ishan Joshi, Mr. Randall Williams, Mr. Rohan George, Mr. Sagar Godbole, Mr. Advait Gohil, Ms. Yashma Mathur, Ms. Stuti Joshi, Mr. Munjaal Bhatt, Mr. Hari Krishna Pramod, Ms. Arunima Chandra and Ms. Kriti Jha.
- 2nd Intra Round, September 2018: The 2nd Intra Round of the odd semester is organized in two parts; one round based on a problem of Public International Law ("PIL Round"), and the other on Arbitration law ("Arbitration Round"). Students who wish to participate in international or national moot court competitions participate in the PIL Round, whereas those who wish to participate in arbitration moots participate in the Arbitration Round. The PIL Round problem was drafted by Mr. Deep Choudhuri, an alumnus of GNLU. The judges were Mr. Prateek Rath, Ms. Ankeeta Parhi, Mr. Sukrit Kapoor and Ms. Ishita Farsaiya. The Arbitration Round problem was drafted by Ms. Anu Shrivastava, an alumnus of GNLU. The judges were Mr. Prakshal Jain and Mr. Tirth Bhatt.
- Vis Challenger Round, September 2018: The MCC conducted a challenger round for the prestigious Willem C. Vis International Commercial Arbitration Moot organised in Vienna and Hong Kong every year. This round included a memorial submission on behalf of the teams.

GNLU Students at Moot Court Competitions: In keeping with the active mooting culture in the university, GNLU students participated in over 100 moot court competitions, client counselling, mediation, judgment writing competition in the last year.

STUDENTS ACTIVITIES COMMITTEE (SAC)

About the Committee: The Student Activities Committee, popularly known as SAC, is a committee of students who work to promote extra-curricular activities in the University. The various events and activities organised by SAC give the students, the much-needed break from the busy and stressful law university life. SAC consists of nine clubs namely, Art Club, Music Club, Photography Club, Theatre Club, Film Club, Dance Club, Gaming Club, Literary-Entertainment Club, Quiz Club.

Events Organised:

- Swara Natya Sanjhe: SAC organized 5th edition of annual folk and cultural event Swarna Natya Sanjhe on September 12th 2018. The event saw participation of students representing various states. The Theatre club performed a play titled "Mundan" which was a sarcasm on our politicians. Students from the Music Club performed songs from their own states like in gadwali, Kannada and Gujarati language. The much applauded was the Bihu dance performed by the members of the Dance Club. The program concluded by the Gujarati Garba.
- GNLU-GARBA Celebration: Garba is a form of dance which originated in the state of Gujarat. The name is derived from the Sanskrit term Garbha ("womb") and Deep ("a small earthenware lamp"). Many traditional garbas are performed around centrally lit lamp or a picture or statue of the Goddess Shakti. SAC organized the annual GNLU Garba on 13th October, 2018 on one of the 9 Navratri days. Enthusiastic students from all the years dress up in traditional Gujarati attire and dance on Gujarati folk songs.





OFFICE OF THE DEAN – STUDENTS' WELFARE (ODSW)

About ODSW:

The Office of the Dean of Students' Welfare (ODSW) looks after the welfare of the students with active support from the faculty, the administration and the elected representatives of the students. ODSW is a bridge between students and authorities at GNLU. We create a formal platform enthused with the energy to channelize all the imaginative, emotional, technical and even the unheard chords of the students. This office, through its two wings Student Welfare and Grievance Redressal Committee (SWGRC) and GNLU Student Mentorship Programme (GSMP), is committed to helping all students at the University to reach their fullest potential in and out of the classroom.

Activities Undertaken by SWGRC Group Therapy Sessions: The SWGRC recognized the need to approach mental wellness in a unique manner, and conceptualized group therapy sessions. Under the guidance of the University counsellor, Dr. Urja, students were put into groups of ten every Tuesday, and indulged in group therapy – a framework similar to Alcoholics Anonymous. The initiative was well received by the participants, who reported remarkable progress after each session, as they realized that they were not alone in their struggles. Overall, the initiative benefitted at least 100 students.



Painting Sessions: The SWGRC organised painting sessions, which took place in the hostel premises. Students painted the walls of their respective hostels and promoted a clean environment in the hostel. The event saw participation of at least 200 students from all batches.

Online Grievance Tracker: An online Google Form was circulated to the student community, which served as an apparatus for students to register their grievances. Further, the Form allowed students to monitor the progress of each and every complaint.

Google Drive with Class Notes on the PDC Server: The SWGRC coordinated with the ICT Department to install a link on the GNLU PDC Server, which led to a repository of class notes uploaded by the student community. This repository allowed junior batches to access class notes of their seniors with ease.

Aside from these, the SWGRC regularly conducted batch level meetings and meetings with the Administration to fulfil its primary role of serving as the conduit between the Administration and the student community.

Activities Undertaken by GSMP:

Interactive Session with Students: GSMP resolved to organize general interactive sessions with students where questions of general interest would be discussed. One such session was organized on "Applications for Higher Education and Scholarships" on 12.09.2018 which was taken by our alumni Sameer Bhat, Gayathree Kalliyat and Isa Hakim from the 2013 Batch.

Alumni as Mentors: The GSMP after consultations with the Dean Students' Welfare and the Dean Academic Affairs decided to extend the mentorship programme to alumni as well and make special arrangements under the mentorship programme for people belonging to underprivileged backgrounds which will be given effect in the coming semester. The modalities with respect to the same have yet to be finalized.
