Memorandum of Understanding

between

Gujarat National Law University

And

KD Hospital

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is made at **Gandhinagar**, this day of **June 2024** between the **Gujarat National Law University**, having it's Office at Attalika Avenue Knowledge Corridor, Koba, Gujarat-382426, India through Registrar or duly authorised by the University (Hereafter referred to as '**GNLU**') and which expression shall mean and include it's successor, administrator, executor and assignee of the FIRST PARTY.

AND

The **KD Hospital, Ahmedabad** having it's Office at SG Road, *Vaishnodevi* Circle, Ahmedabad, Gujarat-382421, India duly incorporated under the Companies Act through it's Unit head duly authorised in this behalf. Herein referred to as '**Hospital**' and which expression shall mean and include it's successor, administrator, executor and assignee of the SECOND PARTY.

AND whereas, the GNLU is desirous of availing medical facilities/ treatment for it's Employees, their family (including spouse, children and parents) Students.

AND WHEREAS, the **KD Hospital, Ahmedabad** is ready and willing to provide medical services (Outdoor and Indoor) to the said Employees, their family and Students as agreed by and between them with the following terms conditions: -

1. The **KD Hospital, Ahmedabad** shall admit or attend the Employees, their family (as mentioned above) and the students for getting treatment on production of photo identity card or authorisation letter by the authorised person from **Gujarat National Law University**. During or after the treatment of the GNLU Employees, their family (as mentioned above) and the Students as the case may be, the Hospital shall take the expenses/ expenditure/ bill incurred in connection with treatment, directly from the beneficiary. GNLU will not be responsible for making payment of any nature such as bills or items such as special attendant charges, telephone, snack, food and beverages etc. and the Hospital shall directly collect all charges from the beneficiary.



2. The Hospital shall provide the following concessions/ discounts for the Employees, their family members (as mentioned above) and the students of the University: -

OPD Services-

- 10% Discount on Radiology and pathology investigation (In house only).
- 10% discount on OPD consultation (speciality and super speciality).
- 10% discount on health check-up packages.
- No registration charges to be taken.

IPD Services-




- 5% discount on IP excluding consumables, medicine, packages, implants and blood products.

(Applicable for cash billing, for insurance rates are as per hospital policy)

3. The hospital shall also provide 'Ambulance' during any emergency of the Employees, their family members (as mentioned above)/ Students from their residence or GNLU.
4. GNLU shall facilitate KD to conduct medical camps, training and awareness programmes for the students and employees of GNLU.
5. Terms of Payment: KD will accept payment in Cash/ Card (Debit/Credit) at the time of availing of services. For inpatient cases, depending on the type of health insurance, cashless treatment can be availed, subject to the approval of the insurance company/TPA upto the approved limit.
6. The Memorandum of Understanding will be valid for three (3) year from June 10, 2024, and may be extended upon mutual agreement.
7. MoU can be terminated by either party by giving one-month prior notice.
8. Any disputes arising out of this agreement are subject to arbitration and fall under the jurisdiction of the courts in Ahmedabad only.
9. Any Clarification/ changes in the MoU may be affected through an addendum, after written approval from both the parties
