

About Gujarat Law Journal

The Gujarat Law Journal (GLJ) started in 2011, as a part of Sapta-Dhara Research Initiative of the Vibrant Gujarat Summit 2011. GLJ is a bi-annual, peer-reviewed Journal having an ISSN number. It provides a dedicated platform to express views on topical legal issues, thereby generating interplay of ideas on emerging matters and issues.

This platform is also destined at generating and acknowledging the initiative and desire of young law students, academicians, lawyers, and legal advisors to contribute in the field of law and at society at large. The purpose of the Journal is to report quality research, develop theory and explore new perspective on different issues and challenges prevailing in the society.

The Journal offers an avenue for high-quality empirical and theoretical scholarly work with an interdisciplinary approach towards law. In the present globalized scenario, it is necessary for such an approach so that people from varied fields of academia can understand the importance, impact, and the image of law as it can affect the community at large. In nutshell, GLJ provides a forum for the exchange of ideas and constructive debate on legal, interdisciplinary and policy-related issues surrounding us.

Procedure

GLJ works with a double-blind review procedure. After the article is received, as part of the editorial process, it sent for an external review. On the basis of the review reports, the author is thereupon asked to *revise and resubmit* the article by incorporating the comments by expert reviewers.

The journal stands for novel research and thus, existence of plagiarism above 30% would lead to rejection of the paper before it is sent out for external review. The same shall be duly communicated to the author.

On acceptance of the paper, the contributor will be asked to assign copyright to GLJ, Gujarat National Law University, Gandhinagar.

The Journal reserves the right to deny the publication of the article at any stage of the review process, and the same shall be communicated to the concerned authors with due effect.

Contributors are responsible for obtaining permission to reproduce any materials, including photographs and illustrations for which they do not hold copyright in both print and electronic formats and for ensuring that the appropriate acknowledgments are included in the manuscript.

Style Guidelines

- The submissions must contain an **abstract** of not more than 200-300 words. It must be italicised and inserted just after the title and the author's name.
- A cover page must be submitted along with the paper. The cover page must provide the Title of the paper, Author's details, providing Name, Address, Phone number, email ID and institution's name, and word count.
- **Co-authorship** is permitted but it must not be more than **two**.
- The submissions to be accepted by the Journal are of the following **categories**:
 1. Long Articles: 5000 words minimum
 2. Short Articles: 3000 words minimum
 3. Case Comments: 3000 words minimum
 4. Book Review: 2000 words minimum
- The word limit in the journal is *exclusive* of the footnotes. There is a provision for *flexibility* in terms of word limit depending upon the quality of the submission.
- All Submissions and Abstracts should be sent as a Word file by e-mail to glj@gnlu.ac.in.
- **20th Harvard Bluebook Edition** has to be strictly followed as the format for citations. Authors shall only use footnotes and no *Bibliography* and no *End notes* shall be inserted in the article. The citations can also *not* be inserted in the main text, for instance through parenthesis.
- The submission must have an **introduction** and a **conclusion**, along with its body being divided in suitable **heading** and **sub- headings**.
- The name of a **case** in the main text has to be italicised.
- Any **quoted text**, whether of a judgment or of an author, *etc*, has to be mentioned in a separate paragraph, italicised, with one indent. The word limit for the quoted text is **100 words**.
- **Formatting** that has to be followed for the article is as follows-

1. **Title:** Times New Roman, size 14, Centre Aligned, Small Caps, Bold.
2. **Author's details:** Font Times New Roman, size 12, Right aligned, Italicised.
3. **Abstract:** Font Times New Roman, size 12, Justified, Italicised, Line spacing 1.5.
4. **Main text:** Font Times New Roman, size 12, Line spacing 1.5, justified (As per the discretion of the author, some words or sentences can be made bold or italicised, but the same shall be appropriate). There must be a one-line gap between all paragraphs and headings.
5. **Footnotes:** Font Times New Roman, size 10, Line spacing 1, justified. No speaking footnotes are permissible.

Withdrawal

The author must communicate to the editorial board at glj@gnlu.ac.in to withdraw from the submission process. The withdrawal must be so communicated before the acceptance of the article by the editorial board.
