MANUSCRIPT SUBMISSION GUIDELINES:

- 1. The author/s are request to strictly follow the guidelines (stated below) and the style sheet for citation and references.
- 2. Manuscripts and all editorial correspondence should be addressed to Editorial Board of GNLU Journal of Law, Development and Politics, Gujarat National Law University Attalika Avenue, Knowledge Corridor, Koba, Koba (Sub P.O.), Gandhinagar- 382426
- 3. Manuscripts should be submitted in online (soft copy), preferably in MS Word, as an attachment to an email to be sent to the Editorial Board at <u>gjldp@gnlu.ac.in</u>.
- 4. Manuscripts should be submitted in Garamond, with font size 12, line spacing 1.5'; justified, with sufficient margins of 1.5" to the left and 1.0" on all sides.
- 5. The author(s) is/are required to submit a covering letter containing all personal details (Name of the author/s, their degrees, Designation, Name of College/University/Institution, Postal Address, Phone Number and E-mail ID) in separate sheet.
- 6. The author(s) is required to submit along with the Manuscript the Submission Application and Waiver form. The Submission Application and Waiver form is available on the website, https://gnlu.ac.in//Content/journal-of-law-development-and-politics/pdf/Submisson-Application-Waiver-Form.pdf
- Attach (1) the Submission Application and Waiver Form and (2) Covering Letter with details (3) your Microsoft Word formatted submission to an email with the subject "Submission".
- 8. IMPORTANT: Manuscripts shall be assessed by subjection to Blind Review Procedure. Reviewers shall not be informed of the author's name, university, year in college, or any other personal information.

EDITORIAL POLICY OF GNLU JOURNAL OF LAW, DEVELOPMENT AND POLITICS

Each Manuscript should contain:

- a. Title page with full title and subtitle (if any). The Manuscript should not contain any identification of the author/s, which shall be ground for rejection of the submission.
- b. Research Area: (e.g., International Relations, Law, Socio-Legal, Public Policy....)
- c. Suggested Keywords up to 10 words
- d. Abstract of 200-250 words
- e. Citation: GJLDP prefers the author-date system with parenthetical citations or references and endnotes. Endnotes, when used, should be numbered serially and presented at the end of the paper. The citation style should conform to Chicago Manual of Style (CMS) 17th Edition. The full citation of all reference should be compiled together in alphabetical order (by author's surnames) and presented as a list of References at the end of the manuscript. - f. Notes (if there are points that require discussion/explanation in the article but not in the body of the text) should be kept to a minimum and should be numbered and compiled as endnotes at the end of the articles just before the references.
- g. Tables: tables should be supplied separately from the text in Microsoft Word or Excel format and their position indicated in the text. All tables should have short descriptive captions with footnotes and their source(s) typed below the tables.
- h. Illustrations: all line diagrams and photographs are termed 'Figures' and should be referred to as such in the Manuscript. They should be numbered consecutively. Line diagrams should be presented in a form suitable for immediate reproduction (i.e. not requiring redrawing), each on a separate A4 sheet or separate file. They should be reproducible. All figures should have a resolution of minimum 300 dpi, 1,500 pixels, min width 4 inches and their format should be TIFF or JPEG. Due permissions should be taken for copyright protected photographs/images.
- i. Authors are responsible for obtaining permissions from copyright holders for reproducing any illustrations, tables, figures or lengthy quotations previously published elsewhere. Permission letters must be supplied to Editorial Board.
