

ABOUT GASLA

Non-State actors, including private investors are no exceptions to this emerging trend. It is becoming evidently clear that supremacy in air and space is set to define international relations come. years the in to Recognizing the potential of these developments, the GNLU Centre for Public International Law has conceived the GNLU Academy on Air and Space Law (GASLA) as a platform for engaging in discourse on contemporary legal issues in these fields. The first edition of GASLA was successfully conducted between 14 and 23 September 2016, in collaboration with the Institute of Air and Space Law, University of Cologne and the Forum for Integrated National Security. Encouraged by the success of the first edition, the GNLU Centre for Public International Law is organizing the second edition of GASLA from 16 September to 22 September 2017.

AIMS AND OBJECTIVES

- To familiarize participants with country specific approach with regard to air and space law.
- To enable participants to appreciate the challenges in developing national aviation and space policy.



CONCEPT NOTE

Outer Space Treaty (OST) entered into force in October 1967. It provides a basic framework on international space law. 2017 marks its golden jubilee. The occasion is a matter of pride but at the same time offers an opportunity to reassess its adequacy in the light of fast changing global arena of ever increasing human activities in space. However, international space law comprises not only OST but other conventions and declarations to deal with various aspects of human endeavors in space. Various space faring nations have developed or have initiated the process of developing their own policies to regulate their space activities and some have enacted legislations for this purpose. Need is increasingly felt to overhaul the regulatory framework of international space law in order to address the contemporary challenges which could not have been foreseen at the time of negotiations of OST.

International civil aviation has emerged as a classical example of global cooperation both on ground and in airspace. While its safety and security continue to be a major challenge requiring global attention at the highest level, its economic viability too has engaged policy makers on continual basis. Regulatory framework for its safety and security as well as economic violability has been developed at the international level with the involvement of ICAO. Nevertheless, with the rapid improvement in aviation technology as well as emergence of newer forms of threats to its safety and security, regulatory framework for international air law needs to be constantly amended.
