

The first ever All India Legal History Congress was organized and conducted by the Gujarat National Law University in February 2020 in Gandhinagar. It brought together teachers, students and other aficionados of Legal History. There were quite a few interesting papers presented demonstrating how much such a platform was needed and the immense possibilities for research in this field. While history of law and the judicial system, in different periods, have been taught in law colleges for guite a long time in India and a few books written, there has been very little interest shown by either historians or law teachers in India in the actual pursuit of Legal History. Most good scholarship is the result of the painstaking work of foreign scholars, mostly from Western countries. At the same time with the proliferation of the institutions offering the five years integrated Under Graduate law programmes Legal History is being systematically taught in all of them across the country. However, till last year there was no platform for sharing their research interests and findings. The 1st All India Legal History Congress followed by the formation of the All India Legal History Association filled that need. It is in this background that the Tamil Nadu National Law University (TNNLU), Tiruchirappalli is organizing the 2nd All India Legal History Congress (AILHC) on May 21st and 22nd 2021 online. This Legal History Congress is being organized with the generous financial support of the Government of Tamil Nadu. We are grateful to our Pro Chancellor, the Hon'ble Thiru C. Ve. Shanmugham, Minister for Law, Courts, Prisons and Mines & Minerals of the Government of Tamil Nadu.

We hope that this Congress will provide an opportunity for everyone interested in various facets of legal history whether they are legal historians, historians from other fields, academicians from the social science disciplines, judges, advocates, research scholars and students across the country to present papers on the subthemes indicated at the end, in order to enhance our knowledge of the Legal History of India and other parts of the world. The theme for this year is "Pursuit of Legal History of India in the 21st Century". There will be 8 Sections divided on the basis of chronology and interested persons are invited to submit their abstracts on the sub-themes, enumerated at the end, according to the time period of their interest.

LEGAL CENTRE FOR HISTORY OF SOUTH INDIA


A research centre for the pursuit of the study of Legal History, especially that of South India in general and of Tamil Nadu in particular, is urgently needed in order to document the very rich and well developed legal and judicial systems of this



government during the Côla period is very well known. However, much of the immense treasures of similar records are yet to be taken note of by teachers and students of legal history. The Government of Tamil Nadu has sanctioned an initial grant to set up a Legal Centre for History of South India at TNNLU. The objective of the Centre is to carry out the research into the Legal History of South India from the earliest times till the creation of India. Organising this Congress under the aegis of this Centre is the first step in that direction.

LEGAL HISTORY MUSEUM

In order to preserve and exhibit the rich and diverse legal history of Tamil Nadu, a Legal History museum was inaugurated on 30th September 2019 in the building housing the Library. There is a small collection of epigraphs dealing with some aspects of the Legal History of Tamil Nadu in the ground floor of the Library. On 22nd February 2020, the former Chancellor of TNNLU, Hon'ble Mr. Justice Amreshwar Pratap Sahi, Chief Justice of the Madras High Court unveiled a mural of scenes from the Silapathikaram in the foyer of the Library in TNNLU. In February



2020 the government of Tamil Nadu granted a generous fund to procure copper reliefs, models, photographs etc., to extend the museum and digitalize documents, for registration and insurance for the same and to create digital archives in the Legal History Museum at TNNLU. We hope to establish a fully functional Legal History Museum before the end of 2021.

TNNLU: A GLANCE

TNNLU is located in Srirangam Taluk of the Tiruchirappalli Corporation, formerly known as Trichinopoly. This institution of learning was established by the Government of Tamil Nadu by an Act of State Legislature (Act No. 9 of 2012) to provide quality legal education. TNNLU is the brainchild of the former Hon'ble Chief Minister Dr. J Jayalalithaa who laid its foundation stone on 13th February 2012. Tiruchirappalli, known as Rock Fort City, is well connected by road, rail, and air. This city was the capital of the Côlas in the Sangam period, i.e., in the 3rd century B.C. It passed through the hands of the Pallavas, the imperial Côlas, the Pandyas, the Delhi Sultanate, and the rulers of Vijayanagara. Tiruchirappalli was also a battlefield in the Carnatic Wars of the 18th century during the administration of the East India Company.

TNNLU offers two five years integrated Under Graduate Programmes, B.A.LLB. (Hons.) & B.Com.LL.B. (Hons.) and three one year LL.M. Programmes:-Corporate and Securities Laws, Intellectual Property Laws and Natural Resources Laws. TNNLU aims to develop among the students and faculty a sense of responsibility to the society through an interdisciplinary approach to the study of law. TNNLU is a fully residential campus with separate hostels for men and women. The library aims to have state of the art with an updated Web OPAC system, Remote Access facility, and air-conditioned discussion rooms. TNNLU is located about 10 kilometers from the District and Sessions Court and other Subordinate Courts, thus facilitating easy and effective interaction between the students and faculty of TNNLU and the Bar and Bench of Tiruchirappalli.
