SUBMISSIONS UNDER THE FOLLOWING CATEGORIES ARE INVITED:

- ➤ Long Articles: Should not exceed 5000 words, including Footnotes.
- ➤ Short Articles: Should not exceed 2500 words, including Footnotes.
- Case comments and Case summaries: Under 2500 words, including Footnotes.
- ➤ General Write-ups and Comments: Under 2500 words, including Footnotes.
- ➤ Review of Books on Contemporary Legal Issues and Associated Disciplines: Under 2500 words, including Footnotes.

SUBMISSION GUIDELINES:

- All contributions must be accompanied by a covering letter stating the title, author's full name, university and year of study and author's contact details, qualifications and institutional affiliations, if any. Only the covering letter should contain the above mentioned details and not the manuscript. Co-authorship (up to 2 authors) is permitted. - All work should be sent in MS Word format- (.doc or .docx).
- The mode of citation to be followed by the Author(s) should be as follows:
 - Main Text Garamond, font size 12, 1.5 spacing, justified, with a margin left
 1.5 inch and right 1.0 inch, top 1 inch and bottom 1 inch in MS-Word.
 - Foot Notes: Garamond, font size 10. Substantive foot notes are accepted.
 - Citation format: The style of referencing should be as per Indian Citation Index. For further details, please refer to the following link: https://gnlu.ac.in//Content/gujarat-law-journal/pdf/submition-guidline.pdf
- > The paper should be free from all grammatical and spelling errors.
- Non-conformity could be a ground for rejection.

Deadline for Submissions: 20/06/2019 (each article except book reviews should be accompanied by an abstract of not more than 200 words which should be included in the main word count.)

All submissions are to be made only in electronic form. They are to be sent to gli@gnlu.ac.in and cc to stalukdar@gnlu.ac.in. The subject of the email should be "Manuscript Vol. 4 Issue I –GLJ".

Scope of the Submissions: The work must be on contemporary legal issues, case analysis and policy in India or/and outside. The language used must be formal and clear, adhering to the submission guidelines.

Review Process:

The submissions received will be reviewed by the Editor(s) and external reviewers through a double blind peer review process. They will determine the quality of the manuscript and whether the subject matter fits within the scope of the topic. The submissions shall be evaluated on important parameters such as the quality of the research, originality in thoughts, analysis of facts and the author's demonstrated ability to develop theory and explore new perspectives on different issues and challenges that prevail in society.

Award:

The Editorial Board will award the best submission a prize money of Rs 5000/- through the 'GNLU Navinchandra Desai Law Foundation Chair'. The collaboration is established with the vision of providing a platform to students, researchers, academics, practitioners and the like to develop their skills and to continue legal and interdisciplinary research and writing.
