### 1) ABOUT THE GUJARAT NATIONAL LAW UNIVERSITY:

Established in the year 2003 as a statutory University by the Government of Gujarat, Gujarat National Law University (GNLU) is one of the premier National Law Universities in India and recognized by the Bar Council of India, and the University Grants Commission, New Delhi. The University aims to advance and disseminate learning and knowledge of the law and legal processes and inculcate among the students, research scholarship, legal analytical skills, and legal reasoning and a sense of responsibility, rectitude and justice to enable them to serve the society in myriad roles as legal practitioners, researchers, reformers and policy makers, and other similar roles; to make law as an instrument of social change and development; and to undertake the inter-disciplinary study of the law in relation to management, technology, and development.

GNLU as a nodal agency, is empowered to enhance the standards of legal education, training and extension for 32 law colleges in the state of Gujarat, catering to nearly 12,000 students every year. GNLU offers interdisciplinary legal courses in five faculties namely, B.A., LL.B., B.Com., LL.B., B.Sc., LL.B., B.S.W., LL.B., B.B.A., LL.B. and LL.M. as well as doctoral programmes in law and inter-disciplinary fields and foreign law and languages programmes.

Over a period of time since its inception, the University has established itself as a leading National Law University in the country, with its intensive focus on research-based activities and teaching through the establishment of specialized centres, extension and training programmes, national and international conferences, student exchange programmes, and guest lectures. For its exemplary efforts in the promotion of legal education, UGC has recognized GNLU as a model legal university in terms of access, equity, relevance, and high standards in 2011.



### 3) RESEARCH BASED ACTIVITIES:

The brief of the Research activities are as follows:

- A comparative analysis of the judicial appointments in more than 20 countries around the globe- 'Appointment of Judges: Procedures in Commonwealth Member States and Other Selected Jurisdictions'.
- 3. Weekly News and Views Bulletin : On the weekly basis, centre brings forward news and issues of utmost importance related to Constitutional and Administrative Law. This news bulletin is then circulated among the faculty and students of GNLU and it is also sent to the stake holders which includes Judges, Advocates, other Law Colleges, NGOs, and other Professionals and Academicians and thereby invites their views on those issues.

### 4) CCAL'S TRAINING AND EXTENSION ACTIVITIES

# a) "Certificate Course on Expanding Horizons of Fundamental Rights in India" (24<sup>th</sup> – 27<sup>th</sup> September, 2015)

The Centre for Constitutional and Administrative Law, organized Certificate Course on Expanding Horizons of Fundamental Rights in India. This course was planned with an object to impart the knowledge of fundamental rights and its applicability in the current scenario. The course offered a comprehensive and basic understanding of fundamental rights in India. It covered landmark and latest judgments of Supreme Court of India and also dealt with the contemporary issues relating to fundamental rights.

The course covered with several themes like: Fundamental Rights: Conceptual and Historical Reflections, Right to Equality: Key Concepts and Emerging Issues, Fundamental Freedoms and Social Control, Right to Property and Right Against Exploitation, Religious, Cultural and Educational Rights. The lecture method, Group discussions and Case studies approach was adopted to cover the whole syllabus.

There were 52 candidates who have registered themselves for the course from various university across India.



### b) CCAL's Judgement Analysis Series:

The Fourth session of the Judgment Analysis Series was organized on the 16<sup>th</sup> of January 2016 by the Centre for Constitutional and Administrative Law at Gujarat National Law University. The short summary of the previous sessions are as follows:

The case selected for deliberation was *Shri Jogendrasinhji Vijaysinghji v. State of Gujarat and Ors*, a judgment pertaining to various issues regarding Art. 226 and also Art. 227, whether the High Court has original jurisdiction in appeals from Civil Courts, whether tribunals are to be made a party when its judgment is in question under Art. 227, and so on. The cases was discussed by Mr. Asim Pandya, Senior Advocate, Gujarat High Court.

compilation of the research on different aspects of current Constitutional and Administrative issues. The research is done by the students.



### 5) CENTRE'S ACTVITES (IN CELEBRATION OF 125<sup>TH</sup> BIRTH ANNIVERSARY OF DR. BABA SAHEB AMBEDKAR:-)

### a) CCAL's First Debate Competition, 2015 on "ડૉ. બાબા સાફેબ આંબેડકર ની દ્રષ્ટીએ, શું સ્વતંત્ર ભારત, માથે મેલું ઉપાડવાની પ્રથા થી મુક્ત છે" on 01 October, 2015.

The Competition was organised to critically debate on ill practice of Manual Scavenging on the thresholds of constitutional and public laws, fitting them in the frame of vision and ideologies of Dr. Babasaheb Bhimrao Ambedkar.

The rounds were being presided and judged by Prof. (Dr.) N.K. More than 44 participants from various Law colleges across Gujarat participated. Among the 44 participants Vraj Shah of Law College Godhra and Dhruda Krupa of Government Law College, Ahmedabad bagged first and second best proposition speaker repectively and Hemendra Kanani of K. A. Pandhi Law College and Atraya Trivedi of School of Law, Auro University bagged first and second best opposition speaker respectively.



b) CCAL's First National Essay writing Competition, 2015, on 31<sup>st</sup> October, 2015.

The competition was organised to invite young minds to deliberate and analyse the thoughts and ideas of Dr. B.R.Ambedkar in the context of contemporaneous society and to open new avenues of thinking, reasoning and dissipation of novel ideas.
