ABOUT THE UNIVERSITY



Gujarat National Law University (GNLU) is a statutory University established by the Government of Gujarat through Gujarat National Law University Act, 2003. GNLU is recognised by the Bar Council of India (BCI) and the University Grants Commission. GNLU is a member of the Association of Indian Universities (AIU), the United Nations Academic Impact (UNAI), and International Association of Law Schools (IALS). For its exemplary efforts in the promotion of legal education, UGC has recognized GNLU as a model legal university in terms of access, equity, relevance, and high standards in 2011. The National Assessment and Accreditation Council (NAAC) has accredited the University with 'A' Grade in 2016.

The GNLU Act 2003 proclaims that the objective of the GNLU, "shall be to advance and disseminate learning and knowledge of law and legal processes and their role in national development: to develop in the students and the research scholars sense of responsibility to serve society in the field of law by developing skills in regard to advocacy, legal services, legislation, parliamentary practice, law reforms and such other matters; to make law and legal processes efficient instruments of social development; and to promote interdisciplinary study of law in relation to management, technology, international cooperation and development."

It envisages strategic engagements and collaborations between faculty members, researchers, research centres of these institutions to contribute to the legal development within and outside the country.

Engagements with International Agencies

GNLU seeks to engage and collaborate with international agencies, inter-governmental bodies and international NGOs, especially with organizations like UNO, BRICS, IORA, WTO, ADB, WB, AALCO, EU, and so on.

Engagements with Economy and Financial Organizations

Corporate and financial houses, Chambers of Commerce and other commercial establishments are the drivers of the nation's economy and are the leaders of national growth and prosperity in the present globalized and liberalized economy. With the expansion and diversification of the private and commercial sectors, law and legal education have crossed all conventional boundaries and spread its expanse to various non-conventional areas. 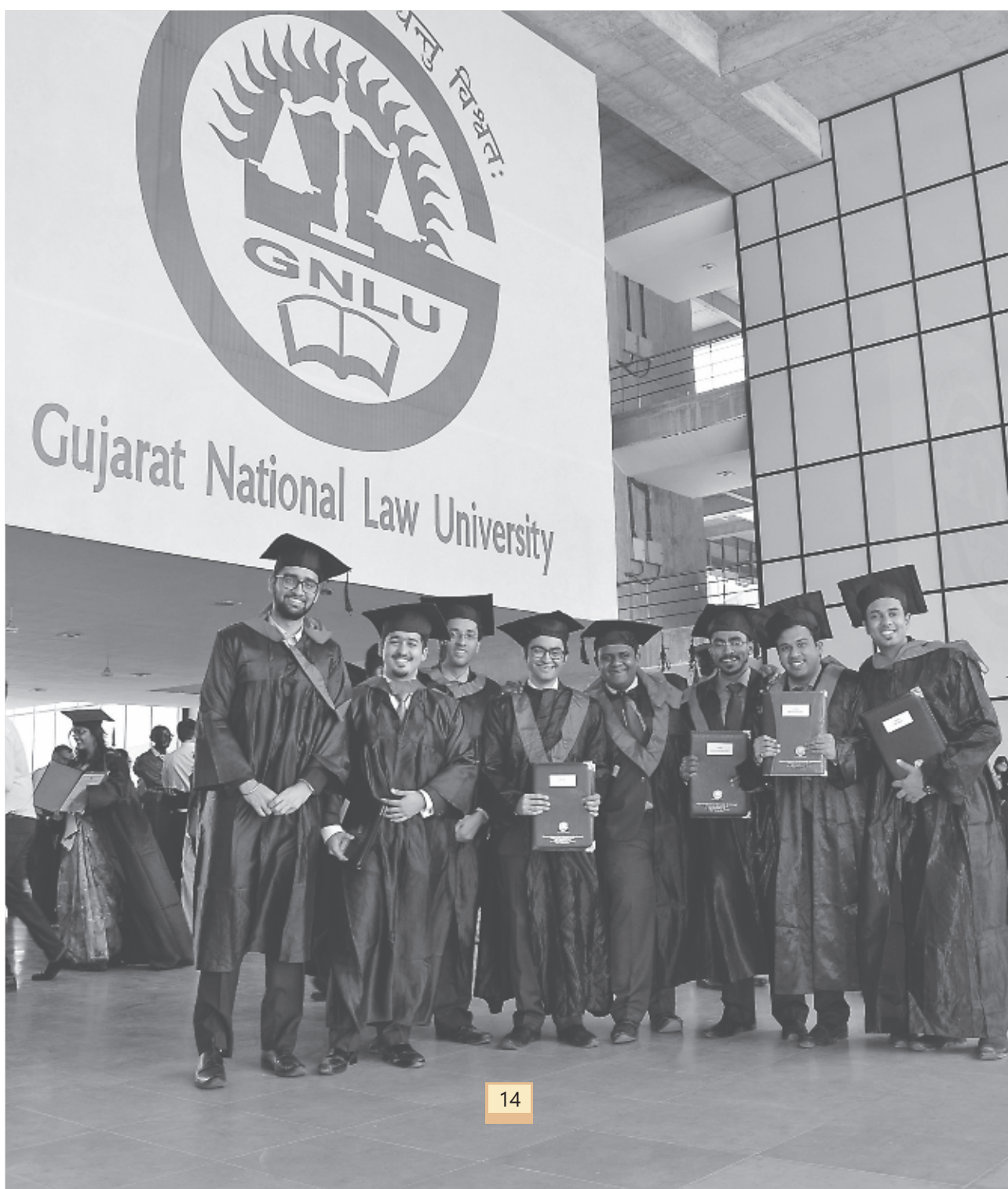

Academic Division

Academic Curriculum Committee (ACC)

The main object of the GNLU Academic Curriculum Committee ('ACC') is to provide guidance, approval and supervision to the faculty members on curricular innovation and instructional quality by ensuring that the curriculum of the University is academically sound, comprehensive and responsive to the evolving needs of the society; thus, serving the University's mission, and also the educational and vocational needs of the students. This Committee comprises mostly the senior faculty members of the University.

Roles and responsibility: ACC is entrusted with developing the standard curriculum and addressing the broader concerns that would be reflected in the curriculum framework. The following are the broad roles of the ACC:-

- Defining the goals and objectives of the curriculum;
- Designing and management of the curriculum;
- Scheduling of courses;
- Recommendations on new courses and new instructional programmes;
- Recommendations on deletion of courses and instructional programmes;
- Vetting of proposed courses;
- Allocation of subjects;
- Offering academic inputs to initiatives and proposals for different types of extra-UG courses;
- Review, evaluation, revision and implementation of policies/guidelines for course-outline/reference materials, etc. to ensure that the curriculum is coherent, coordinated, fully integrated, current and effective.

Curriculum Development-2019

The Academic Curriculum Committee has approved the introduction of new courses and updated or modified existing courses according to the requirements of the time. Three seminar paper subjects 'Health Law', 'Animal Protection Law', and 'Socio-Economic Offenses (White Collar Crimes)' has been shifted from Semester X to Semester IX effective from July 2018. Also, the seminar paper of the subject 'Medical Law and Ethics' was removed from Semester IX, effective from July 2018. Besides, the Committee has approved the content of 15 training programmes/certificate courses imparted at GNLU.

Course Structure for the Undergraduate Law Programme [BA/BCom/BBA/BSc/BSW, LLB (Hons)]*

Curriculum Re-Structuring:

A need was felt to revise and restructure the curriculum of the UG Programme in order to cater to the changing demands of industry (globally and nationally) as well as to prepare students for joining the bar. With this end in view, curricula of other National Law Universities, Private and Public Universities (offering five-year integrated course only) were referred to. The draft curriculum so prepared was presented to the Director and faculty members for their views and suggestions. Their suggestions were incorporated and the revised draft was discussed with top five students (from third year onwards) of the GNLU. Thereafter, consultation on the revised draft curriculum was undertaken with other relevant stakeholders: academics, judge, professionals and alumni. The draft curriculum was approved by the Academic Council and implemented from the Academic Year 2018-19.

About the Division:

To foster the requirements of contemporary legal education, the Gujarat National Law University's Research and Publication Division had undertaken several research activities like various research projects and endowed research programmes, publishing research outputs through various modes like books, articles, columns, research publications, group publications, in-house publications etc. The Division also promote students involvement in scientific legal research through its Student Research Development Council (SRDC) in line with the best practices prevailing in the other law schools of the world.

Presently, the University has twelve Centres of excellence and ten endowments, which are aligned with the Centres, headed by faculty members, under the supervision of the research division, undertaking research in important, evolving and niche areas of law. The maturity of the Centre activities is reflected in their important outreach and policy impact. The division oversees the four University Journals along with the University publications, an OUP publication being the most recent one.

Objectives:

- To develop Research Culture amongst the faculty members and students;
- To develop scientific research in contemporary areas in law and interdisciplinary studies;
- To ensure that the research activities of the Division carry forward the University's objective to become a true Research-based Teaching University;
- To work in close proximity with the endowment Agencies, Policymakers, Government Departments and Private and Public Sector;
- To promote, develop, manage and assess various Endowed Research Programmes run by the University.

The Gujarat National Law University has always taken proactive initiatives and outlook to provide valuable and mutually beneficial services to various stakeholders in the society. Student Research Development Council (SRDC):

GNLU has structured to be a research-based teaching university in clear recognition of the significant synergies between teaching and learning the existing literature on one hand. And on the other hand, research towards finding solutions and adding to existing literature. In order to encourage unique and interdisciplinary research that engages with relevant contemporary issues, it has geared its research-based teaching to remain open to new developments. In our opinion and to the best of our information and according to the explanations given to us, the financial statements give a true and fair view in conformity with the Accounting principles generally accepted in India:

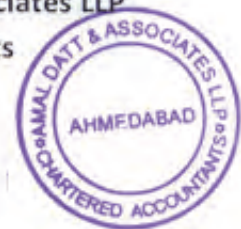

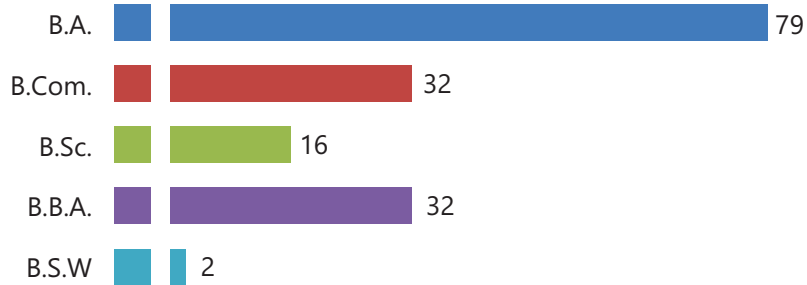

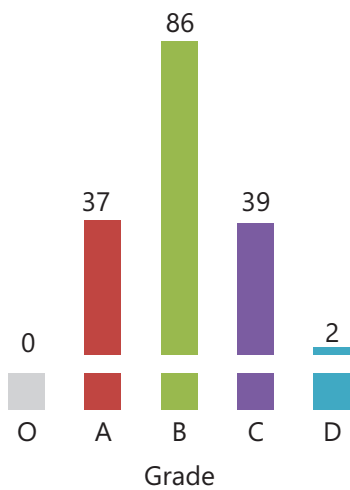

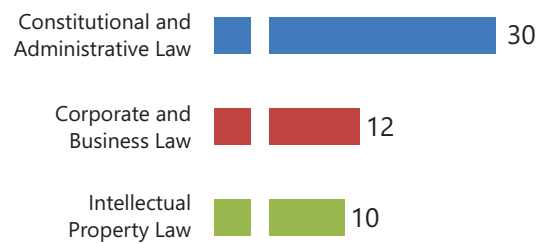
Stream wise strength of final year (UG)



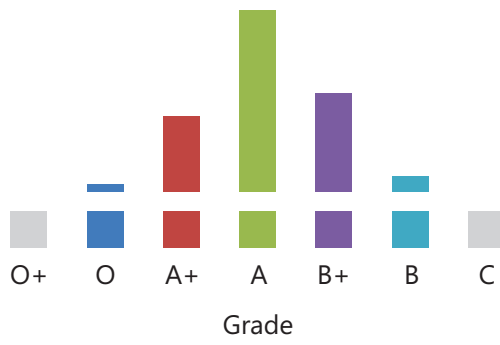
Grade wise result of final year (UG)



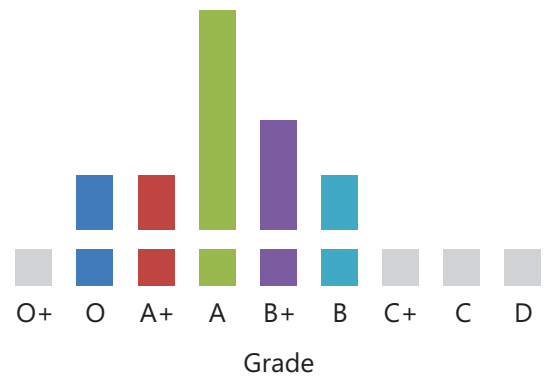
Specialization wise Strength of LL.M. batch

GENDER SENSITIZATION COMMITTEE



About the Committee:

The philosophy of Gender Sensitization at GNLU involves creation of value and virtue based system for gender equality. It involves creation of gender sensitive social and cultural environment which discourages gender biased behaviors and practices.

Activities Undertaken:

1. Gujarat National Law University in collaboration with National Commission for Women organized Regional Consultation on "Law Review of Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 and Women's Property Right on 2nd February, 2019. Representatives from various sectors including lawyers, academicians, activists, civil society organizations participated in the consultation. The participants deliberated on the issues identified in the legislation and proposed feasible suggestions and recommendations to make the POSH act, 2013 more robust and meaning ful.
2. Committee has organized "Gender Sensitization and Awareness Program" for the Students on Friday 04 October 2019. The session was delivered by Ms. Nupur Sinha, Director, Centre for Social Justice.



INTERNAL COMPLAINTS COMMITTEE



The University aims to provide a safe working and learning campus life for staff and students, free from gender discrimination and sexual harassment. As per the guidelines given by the UGC's Saksham Report with respect to the constitution of Complaints Committee on "Sexual Harassment of Women at Workplace", GNLU has constituted the Internal Complaint Committee (ICC). The ICC shall be responsible for the formal redressal of complaints of gender discrimination and sexual harassment. It shall receive the complaints, conduct inquiries and recommend disciplinary action, if any, in accordance with the provisions of the Regulations. GNLU is committed in terms of providing working environment as creative, productive and fulfilling. This includes ensuring that each student, teacher and non-teaching staff work together, in an environment of mutual trust, freedom of expression and dignity, free from all forms of violence, harassment, exploitation, discrimination and intimidation. Accordingly, ICC has framed the rules and regulations namely, 'Sexual Harassment of Women at the GNLU, Redressal of Complaints Regulations 2014', after due deliberations and same has been notified by the University. These regulations prescribe the institutional process to handle complaints of reported Sexual Harassment issues. Gender Sensitisation Committee is also responsible to create awareness on gender related issues and promote gender sensitisation.

LANGUAGE LABORATORY



About the Laboratory: The University offers seven foreign languages courses to the students. These includes French, Spanish, Japanese, Chinese, Arabic, Swahili and German. It is compulsory for the first semester students to learn a foreign language. The students may choose to learn any one of the seven languages offered. GNLU conducts foreign language classes every semester and shall run parallel to the regular semester. Each language is taught for a minimum of 120 hours, stretching across three semesters. This gives them basic proficiency in reading, listening, speaking and writing in the language of their choice. A final test is conducted in each foreign language a week before the regular end term examination. On successful completion, students are provided with certificates on the basis of their grades.

State-of-the-Art Language Laboratory: GNLU is proud to have established a state-of-the-art language laboratory. It is used optimally by foreign language faculty for speaking and listening modules. The University also plans to use the language laboratory as a repository of Ancient Indian Languages. In the years to come, the University hopes to offer the study of ancient Indian languages such as Pali, Ardhamagadhi, Sanskrit, etc.

Library provides huge space to accommodate more than 300 users at a time, with common, group and individual silent reading space facilities. The library occupies 2760 square meters of space and is the largest air-conditioned wing in the administrative building to stack and preserve print and digital resources. Library has a vast collection of more than 37500 print resources, books, e-books, law reports, journals, e-journals, online databases and reference collections. Library has developed E-Books collections of Cambridge, Oxford, Edward Elgar, Taylor & Francis, Brill, Hart publications etc.

Library acquired more than 1900 Books, which includes books on International laws, Financial and Investment laws, Intellectual Property Rights, Management, other special collections on Law and Economics, Entrepreneurship, Startup, Literature, Political science, History, Management, and Commerce etc. The best collections in the areas of law and inter disciplinary subjects are of top priority for our library collections and its development.

MODEL UNITED NATIONS (MUN)



About GNLU Model United Nations Society:

The GNLU Model United Nations Society was founded in March 2015, with an aim to promote and foster an MUN culture amongst students within the University and outside. It aims to provide a platform where learning is facilitated by allowing students to confront a range of issues that the world is facing today. The objective is to enable students to broaden their worldview, develop an appreciation of differing views, face the challenges of negotiations, see the benefits and rewards of cooperation and discover the human side of international relations and diplomacy. At GNLU, the society too aims to prepare students not only for their future careers but for global citizenship as well. The MUN Society does this through conducting intra-rounds every semester, as well as organising a national-level inter-college MUN conference.

Activities Undertaken:

- **GNLU G20 Summit:** The GNLU G20 Summit was organised by the MUN Society on 1 February, 2019. The agenda for the conference was 'The role of the G20 in tackling climatic change'. Topics covered included defining "Climatic Refugees", utilizing renewable forms of energy and questioning dependence on coal energy. The session started with the delegates opening discussion on the very first topic of concern, which was coming up with a definition for "Climate Refugees".
- **Quiz on International Law and International Relations:** The Committee organised a quiz on Law and International Relations on 4th April, 2019. It comprised of 2 major rounds. The first round was a preliminary written round comprising of basic knowledge questions on the subject matter of the quiz. It saw participation from 20 teams of two participants each. 6 teams qualified from this round to the final round of the quiz. In the final round, there were multiple rounds of questioning dealing with identification of persons/events, identification of different types of diplomacy as well as two rounds of general high - level questions on the subject matter of the quiz. In a close finish, the team comprising of Ujval Mohan and Shruti Trikanand took the first place while Anand Kumar and Abhinaba Sarkar stood second. Team comprising of Shantanu Singh and Vedika Pareek finished a close third.



GNLUMUN: As a part of its aim of providing holistic academic and co-curricular education and in continuation from the inaugural edition, GNLU hosted the fourth edition of GNLUMUN from 6th to 8th September, 2019. As part of GNLU MUN GNLU in collaboration with UNICEF organised a panel discussion on "Prevention of Trafficking in Women and Children and Rehabilitation of Victims". The registration fees for these delegates had been waived keeping in mind the fact that Teach for India works in low income government and private schools and we believe that money should not be a reason because of which a student should be deprived of an opportunity like this.



MOOT COURT COMMITTEE (MCC)



About the Committee: The GNLU Moot Court Committee (MCC) is responsible for facilitating and administering moot courts and allied competitions such as client counselling, in order to prepare students before they represent the University at the national, and international levels.

The primary function of the MCC is to ensure that the standards of mooting in the University are enhanced every year and that deserving students get the opportunity to represent the University at moot court competitions, winning laurels both for themselves and for the University.

The Committee also expands in order to form the Organizing Committees for annually conducting the GNLU International Moot Court Competition ("GIMC") and the GNLU Moot on Securities and Investment Law ("GNLUMSIL"). GIMC and GNLUMSIL have acquired the reputation of being quality platforms for discourse on niche areas of law viz. International Trade Law and Securities and Investment law respectively. The Competitions have attracted teams of the highest merit from far and wide to exhibit their research and advocacy skills on pertinent and emerging issues in these areas of law. In 2019, the Committee also conducted the NHRC-GNLU National Moot Court Competition in collaboration with the National Human Rights Commission.

Activities Undertaken:

Intra Rounds: The MCC adopts a rigorous twin intra rounds system every semester, which serves as a fair procedure to decide which students can represent the university in national and international moots. The intra rounds witness participating students being evaluated both on the basis of written submissions as well as oral pleadings. In order to encourage students to take up the Researcher's spot in a moot team, a separate Researcher's Round (which requires only memorial submission) is also conducted every year. Challenger Rounds are also organised for specific competitions.

- **1st Intra Round, January 2019:** This round was conducted to screen students from the 1st - 5th year with the best performers qualifying for the second intra round. The top 80 oralists and 50 researchers qualified for the next round.
- **2nd Intra Round, February 2019:** After the first round, the selected students took part in the Second Intra Moot Court Competition which involved a moot problem revolving around the issues of Public International Law.





- **1st Intra Round, August 2019:** This round was conducted as a screening round for students from the 2nd – 5th year. The top 120 oralists and 51 researchers qualified for the next intra rounds.
- **First Years’ First Intra Round, August 2019:** The MCC recognizes the difficulty faced by first year students to compete with their seniors in the very first go. Therefore, a separate intra round moot based on municipal law, usually Tort law, is organized for first year students exclusively.
- **2nd Intra Round, September 2019:** The 2nd Intra Round of the odd semester is organized in two parts; one round based on a problem of public international law (“PIL Round”), and the other on arbitration law (“Arbitration Round”).
- **Jessup Challenger Round, September 2019:** The MCC conducted a challenger round for the prestigious Philip C. Jessup International Law Moot Court Competition.
- **Vis Challenger Round, September 2019:** A challenger round was also conducted for the prestigious Willem C. Vis International Commercial Arbitration Moot annually organised in Vienna and Hong Kong.
- **Oxford IPR Moot Challenger Round:** This year, the MCC organized a Challenger Round for the prestigious Oxford Intellectual Property Rights Moot Court Competition, for the first time.

Other Allied Competitions: The MCC conducts internal rounds to select students for various client counselling competitions, research paper, judgment writing, legislative drafting competitions, etc. This year’s client counselling rounds were held in January 2019.

GNLU Students at Moot Court Competitions: In keeping with the active mooting culture in the university, GNLU students participated in over 100 moot court competitions, client counselling, mediation, judgment writing competitions in the last year.

The competition boasts of successful past collaborations with the World Trade Institute – University of Bern (WTI-Bern), IELPO LLM Programme – University of Barcelona, Borden Ladner Gervais LLP, Lakshmikumaran & Sridharan Attorneys, Centre for WTO Studies – Indian Institute of Foreign Trade (CWS-IIFT), Manupatra, Westlaw, Thomson Reuters India and Trade Law Guide.





- The 11th edition of GMC in 2019 partnered with Lakshmikumaran & Sridharan Attorneys, World Trade Institute - Bern, Centre for Trade and Investment Law- Indian Institute of Foreign Trade, Centre for WTO Studies, Lex Witness, Eastern Book Company and SCCOnline.
- A memorandum of understanding was entered into between GMC and EBC-SCCOnline with the latter becoming the Exclusive Knowledge Partners of GMC for a period of 5 years henceforth.
- The Competition which has come to signify an important fixture in the mootng calendar and a reputed platform for discourse on International Trade law, witnessed the participation of 56 teams from various countries across the world.
- The Moot problem for the 11th GMC, 2019 was drafted by Mr. Sagnik Sinha, an alumnus of GNLU currently working at the WTO and dealt with intriguing issues on the WTO Agreement on Subsidies and Countervailing Measures.
- The panel for the Final Round of GMC, 2019 consisted of Ms. Anuradha RV (Partner, Clarus Law Associates), Dr. James J. Nedumpara (Professor & Head, Centre for Trade & Investment Law- Indian Institute of Foreign Trade) Mr. Santanu Mukherjee (Advocate & Head, Ex Lege Law Chambers), Mr. V. Lakshmikumaran (Managing Partner, Lakshmikumaran & Sridharan Attorneys), and Mr. Andrea Schlaepfer (Lecturer, University of Bern).
- A special lecture was also delivered for final year students of GNLU, by Ms. Wakako Oshima, Asteri Consultants, Japan on the topic of 'WTO and CSR from the International Business Perspective.'
- The team representing School of Law, Christ (Deemed to be University), emerged as winners of GMC 2019. The triumphant team received a trophy along with a cash prize of Rs. 50,000, merit certificates, internships at Lakshmikumaran & Sridharan Attorneys, an invitation to WTI's Summer Academy on International Trade and Investment Law and Policy and access to SCCOnline and EBC E-Learning.

Activities Undertaken:

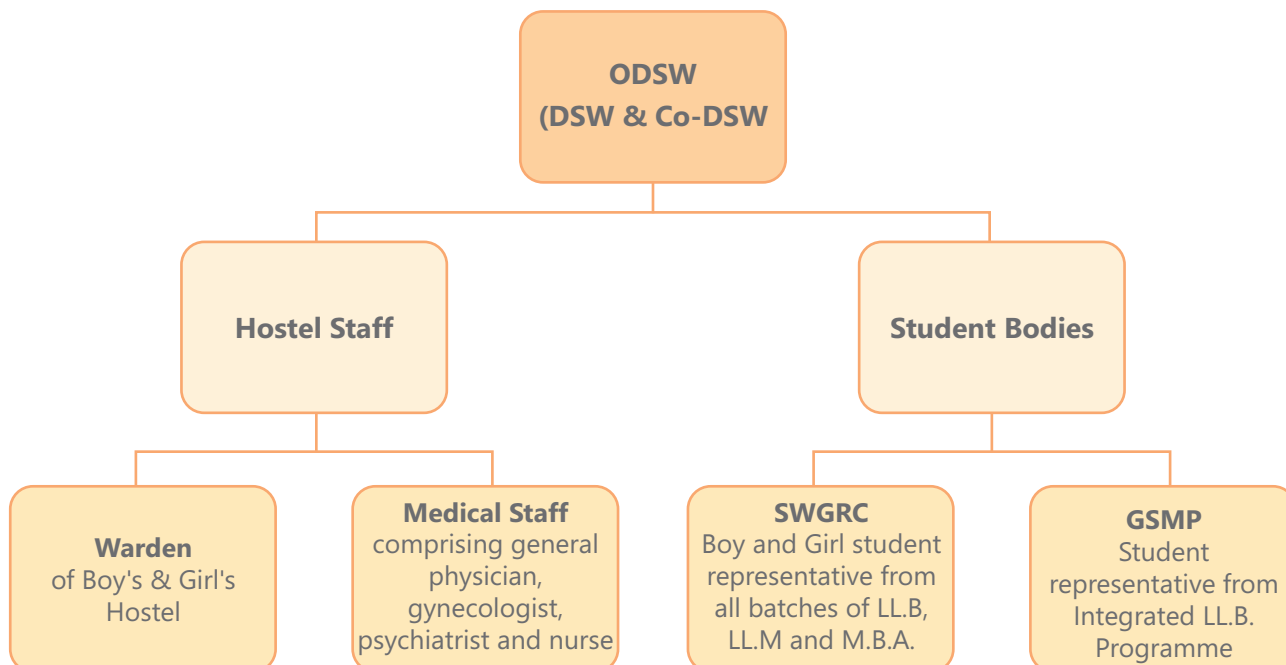
