4th International Conference on 'Rule of Law' in Space

The launch of Sputnik in the Cold War era is considered the beginning of the space age, which culminated in the moon landing in international The community realized the need to frame laws to govern the challenges posed by these pathbreaking technological breakthroughs. Such efforts resulted in International Space Law in the form of the Outer Space Treaty (1967). Rescue and Return Agreement (1968).Liability Convention (1972).Registration Convention (1975) and Moon Agreement (1979).However. two developments characterised the subsequent development of space law. Firstly, a distinct rise in the number of private players and the significant role played by they in human space endeavours. Secondly, increasing democratisation of the group of space-faring nations. Coupled with the integration of cyber technology and artificial intelligence in the space domain, these developments necessitate a review or appropriate amendment to Space Law to govern human activities in space. However, another viewpoint is that the Space Law in its existing form provides opportunities to address all the concerns posed by the abovementioned challenges in order to meaningfully fulfil the global human aspirations to benefit from exploration and use of outer space.

While militarisation and Weaponisation of space continue to be a concern for the international community, the Artemis Accords and the International Lunar Research Station present two competing approaches to commercial cooperation in governance of human activities in space in future, bringing the focus back to the moon.

India has unleashed Reforms in the space sector in 2020 to promote the participation of private players in carrying out end-toend activities in the space domain. As part of the reforms, the Indian National Space Promotion and Authorisation Centre (INSPACe) was established for promoting and authorising space activities by private players. Indian Space Policy 2023 provided further fillip by providing regulatory clarity to various stakeholders in order to develop a vibrant space ecosystem in India. Long-awaited enactment of a national legislation for regulating Space activities in India is expected to enable India to fulfil its aim of Viksit Bharat by 2047.

This international conference aims to provide a platform for deliberations amongst the Space Law enthusiasts and thereby contribute to the emerging discourse on the challenges posed to Space Law in future.

- Abstract: 300-500 words
- Paper: 3500-5000 words (excluding references).
- Submissions below or above the word limit shall not be considered.
- Citation style: OSCOLA. (4th Edition)
- Font: Times New Roman; Font size: 12; spacing: 1.5.
- Papers with a similarity score as per the UGC Regulation shall only be accepted.
- A cover page with the title of the paper, name, and affiliation of the author/coauthors shall be attached.
- Submit text as a Microsoft Word document (.doc or .docx).
- Co-authorship is permitted up to two authors.
- Submissions shall be in English.
- The title of the paper, once registered, shall not be changed.
- Any identification mark (in any form) on the paper shall lead to automatic disqualification.
- Multiple or incomplete submissions shall not be considered.
- Any contribution received after the last date shall not be considered.
- Selected papers from the conference may be considered for publication in the GNLU Journal of Air and Space Law, subject to the review process thereof.
