Authors are free to delve into any contemporary issues falling under the above themes. The given sub-themes are merely indicative and suggestive in nature. Authors are suggested to submit their manuscripts on any other relevant topics.

GUIDELINES



- Author(s) should indicate the theme on which the paper is based.
- The paper should include a title, an abstract (max. 500 words) and a minimum of 5 keywords.
- The papers shall be screened by the editorial board. The author(s) of the shortlisted papers shall be intimated accordingly.
- The word limit (excluding abstract and foot notes) can range between 3000-5000 words.
- Mode of citation: OSCOLA.
- The font to be used will be Times New Roman, Heading (Bold) Size -14, Body Size - 12.
- Uniform margins of 1" shall be kept on all sides.
- Co-authorship up to 2 authors is permissible.
- All submissions should be the original work of the author(s) and should not have been submitted for publication/published/ presented elsewhere in any form.
- Use of any kind of generative Artificial Intelligence is strictly prohibited.
- Certificate of Participation will be given to all the participants.
- Papers with similarity score of up to 10% will be accepted and anything above will be outrightly rejected.


