• SC Refuses to Monitor CBI Investigation Into Saradha Chit Fund Scam.

The Supreme Court on Monday refused to monitor the ongoing Central Bureau of Investigation (CBI) case into the Saradha chit fund scam in West Bengal.

A two-judge bench comprising Chief Justice Ranjan Gogoi and Justice Sanjiv Khanna did not allow the application filed by some investors, that despite the apex court's order from 2013, directing the agency to probe the chit fund scam, the investigation has not attained finality.

Section 377: Naz Foundation withdraws Curative Petitionagainst 2013 SC verdict.

NGO *Naz Foundation* today withdrew its curative petition against the 2013 judgment of the Supreme Court which had upheld the validity of Section 377 of the Indian Penal Code (IPC).

Introduced by the British during the colonial era, Section 377 penalised all sexual activities "against the order of nature". Modeled on the then-existing English Buggery Act (1553), this provision effectively came to be used to criminalise sexual activity between homosexuals persons, regardless of whether it was consensual.

PILs in the SC and the Gujarat HC

• Mirage-2000 crash: Plea in SC on crash of aircraft, choppers of Indian armed forces

A petition was filed in the Supreme Court Wednesday over the "alarming increase" in crash of aircraft and helicopters of the Indian Armed Forces, seeking direction to the Centre to take steps to ensure that such accidents do not occur in future.

The public interest litigation (PIL) has been filed after a Mirage-2000 trainer aircraft of the Indian Air Force crashed on February 1 at the Hindustan Aeronautics Limited Airport here killing both the pilots -- Squadron Leader Samir Abrol and Squadron Leader Siddhartha Negi, both from Aircraft and Systems Testing Establishment.

The PIL has sought setting up of a court-monitored committee comprising a retired judge of the apex court and experts from Indian defence services to conduct a thorough enquiry into the Mirage crash.

• PIL for fresh probe into death of ex-Gujarat Home Minister Haren Pandya posted before Justice Arun Mishra

The Supreme Court on Friday required a petition by NGO Centre for Public Interest Litigation (CPIL) for a fresh, court-monitored investigation into the murder of Haren Pandya, BJP leader and Home Minister in the Gujarat Cabinet, to be placed before the same bench which is hearing the criminal appeal in the matter. The bench of Justices A. K. Sikri and Abdul Nazeer was of the view that the new PIL should be heard by a bench headed by Justice Arun Mishra, which is considering the appeal against the 2011 judgment of the Gujarat High Court acquitting the 12 persons convicted for Pandya's murder by the trial court.
