ABOUT THE CENTRE

The **GNLU Centre for Women and Child Rights (GCWCR)** was established in September 2020 to develop, promote and support advanced interdisciplinary studies and research which lie at the intersection of law and policy within the area of women and child welfare. OBJECTIVES OF THE COURSE

This course is focused to-

- help the participants gain a deeper understanding of the origins and evolution of gender jurisprudence,
- create awareness among learners about the social, cultural, and economic factors leading to the evolution and development of gender jurisprudence,
- introduce students to key writings, concepts, principles, and discourses in gender jurisprudence,
- enable the students to critically examine statutes, judgments, and discourses on law through the feminist lens,
- facilitate informed decisions and deliberations among the students on law and gender justice in India,
- comprehend the intersectionality within gender jurisprudence with concepts like caste-ism, sexual orientations, economic and social capital, etc, and
- develop a comprehensive understanding of the evolution of gender jurisprudence in India, and globally through deliberations, research work, theory building, and information discrimination.
