# Guidelines for Paper Submission

Original research papers are invited on the afore-mentioned and related themes.

- The author(s) should indicate the theme on which the paper is based.
- The paper proposals should include a title, an abstract(max. 500 words) and a minimum of 5 keywords. Abstracts are to be submitted through [this form](#)
- The abstracts shall be screened by the editorial board. The author(s) of the shortlisted abstracts shall be intimated accordingly.
- The word limit (excluding foot notes) can range between 3000-5000 words. Mode of citation: APA/OSCOLA
- The font to be used will be Times New Roman, Heading (Bold) Size -14, Body Size - 12. Uniform Margins of 1" shall be kept on all sides.
- Co-authorship is permissible (subject to an upper limit of 2 authors per submission).
- All submissions should be the original work of the author(s) and should not have been submitted for publication/published/ presented elsewhere in any form.
- Certificate of Participation will be given to all the participants.
