## GENERAL INSTRUCTIONS

1. Please fill out all the sections of the Registration Form for participation in the 12<sup>th</sup> GNLU International Moot Court Competition, 2020. All fields are mandatory.
2. The registration fee shall be payable in accordance with Rules 3.2 – 3.3 and **Annexure I** of the Rules of the Competition. Once the registration fee is paid, refund, if any, shall take place only in accordance with Rule 3.2.3 of the Rules of the Competition.
3. Upon receipt of the duly filled-in Registration Form as per the rules below, and the registration fee from a Team, the Organizing Committee shall assign a Team Code to such a Team pursuant to Rule 3.1.7 of the Rules of the Competition. The Team Code will be communicated to the Team's Official Team Contact Person.

### **Indian Teams:**

5. Teams that choose to pay the Registration Fee by way of online transfer in accordance with Rule 3.2 of the Rules of the Competition will be required to submit a duly signed and scanned copy of the Registration Form, along with the proof of payment. The same should be e-mailed to the Organizing Committee no later than 25 October 2019. Registration Forms received after this deadline will not be considered for participation in the Competition.
