

Gujarat National Law University Administrative Directive GNLU/REG/AD/05/2017

Rules for Access to Recreation Room in the Halls of Residence

The Recreation Room in each of the Halls of Residence shall be used in strict compliance with the following rules:

- 1. Any person with a valid GNLU Identity Card is entitled to access the Recreation Room ("the User")
- 2. The Recreation Room shall remain open from 0700hrs to 0845hrs and from 1400hrs to 2330hrs each day ("the Access Hours"), notwithstanding the fact that a given day is a holiday as per the GNLU Academic Calendar or is any other University-designated holiday, except during vacations.
- 3. Any User(s) is required to take the prior permission of the Dean Students' Welfare to access the Recreation Room beyond the Access Hours.
- 4. No equipment or facilities, including but not limited to chairs, dumbbells, carom board, posters and other things, provided in the Recreation Room shall be moved from their designated area. Violation of this rule shall result in a fine of Rs.1000 on the defaulter.
- 5. No food item(s) and/or beverage(s), other than water, is allowed inside the Recreation Room. Violation of this rule shall result in a fine of Rs.500 on the User.
- 6. All Users shall ensure that all electrical appliances in the Recreation Room, including but not limited to the Television set, tube lights, fans and the like, are switched off when not in use, and while leaving the Recreation Room.
- 7. All Users shall maintain discipline and safety while in the Recreation Room.
- 8. Any case of malfunctioning/broken/stolen equipment or facility shall be immediately reported to the respective hostel warden for necessary action(s).

- 9. The University, the wardens or any other staff of the Halls of Residence shall not be responsible or liable for any liability arising from any untoward incident, including but not limited to electric shocks, arising out of the improper use of the equipment or facilities in the Recreation Room.
- 10. The Hostel Administration and a class representative shall adjudicate upon all cases of damage(s) caused to any equipment and/or any facility in the Recreation Room. Compensation for any damage caused by a User(s) shall be adjusted against the security deposit of the User(s) causing such damage. For the purpose of this Rule, the class representative shall be nominated by the Dean Students' Welfare.
- 11. Notwithstanding any individual action that may be prescribed for violation of a particular rule, non-compliance with any of the rules by a User(s) shall result in the following action(s) imposed by the Hostel Administration:
 - i. Infraction #1: Fine of Rs.500/-
 - ii. Infraction #2: Fine of Rs.1000/-
 - iii. Any additional infractions: Bar on access to the RecreationRoom for one academic year.
- 12. The University, in larger interest, may suspend access to the Recreation Room upon recommendation of the Dean Students' Welfare.
- 13. These rules are subject to amendment and changes from time to time.
