- A candidate seeking admission under the J & K Residents/NEI category shall have appeared in the Common Law Admission Test (CLAT).
- A candidate seeking admission under J & K Residents/NEI category shall have to produce a relevant domicile certificate at the time of admission.

The candidates interested in seeking admission under the subject to satisfying eligibility conditions can apply directly by filling out the below application form latest by **30 April 2024 (05:00 P.M.)**. Step 5: Select “NA” under Horizontal category

Step 6: Enter your CLAT Credential/Score details

Step 7: Upload the necessary documents

Step 8: Accept T&C

Step 9: Click on save button

Step 10: Click on payment link to pay the online payment of the application fees.

Step 11: On successful payment, a confirmation e-mail will be delivered to the given e-mail id.

** If the candidate is selecting wrong admission category, then the candidate himself/herself will be fully responsible for the result and the University will not accept or edit the admission category once the application is submitted.*

The Candidates may upload the documents or can edit the application form till 30 April 2024 by 05:00 P.M. The candidates are advised to fill the form in full. Incomplete application form (including non-submission of documents/fees) shall be rejected.

5. Selection Process:

The selection of candidates shall be purely based on merit, out of the application(s) received by the GNLU under this category. The application received after the due date will not be considered.

6. General Instructions:

- The candidates appearing in the qualifying examination shall be required to produce evidence of their passing the qualifying examination at the time of admission.
- The students who have passed their qualifying examination from schools located outside India (affiliation boards other than CBSE, ISCE, IB and Cambridge) are required to produce the equivalency certificate from the Association of Indian University. The same certificate is required to produce at the time of admission. - The candidate(s) applying under PG (LL.M.) Programme are required to submit their final year mark sheet of LL. B. Programme at the time of admission.
