

Notification: Inviting Expression of Interest for Seeking Admission Under the Economically Weaker Sections (EWS) Category for UG (LL.B.)/PG (LL.M.) Programmes for the Academic Year 2020-21

Pursuant to the UGC Notification Number F.No.87-2/2019 dated August 16, 2019 and the Government of Gujarat, Social Justice and Empowerment Department Resolution No. EWS/122019/45903/A dated 11/02/2019, Gujarat National Law University is providing 10% reservation to Economically Weaker Sections of the society in the UG/PG Programmes offered by the University. The candidates appearing in the Common Law Admission Test (CLAT) – 2020 and who are interested in seeking admission under the EWS Quota for UG/PG Programmes, subject to satisfying eligibility criteria and fulfilling all of the below mentioned conditions can apply directly to the University.

1. Number of Seats:

UG Programme (LL.B.) – 18
PG Programme (LL.M.) – 06

2. Eligibility:

The admission under the EWS category shall be filled directly on the basis of the merit of Common Law Admission Test (CLAT) – 2020 and subject to production of relevant certificate issued by the competent authority.

3. Application and Fees:

The candidates appearing in the Common Law Admission Test (CLAT) – 2020 and who are interested in seeking admission under EWS Category for LL.B./LL.M Programmes can apply directly by filling the 'Expression of Interest Form' on or before 01st July, 2020. The hard copy of the filled-in admission (Expression of Interest) form along with all the relevant certificates shall reach the University through post latest by 15th July, 2020.

- a) District Magistrate/ Additional District Magistrate/ Collector/ Deputy Commissioner/ Additional Deputy Commissioner/ 1st Class Stipendiary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner
 - b) Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/ Presidency Magistrate
 - c) Revenue Officer not below the rank of Tehsildar/Mamlatdar.
5. The selected candidates shall be required to produce original certificates/documents at the time of Personal Interview/Admission.
