

Notification: Inviting Expression of Interest for Seeking Admission Under Foreign National (FN) Category for UG (LL.B.)/PG (LL.M.) Programmes for the Academic Year 2020-21

Gujarat National Law University invites application for admission under FN category for UG/PG Programmes for the academic year 2020-21. The seats under the FN Category shall be filled by the University directly and the candidates seeking admission under this category shall not require to appear in the Common Law Admission Test (CLAT) – 2020 and can apply directly to the University.

1. Number of Seats:

UG Programme (LL.B.) – 06

PG Programme (LL.M.) – 02

2. Eligibility:

a) For admission to LL.B. Programme:

- i. Passed 10+2 or equivalent examination with the minimum of 45% marks.
- ii. Candidates who are appearing in the qualifying examination in April/May 2020 are also eligible to apply.

b) For admission to LL.M. Programme:

- i. LL.B. or equivalent degree in law examination with a minimum of 50% marks.
- ii. Candidates who are appearing in the qualifying examination in April/May 2020 are also eligible to apply.

3. Application and Fees:

The candidates, who are interested in seeking admission under the FN Category for UG (LL.B.) & PG (LL.M) Programmes, subject to satisfying eligibility conditions, can apply directly by sending expression of interest by filling the 'Admission (Expression of Interest) Form' on or before 01st July, 2020. The hard copy of the filled-in admission (Expression of Interest) form along with all the relevant certificates shall reach the University through post latest by 15th July, 2020.

- i. The candidates appearing in the qualifying examination shall be required to produce evidence of their passing the qualifying examination at the time of admission.
 - ii. The students who have passed their qualifying examination from schools located outside India (affiliation board other than CBSE, ISCE, IB and Cambridge) are required to produce the equivalency certificate from the Association of Indian University.
